MINUTES OF MEETING  
OCTOBER 8, 2014

At 9:00 a.m., Chairman Abarbanel called to order the meeting of the California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) at the City of Mission Viejo City Council Chambers, 200 Civic Center, Mission Viejo, California.

**Item 2** – Public Forum

Sam Allevato, Mayor of the City of San Juan Capistrano, welcomed the Board to Orange County.

Wayne Brown, South Orange County Economic Coalition, spoke about the importance of building an infrastructure that meets the highest water quality standards while also accommodating the needs of a growing population.

Rhonda Reardon, Council Member of Mission Viejo, welcomed the Board to Mission Viejo.

Edward Modiano, Project Coordinator of the Chatham Site for the PRP Group, provided an update on the Chatham Brothers Barrel Yard plume in Escondido. Ms. Warren recused herself and stepped away from the dais during this time.

Ziad Mazboudi, City of San Juan Capistrano, stated that he was leaving the City of San Juan Capistrano to take another position in the Middle East. He praised the Regional Water Board staff for their dedication, hard work, and willingness to work with stakeholders to improve water quality.

Mary Anne Skorpanich, Deputy Director, Orange County Public Works, presented an award to Mr. Mazboudi for his work in Orange County.

Michael Beanan, Laguna Beach Wastewater Task Force, provided an update on the task force's activities toward the use of wastewater, and he spoke about the importance of mapping of coastal receiving waters and urban runoff plumes.

Mr. Gibson also provided a summary of the WQCC. He also thanked staff for their attendance at a public meeting on September 30 regarding the Chatham Brothers site and for the multi-page summary of the history of the site in the Executive Officer's Report. In addition, Mr. Gibson summarized the visit of EPA Administrator Gina McCarthy at Border Field State Park on October 7.

Ms. Warren requested that the Board have an information item regarding California water law and water rights at a future Board meeting.

Mr. Gibson relayed a request from Board Member Kalemkiarian for information items from some of the community groups with which she and other Board members have been conducting outreach meetings.

Dr. Abarbanel asked that Rob Egel, Chief of the State Board's Legislative Affairs Office, be invited to join the Board at the June meeting to discuss legislative priorities.

This Closed Session was not held.




This Closed Session was not held.
