**ITEM 4a** – Staff from the Scripps Institution of Oceanography (SIO) will give a presentation on Phase One of their Pathogen Forecast Model, released in July 2025. Phase One of the Pathogen Forecast Model includes an online, five-day prediction of ocean sewage and swimming-related illness risk for beaches in the San Diego and Tijuana border region, from Coronado to Playas de Tijuana.
