Resolution No. R9-2012-0025 for the San Diego Bay Shipyard Sediment Site**

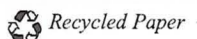
On March 14, 2012, the California Regional Water Quality Control Board, San Diego Region, (San Diego Water Board), pursuant to Water Code section 13304, adopted Cleanup and Abatement Order No. R9-2012-0024 with Technical Report (collectively Final CAO). The San Diego Water Board also adopted Resolution No. R9-2012-0025 certifying the Final Environmental Impact Report (FEIR). The San Diego Water Board filed a Notice of Determination for this project on March 16, 2012.
