## **APPENDIX B - Copermittee HMP Development Process**

Although the County of District serves as the lead agency for development of the HMP, all SMR Copermittees have participated in its development, both financially and through participation in HMP workshops scheduled over the course of the project at times corresponding with key decision points in developing the HMP. Participants in the HMP workshops provided valuable input on the development of the HMP.

The Copermittees will continue to meet to discuss and resolve any issues that may arise during the HMP implementation phase. Participants in the HMP development process will also assist in refining and reinforcing methodologies, criteria, and standards established in the HMP.

The group of participants in the SMR HMP development process has met four times since October 2012. **Table 6** shows meeting dates, locations, and agenda items. In addition to the formal meetings, the Copermittees coordinated via email to review and discuss technical documents, deliberate on specific HMP related topics, and concur on issues.

A Draft SMR HMP will be submitted to the SDRWQCB on or before June 30, 2013. Within 180 days of receiving SDRWQCB comments on the Draft SMR HMP, the Copermittees will submit a final HMP that addresses the SDRWQCBs comments.

As required by Permit Provision F.1.h(5)(a), the draft document was posted on the District's website in January 2013 (http://rcflood.org/NPDES/SantaMargaritaWS.aspx) for public review and comment. Once the Final Draft SMR HMP is submitted to the Regional Board, the document will be posted on the District's website for a second round of public review and comment.

No later than 90 days after receiving a finding of adequacy from the SDRWQCB Executive Officer, the Final SMR HMP requirements will be incorporated into the SMR WQMP. The Copermittees will use the revised SMR WQMP to incorporate the HMP requirements into the local approval processes through their local WQMPs and municipal ordinances. This will also be completed within 90 days after receiving a finding of adequacy from the SDRWQCB Executive Officer.
