CHANGES TO TENTATIVE CONDITIONAL WAIVER OF WASTE DISCHARGE REQUIREMENTS FOR GRAZING OPERATIONS IN THE TOMALES BAY WATERSHED (TOMALES BAY, LAGUNITAS CREEK, WALKER CREEK AND OLEMA CREEK) IN THE SAN FRANCISCO BAY REGION

Water Board staff have made changes to the Tentative Conditional Waiver of Waste Discharge Requirements for Grazing Operations in the Tomales Bay watershed, in order to elaborate on the implementation of management practices in the Walker Creek watershed, downstream of the Gambonini Mine. Changes to the Tentative Conditional Waiver can be found in a new Finding 6 on page 3 and in Condition 3 on page 9 of the Tentative Conditional Waiver, as well as in the Checklist Form (Attachment B of the Tentative Waiver).

Comments received after these dates will not be considered or included in the preparation of the package presented to the Board for their consideration.

The date and time for the public workshop conducted by Water Board staff will remain the same. You may comment at the public workshop held at the Point Reyes Dance Palace, 5th and B Streets, Point Reyes Station, on June 11, 2008 at 6:00 p.m.
