Dear Mr. Salerno:

Enclosed is Complaint No. R2-2008-0099 issued as an administrative civil liability in the amount of \$115,000. The Complaint alleges that the San Francisco Public Utilities Commission (SFPUC) violated California Water Code Sections 13385(a)(1) and (a)(5) for an unauthorized discharge and while authorized to discharge from its temporary treatment unit, violated the requirements of Order No. R2-2006-0075 (NPDES Permit No. CAG912002).

A 468,000-gallon spill occurred in December 2006 (unauthorized discharge). After a few days, the spill was directed to storage tanks and treated under the NPDES permit. While discharging under the NPDES permit, there were several violations of the NPDES permit's discharge prohibition and effluent limits (permit violations). The Complaint describes the alleged violations in detail. SFPUC may be allowed to spend up to \$50,000 on a supplemental environmental project (SEP) that is acceptable to the Assistant Executive Officer.

The Prosecution proposes that the Regional Water Board consider Complaint No. R2-2008-0099 for an administrative civil liability in the amount during a meeting that will commence at the time and place indicated below:

Enclosed you will find a Hearing Notice that sets forth the procedures the Regional Water Board typically follows in conducting the public hearing. Any objections to the hearing process set forth shall be sent to the Regional Water Board's advisory team with a copy to the staff contact listed below by **April 15**, **2009**.

SFPUC has the following options:

- SFPUC can appear before the Regional Water Board at the meeting to contest the matter.
   Written comments and evidence shall be submitted by the deadline indicated below and in
   accordance with the process set forth in the attached Public Notice. At the meeting, the
   Regional Water Board may impose an administrative civil liability in the amount proposed or
   for a different amount, decline to seek civil liability, or refer the case to the Attorney General
   for judicial enforcement.
- 2. SFPUC can waive the right to a hearing to contest the allegations contained in the Complaint by completing the waiver attached to the Complaint.

If SFPUC waives its right to a hearing, it must mail and fax a copy of the signed waiver by the time and date specified below to the attention of Farhad Azimzadeh of my staff at fax number (510) 622-2460.

The deadline for submittal of written comments and evidence to the Complaint and waiver is **April 15, 2009**, at 5 p.m.

The deadline for submittal of an SEP proposal is also April 29, 2009, at 5 p.m.
