Unauthorized Discharge Violations from the Sanitary Sewer Collection System and

the Wastewater Treatment Plant in Sausalito, Marin County

Dear Mr. Simmons:

Enclosed is Complaint No. R2-2009-0043 issued as an administrative civil liability in the amount of \$332,000. The Complaint alleges that the Sausalito-Marin City Sanitary District (District) violated Order No. R2-2003-0109 (NPDES Permit No. CA0038067).

A 9,000-gallon sanitary sewer overflow occurred on August 10, 2008, from the District's sanitary sewer collection system near 215 Main Street. A 764,500-gallon discharge of partially treated wastewater occurred on February 15-21, 2009 from a bypass pipeline at the District's Wastewater Treatment Plant (Plant). Additionally, a 2,700-gallon discharge of partially treated wastewater occurred on February 27, 2009 from the same bypass pipeline at the Plant. The Complaint describes the alleged violations in detail. The District may be allowed to spend up to \$155,000 on a supplemental environmental project (SEP).

The Prosecution proposes that the Regional Water Board consider Complaint No. R2-2009-0043 for an administrative civil liability in the amount during a meeting that will commence at the time and place indicated below:

Enclosed you will find the Hearing Procedure that the Regional Water Board typically follows in conducting the public hearing. Any objections to this hearing process set forth shall be sent to

the Regional Water Board's Advisory Team by **July 13, 2009**, or they will be waived. The Advisory Team contact information is included in the Hearing Procedure.

The District has the following options:

- The District can appear before the Regional Water Board at the meeting to contest the matter.
 Written comments and evidence shall be submitted by the deadline indicated below and in
 accordance with the process set forth in the attached Hearing Procedure. At the meeting, the
 Regional Water Board may impose an administrative civil liability in the amount proposed or
 for a different amount, decline to seek civil liability, or refer the case to the Attorney General
 for judicial enforcement.
- 2. The District can waive its right to the 90-day hearing requirement in order to engage in settlement discussions.
- 3. The District can waive the right to a hearing to contest the allegations contained in the Complaint by completing the waiver attached to the Complaint.

If the District waives its hearing rights, it must mail and fax a copy of the signed waiver by the time and date specified below to the attention of Sandia Potter of the Advisory Team with a copy to Claudia Villacorta of the Prosecution Team. Both faxes should be sent to (510) 622-2460.

The deadline for submittal of written comments and evidence to the Complaint and waiver is **July 13, 2009**, at 5 p.m. The deadline for submittal of an SEP proposal(s) is **July 31, 2009**, at 5 p.m.
