The Order reflects the settlement agreement we reached in this matter, as described in Water Board prosecution staff's letter dated June 26, 2009, and ConGlobal's letter dated June 30, 2009. No comments were received on the Order during its public comment period, which ended August 31, 2009.

On August 12, 2009, the Regional Water Board received your partial civil liability payment in the amount of \$3,625. Payment of the balance of \$3,625 is due to the Regional Water Board not later than 5 pm on March 15, 2010, six months following the Order's adoption.
