**NOTICE OF APPLICATION AND PUBLIC HEARING  
FOR REISSUANCE OF NPDES PERMIT  
AND ISSUANCE OF CEASE AND DESIST ORDER**

**City of Calistoga,  
1232 Washington Street, Calistoga, CA 94515, Napa County**

The above Discharger has filed an application for reissuance of a permit under the National Pollutant Discharge Elimination System. Regional Water Board staff has prepared a tentative permit containing effluent and receiving water limitations and special provisions, in accordance with the Federal Clean Water Act and the California Water Quality Control Act. Regional Water Board staff has also prepared a tentative cease and desist order to require actions to address compliance problems with certain toxic pollutant limits in the tentative permit.

The above Discharger owns and operates the Dunaweal Wastewater Treatment Plant, which treats wastewater from domestic, commercial and industrial sources for a total service population of approximately 5,300. The plant has a current average dry weather design treatment capacity of 0.84 million gallons per day (MGD). Secondary- and tertiary-treated wastewater is disinfected and discharged through shallow water outfalls to the Napa River. Tertiary-treated wastewater is also recycled for landscape irrigation during the dry season.

The Regional Water Board intends to consider adopting the tentative permit and cease and desist order during a meeting to commence at the time and location as follows:

**The deadline for comment is 5:00 p.m. on July 12, 2010.** Comments must be sent to the **attention of John H. Madigan**. Persons wishing to file written comments on or objections to the tentative permit and tentative cease and desist order, or other aspects of this matter must do so no later than this deadline for the comments to be considered. No written comments will be accepted or responded to in writing if received after that deadline. Interested persons are invited to attend and express their views at the public hearing on this matter. The Regional Water Board will hear oral testimony, but will not accept written comments after the deadline.

Pursuant to section 2050(c) of Title 23 of the California Code of Regulations, any party that challenges the Water Board's action on this matter through a petition to the State Water Resources Control Board under Water Code section 13320 will be limited to raising only those substantive issues or objections that were raised before the Regional Water Board at the public hearing or in timely submitted written correspondence delivered to the Regional Water Board.

The tentative permit, tentative cease and desist order, comments received, and related documents may be inspected and copied at the Regional Water Board office.
