The Water Board intends to consider a Tentative Cease and Desist Order (Tentative Order) for the City of Pacifica (City) during a meeting that will commence at a time and place to be determined. The Water Board is currently undergoing negotiations with the City to settle related matters in the Administrative Civil Liability Complaint No. R2-2009-0075. Accordingly, the Prosecution Team will recommend a hearing date based on the progress of these negotiations.

The Tentative Order requires the City to take actions to reduce and eliminate sanitary sewer overflows from its sanitary sewer collection system. The deadline for submittal of written comments on the Tentative Order is **July 28, 2010, at 5 p.m.** Please submit written comments to Gina Kathuria via email at gkathuria@waterboards.ca.gov, mail or fax.
