**Subject: Tentative Order to Update Waste Discharge Requirements for Berkeley Landfill (Cesar Chavez Park), Berkeley, Alameda County**

Enclosed for your review is a Tentative Order to award Waste Discharge Requirements for Berkeley Landfill (the Landfill). The Tentative Order is scheduled to be considered by the Water Board at its regular meeting February 10, 2010. The hearing will be held at:

February 10, 2010, 9:00 a.m.

The Tentative Order would update the Landfill's Waste Discharge Requirements to: 1) reflect changes in closed landfill regulation; 2) require the City to apply for coverage under the General Industrial Storm Water Permit; 3) require an Operations and Maintenance Plan; 4) require an evaluation of the Landfill's Leachate Barrier and Collection Sump System; and 5) to update the Landfill's Self-Monitoring Program.

Written comments on the Tentative Order are being accepted until the close of business on **January 4, 2010**. Comments received after this date may not be considered.
