Dear Messr. Pan and Lichten:

I writing to you in my capacity as an advisor to the San Francisco Bay Regional Water Quality Control Board (Board) concerning Complaint No. R2-2009-0030 issued by the Board's Prosecution Team to Uni Tile & Marble, Inc. (Uni Tile). The Prosecution Team sent a letter on October 8 that proposed that the Board's Advisory Team approve a schedule for the Board's consideration of this matter.

I am approving the schedule subject to the following revisions:

- 1) Uni Tile shall have until November 4 to submit any objections to the Advisory Team to the schedule or such objections will be waived.
- 2) All deadlines proposed in the Prosecution Team's letter are extended by 15 days, with the exception of the date of the Board meeting at which the matter will be heard. The matter will be heard at the Board's February 10, 2010, meeting. The Prosecution Team is directed to issue a revised Hearing Procedure document for this matter that reflects those deadlines and to ensure that it is posted on the Board's enforcement webpage.

When the Prosecution Team issues a revised Hearing Procedure document as described above, it is directed to correct an error in the previously issued Hearing Procedure document. The revised document should not state that the City of San Leandro has been designated as a party in this proceeding.
