Mt. View Sanitary District has filed an application for re-issuance of a permit under the National Pollutant Discharge Elimination System. The San Francisco Bay Regional Water Quality Control Board's (Water Board's) staff has prepared a tentative permit for this discharger containing limitations and provisions in accordance with the Federal Clean Water Act and the California Porter-Cologne Water Quality Control Act.

Mt. View Sanitary District owns and operates a municipal wastewater treatment plant that provides advanced secondary treatment for domestic, commercial, and some industrial wastewater from unincorporated areas of Martinez and portions of the City of Martinez. The plant serves a population of about 23,000 and approximately 270 businesses over a 4,100 acre service area. The plant has a average dry weather design treatment capacity of 3.2 million gallons per day (MGD) and can treat peak wet weather flows up to 11.5 MGD. Effluent is discharged to Moorhen Marsh, which flows to Peyton Slough, where it combines with surface runoff to supply McNabney Marsh. Flows from McNabney Marsh reenter Peyton Slough, which flows to Carquinez Strait.

The Water Board intends to consider adopting the tentative permit during a meeting to commence at the time and location as follows:

The deadline for written comments is 5:00 p.m. on September 6, 2010. Comments must be sent to the attention of Heather Ottaway. Persons wishing to file written comments on or objections to the tentative permit, or other aspects of this matter, must do so no later than this deadline so that such comments may be considered. No written comments will be accepted or responded to in writing if received after the deadline. Interested persons are invited to attend and express their views at the public hearing. The Water Board will hear oral testimony, but will not accept written comments after the deadline indicated above.

Pursuant to section 2050(c) of Title 23 of the California Code of Regulations, any party that challenges a Water Board's action on this matter through a petition to the State Water Resources Control Board under Water Code section 13320 will be limited to raising only those substantive issues or objections that were raised before the Water Board at the public hearing or in timely submitted written correspondence delivered to the Water Board.
