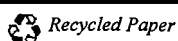

Attached please find a copy of the settlement agreement and stipulated order for the administrative civil liability and a copy of the public notice for this pending action. If approved, the administrative civil liability order would require Atlantic Richfield Company and Union Oil Company of California to each pay \$71,626.50 of the total \$143,253 liability, as proposed in the Settlement Agreement and Stipulation for Administrative Civil Liability Order. Separate checks would be payable to the "State Water Resource Control Board" for deposit in the State Water Pollution Cleanup and Abatement Account no later than thirty (30) days following the Regional Water Board, or its delegee, executing the proposed Order. As discussed in the public notice, the deadline for receiving public comments on this matter is March 30, 2012.


