**TENTATIVE ORDER**

**RESCISSION OF WATER REUSE REQUIREMENTS ORDER NOS. 77-129; 78-071; 85-040; 88-036; 88-060; 90-087; 90-102; 91-130; 91-147; 92-067; 93-070; 93-159; and 94-039 FOR: CITY OF SAN MATEO, SAN MATEO COUNTY; NORTH SAN MATEO COUNTY SANITATION DISTRICT, DALY CITY; SOUTH BAYSIDE SYSTEM AUTHORITY, SAN MATEO COUNTY; CITY OF PETALUMA, SONOMA COUNTY; CITY OF CALISTOGA, NAPA COUNTY; CITY OF LIVERMORE, ALAMEDA COUNTY; CENTRAL CONTRA COSTA SANITARY DISTRICT, CONTRA COSTA COUNTY; FAIRFIELD-SUISUN SEWER DISTRICT, SOLANO COUNTY; SONOMA VALLEY COUNTY SANITATION DISTRICT, SONOMA COUNTY; LIVERMORE-AMADOR VALLEY WATER MANAGEMENT AGENCY, ALAMEDA COUNTY; ALAMEDA COUNTY FLOOD CONTROL AND WATER CONSERVATION DISTRICT, ZONE 7, ALAMEDA COUNTY; NAPA SANITATION DISTRICT, NAPA COUNTY**

The California Regional Water Quality Control Board, San Francisco Bay Region (hereinafter the Regional Water Board), finds that:

- 1. Purpose of Order:** This Order will rescind Water Reuse Requirement Orders for the following dischargers:

**2. Basis for Rescission:** The Regional Water Board issued Order Nos. 77-129; 78-071; 85-040; 88-036; 88-060; 90-087; 90-102; 91-130; 91-147; 92-067; 93-070; 93-159; and 94-039 to the above named dischargers to operate their recycled water programs. Since the time of issuance the dischargers have either: 1) subsequently received the Executive Officer's authorization letter to enroll under Regional Water Board's General Water Reuse Requirements Order No. 96-011; or 2) ceased operating their recycled water program. The water reuse requirements

prescribed by Order No. 96-011 supersede the water reuse requirements prescribed by these previous individual Orders.

Order No. 96-011 is a region-wide general permit for publicly owned wastewater and water agencies that recycle treated municipal wastewater. It is intended to replace individual reuse Orders and authorize municipal wastewater reuse by producers, distributors and users of non-potable recycled wastewater throughout the region. This rescission Order does not update or modify any of the requirements in Order No. 96-011 and is consistent with Provision D.2 of Order No. 96-011: "Current Water Reclamation Reuse Requirements that are superseded by this Order pursuant to Provisions C.1 and 2, will be rescinded under a separate Order(s)."

3. **CEQA:** This action rescinds an order to enforce the laws and regulations administered by the Regional Water Board. Rescission of the Order is not a project as defined in the California Environmental Quality Act (CEQA). There is no possibility that the activity in question may have a significant effect on the environment. (Cal. Code Regs., tit. 14 §§ 15378 and 15061, subd. (b) (3).)
4. **Notification:** The Regional Water Board has notified dischargers and all interested agencies and persons of its intent to rescind water reuse requirement Orders and has provided them with an opportunity to submit their written comments.
5. **Public Hearing:** The Regional Water Board, at a public meeting, heard and considered all comments pertaining to this rescission Order.

**IT IS HEREBY ORDERED**, that Order Nos. 77-129; 78-071; 85-040; 88-036; 88-060; 90-087; 90-102; 91-130; 91-147; 92-067; 93-070; 93-159; and 94-039 are rescinded.
