**Subject: Transmittal of Settlement Agreement and Stipulation for Administrative Civil Liability Order No. R2-2016-1034 for the San Francisco Public Utilities Commission, San Francisco City and County**

Dear Mr. Kelly:

Enclosed is Order No. R2-2016-1034, which imposes an administrative civil liability in the amount of \$611,100 to the San Francisco Public Utilities Commission (SFPUC) for the unauthorized discharge of inadequately treated wastewater to waters of the United States. The full liability amount is suspended pending completion of the Supplemental Environmental Project (SEP).

As part of SEP implementation, quarterly progress reports and a final completion report are required. The next quarterly progress report is due January 15, 2017, and certification of completion of the project is due June 15, 2018, as set forth in SFPUC's SEP proposal (Exhibit E) of the Order.
