NOTICE OF PROPOSED SETTLEMENT AGREEMENT AND STIPULATED ORDER in the matter of VALERO REFINING COMPANY-CALIFORNIA IMPROPER OPERATION OF TREATMENT SYSTEM RESULTING IN EFFLUENT LIMIT VIOLATIONS VALERO BENICIA REFINERY SOLANO COUNTY

The California Regional Water Quality Control Board, San Francisco Bay Region (Water Board) Prosecution Team and Valero Refining Company-California (Discharger) have entered into a Settlement Agreement and Stipulated Order (proposed settlement). The proposed settlement would impose an administrative civil liability against the Discharger in the amount of \$179,000, including \$15,000 mandatory minimum penalties for alleged discharges in violation of NPDES permit effluent limits to waters of the United States.

This proposed liability is based on allegations that the Discharger violated permit effluent limits in December 2014 and January 2016.

The proposed settlement would allow \$89,500 to be suspended pending a Supplemental Environmental Project to fund the San Francisco Bay Regional Monitoring Program, to conduct a selenium monitoring study in Suisun Bay.
