Subject: Transmittal of Amended Tentative Cleanup and Abatement Order for Mr. Reza Gholom Valiye for Unpermitted Placement of Fill in Appian Creek at 4500 Appian Way, Contra Costa County

Dear Mr. Reza Gholom Valiye:

Enclosed is an amended tentative cleanup and abatement order (CAO) requiring you to cleanup and abate the unauthorized discharge of fill into Appian Creek at 4500 Appian Way, El Sobrante. The CAO is being provided in draft form, and the Dischargers and designated or interested parties may provide comments to the proposed draft until **November 14, 2016**. Written comments submitted after this date may not be considered by the Regional Water Board. Pursuant to Title 23 of the California Code of Regulations, section 2050(c), any party who challenges the Regional Water Board's action on this matter through a petition to the State Water Board pursuant to Water Code section 13320 will be limited to raising only those substantive issues or objections that were raised before the Regional Water Board at the public meeting or in timely written correspondence submitted to the Regional Water Board as described above.

We previously sent you a tentative cleanup and abatement order on August 12, 2016 to the email address above, which we have used in the past to communicate with you, and to the address of the site above. We understand that you did not receive the hard copy at that address so we are sending you another hard copy at the new address you provided with ten more days to comment. Please note that we made several amendments to the tentative cleanup and abatement order.

The amended tentative CAO is being posted for ten more days due to several changes and corrections in the wording. If you have already submitted comments, they have already been considered and there is no need to resubmit.
