Subject: Notice of Opportunity to Comment, and Public Hearing for Updated Waste Discharge Requirements and Rescission of Order No. R2-2009-0034, Tonnesen Pet Cemetery, Solano County

Dear Ms. Tonnesen,

The California Regional Water Quality Control Board, San Francisco Bay Region (Regional Water Board) is updating the waste discharge requirements for the Tonnesen Pet Cemetery located at the end of Scally Road, approximately one-half mile south of Highway 12, two miles southeast of Suisun City. The purpose for this update is to reflect a change in operations that affects the classification and regulation of the site.

The deadline for receipt of comment on the draft resolution is 5:00 p.m. on May 19, 2017. Comments must be sent to the attention of Cleet Carlton. Persons wishing to file written comments on or objections to the tentative permit or other aspects of this matter must do so no later than this deadline so that such comments may be considered.

The Board will consider the tentative resolution during a meeting to commence at 9:00 a.m. on June 14, 2017, in the Auditorium of the Elihu Harris Building at 1515 Clay Street in Oakland. Interested persons are invited to attend and express their views at the public hearing.

Pursuant to California Code of Regulations Title 23 section 2050(c), any party that challenges the Board's action on this matter through a petition to the State Water Resources Control Board under Water Code section 13320 will be limited to raising only those substantive issues or objections that were raised before the Board at the public hearing or in timely submitted written correspondence.

All documents related to the tentative resolution may be inspected and copied at the Board office. The tentative resolution and any developments on this matter are also
