STAFF SUMMARY REPORT (Gaurav Mittal) MEETING DATE: July 10, 2019

**ITEM**: **5.C** 

SUBJECT: City of South San Francisco and San Bruno and North Bayside

System Unit, South San Francisco / San Bruno Water Quality Control Plant and Wastewater Collection Systems, South San Francisco, San Mateo County — Reissuance of NPDES Permit

**CHRONOLOGY:** April 2014 – Permit reissued

**DISCUSSION:** This Revised Tentative Order (Appendix A) would reissue the NPDES

permit for the South San Francisco / San Bruno Water Quality Control Plant and North Bayside System Unit based on current data and updated

State and regional policies and regulations.

The plant provides secondary treatment for about 8.3 million gallons per day of sanitary, commercial, and industrial wastewater for discharge through a deepwater outfall shared with other North Bayside System Unit dischargers (i.e., San Francisco International Airport, Millbrae, and Burlingame). The outfall is located in Lower San Francisco Bay, approximately 5,200 feet offshore near Point San Bruno.

We received comments from the City of South San Francisco (Appendix B) on a draft permit distributed for review. We prepared responses (Appendix C) that explain the changes reflected in the Revised Tentative Order. Our responses clarify that the Revised Tentative Order would require the City to propose, but not necessarily adopt, a private sewer lateral ordinance. If it does adopt an ordinance and meets certain other conditions, the Revised Tentative Order would approve occasional wet weather bypasses of biological treatment. During the previous permit term, we approved five wet weather bypasses totaling about 18 million gallons. We expect this item to be uncontested.

#### I. FACILITY INFORMATION

Information describing the South San Francisco / San Bruno Water Quality Control Plant, City of South San Francisco and City of San Bruno wastewater collection systems, and North Bayside System Unit (NBSU) facilities (collectively, Facility) is summarized in Table 1 and Fact Sheet (Attachment F) sections I and II.

#### **II. FINDINGS**

The California Regional Water Quality Control Board, San Francisco Bay Region (Regional Water Board), finds:

- **A.** Legal Authorities. This Order serves as WDRs pursuant to California Water Code article 4, chapter 4, division 7 (commencing with § 13260). This Order is also issued pursuant to federal Clean Water Act (CWA) section 402 and implementing regulations adopted by U.S. EPA and Water Code chapter 5.5, division 7 (commencing with § 13370). It shall serve as a National Pollutant Discharge Elimination System (NPDES) permit authorizing the Discharger to discharge into waters of the United States as listed in Table 2 subject to the WDRs in this Order.
- **B.** Background and Rationale for Requirements. The Regional Water Board developed the requirements in this Order based on information the Discharger submitted as part of its application, information obtained through monitoring and reporting programs, and other available information. The Fact Sheet (Attachment F) contains background information and rationale for the requirements in this Order and is hereby incorporated into and constitutes findings for this Order. Attachments A through E, G, and H are also incorporated into this Order.
- **C. Notification of Interested Parties.** The Regional Water Board notified the Discharger and interested agencies and persons of its intent to prescribe these WDRs and provided an opportunity to submit written comments and recommendations. The Fact Sheet provides details regarding the notification.
- **D.** Consideration of Public Comment. The Regional Water Board, in a public meeting, heard and considered all comments pertaining to the discharge. The Fact Sheet provides details regarding the public hearing.

**THEREFORE, IT IS HEREBY ORDERED** that Order No. R2-2014-0012 (previous order) is rescinded upon the effective date of this Order, except for enforcement purposes, and, in order to meet the provisions of Water Code division 7 (commencing with § 13000) and regulations adopted thereunder and the provisions of the CWA and regulations and guidelines adopted thereunder, the Discharger shall comply with the requirements in this Order. This action in no way prevents the Regional Water Board from taking enforcement action for past violations of the previous order.

#### III.DISCHARGE PROHIBITIONS

- **A.** Discharge of treated or partially-treated wastewater at a location or in a manner different from that described in this Order is prohibited.
- **B.** Discharge at Discharge Point No. 002 is prohibited when treated wastewater does not receive an initial dilution of at least 63:1, as modeled. Compliance shall be achieved by proper operation and maintenance of the discharge outfall to ensure that it (or its replacement, in whole or part) is in good

working order and is consistent with dilution ratios in Fact Sheet Table F-8 or can achieve better mixing than that described in Fact Sheet section IV.C.4.b. The Discharger shall address measures taken to ensure this in its application for permit reissuance.

**C.** Bypass of untreated or partially-treated wastewater to waters of the United States is prohibited, except as provided for in Attachment D section I.G of this Order.

Blended wastewater is biologically treated wastewater blended with wastewater diverted around biological treatment units. Such discharges are approved pursuant to 40 C.F.R. section 122.41(m)(4) and Attachment D section I.G.4 when the following conditions are met:

- 1. The peak wet weather influent flow volume exceeds the wet weather capacity (currently 30 million gallons per day [MGD]);
- 2. The discharge complies with this Order's effluent and receiving water limitations;
- **3.** The Discharger fully complies with Provision VI.C.5.a;
- **4.** The City of San Bruno continues to implement a transfer of title private sewer lateral inspection ordinance, and the City of South San Francisco implements a transfer of title private sewer lateral inspection ordinance by January 1, 2021; and
- **5.** The Facility is operated as designed and in accordance with the Operation and Maintenance Manual developed for the Facility (i.e., the Discharger shall optimize storage and use of equalization units and shall fully utilize the biological treatment units).

The Discharger shall report incidents of wet weather bypasses in routine monitoring reports and shall monitor blended discharge as specified in the Monitoring and Reporting Program (MRP) (Attachment E) section IV.B.

- **D.** Average dry weather influent flow in excess of 13 MGD is prohibited. Average dry weather influent flow shall be determined from three consecutive dry weather months each year, with compliance measured at Monitoring Location INF-001 as described in the MRP.
- **E.** Any sanitary sewer overflow that results in a discharge of untreated or partially-treated wastewater to waters of the United States is prohibited.

## IV. EFFLUENT LIMITATIONS AND DISCHARGE SPECIFICATIONS

**A.** Effluent Limitations. The Discharger shall comply with the following effluent limitations at Discharge Point No. 002, with compliance measured at Monitoring Location EFF-001, except total chlorine residual shall be measured at Monitoring Location EFF-002 and total cyanide shall be measured at Monitoring Location EFF-001 or Monitoring Location EFF-002, as described in the MRP:

- [1] If the Discharger monitors pH continuously, pursuant to 40 C.F.R. section 401.17 the Discharger shall be in compliance with this pH limitation provided that both of the following conditions are satisfied: (i) the total time during which the pH is outside the required range shall not exceed 7 hours and 26 minutes in any calendar month; and (ii) no individual excursion from the required pH range shall exceed 60 minutes.
  - **B. Percent Removal.** The average monthly percent removal of BOD<sub>5</sub> and TSS at Discharge Point No. 002 shall not be less than 85 percent (i.e., in each calendar month, the arithmetic mean of BOD<sub>5</sub> and TSS, by concentration, of effluent samples collected at Monitoring Location EFF-001 as described in the MRP, shall not exceed 15 percent of the arithmetic mean of BOD<sub>5</sub> and TSS, by concentration, of influent samples collected at Monitoring Location INF-001 as described in the MRP, at approximately the same times during the same periods). For a calendar month in which the Discharger discharges blended effluent at Discharge Point No. 001, the BOD<sub>5</sub> and TSS monthly arithmetic mean and percent removal shall include results of blended effluent samples collected at Monitoring Location EFF-001B flow-weighted with effluent samples collected at Monitoring Locations EFF-001.
  - **C. Fecal Coliform Bacteria.** The discharge at Discharge Point No. 002 shall meet the following fecal coliform bacteria effluent limitations, with compliance measured at Monitoring Location EFF-001, as described in the MRP:
    - 1. The geometric mean of all fecal coliform bacteria samples in a calendar month shall not exceed 200 most probable number per 100 milliliters (MPN/100 mL); and

- **2.** The 11-sample 90<sup>th</sup> percentile of all fecal coliform bacteria samples shall not exceed 400 MPN/100 mL.
- **D.** Enterococcus Bacteria. The discharge at Discharge Point No. 002 shall meet the following enterococcus effluent limitations, with compliance measured at Monitoring Location EFF-001, as described in the MRP:
  - 1. The six-week rolling geometric mean of enterococcus bacteria, calculated weekly, shall not exceed 30 colony forming units per 100 milliliters (CFU/100 mL); and
  - 2. The  $90^{th}$  percentile of all enterococcus bacteria samples collected in a calendar month shall not exceed 110 CFU/100 mL.
- **E.** Acute Toxicity. The discharge at Discharge Point No. 002 shall meet the following acute toxicity effluent limitations, with compliance measured at Monitoring Location EFF-001, as described in the MRP:
  - 1. Eleven-sample median of not less than 90 percent survival; and
  - 2. Eleven-sample 90<sup>th</sup> percentile of not less than 70 percent survival.

These acute toxicity limitations are defined as follows:

- **Eleven-sample median.** A bioassay test showing survival of less than 90 percent represents a violation of this effluent limit if five or more of the past ten or fewer bioassay tests show less than 90 percent survival.
- **Eleven-sample 90<sup>th</sup> percentile.** A bioassay test showing survival of less than 70 percent represents a violation of this effluent limit if one or more of the past ten or fewer bioassay tests show less than 70 percent survival.

If the Discharger can demonstrate that toxicity exceeding the levels cited above is caused solely by ammonia and that the ammonia in the discharge complies with the ammonia effluent limits in Table 4 of this Order, then such toxicity shall not constitute a violation of the acute toxicity effluent limitations.

#### V. RECEIVING WATER LIMITATIONS

- **A**. The discharge shall not cause the following conditions to exist in receiving waters at any place:
  - 1. Floating material, including solids, liquids, foams, and scum, in concentrations that cause nuisance or adversely affect beneficial uses;
  - **2.** Alteration of suspended sediment in such a manner as to cause nuisance or adversely affect beneficial uses or detrimental increase in the concentrations of toxic pollutants in sediments or aquatic life;
  - 3. Suspended material in concentrations that cause nuisance or adversely affect beneficial uses;
  - **4.** Bottom deposits or aquatic growths to the extent that such deposits or growths cause nuisance or adversely affect beneficial uses;

- 5. Alteration of temperature beyond present natural background levels unless it can be demonstrated to the satisfaction of the Regional Water Board that such alteration in temperature does not adversely affect beneficial uses;
- **6.** Changes in turbidity that cause nuisance or adversely affect beneficial uses, or increases from normal background light penetration or turbidity greater than 10 percent in areas where natural turbidity is greater than 50 nephelometric turbidity units;
- 7. Coloration that causes nuisance or adversely affects beneficial uses;
- 8. Visible, floating, suspended, or deposited oil or other products of petroleum origin; or
- **9.** Toxic or other deleterious substances in concentrations or quantities that cause deleterious effects on wildlife, waterfowl, or other aquatic biota, or render any of these unfit for human consumption, either at levels created in the receiving waters or as a result of biological concentration.
- **B**. The discharge shall not cause the following limits to be exceeded in receiving waters at any place within one foot of the water surface:
  - **1.** Dissolved Oxygen 5.0 mg/L, minimum

The median dissolved oxygen concentration for any three consecutive months shall not be less than 80 percent of the dissolved oxygen content at saturation. When natural factors cause concentrations less than that specified above, the discharge shall not cause further reduction in ambient dissolved oxygen concentrations.

**2.** Dissolved Sulfide Natural background levels

**3.** pH The pH shall not be depressed below 6.5 or raised above 8.5. The discharge shall not cause changes greater than 0.5 pH units in

normal ambient pH levels.

**4.** Nutrients Waters shall not contain biostimulatory substances in

concentrations that promote aquatic growths to the extent that such

growths cause nuisance or adversely affect beneficial uses.

C. The discharge shall not cause or contribute to a violation of any water quality standard for receiving waters adopted by the Regional Water Board or State Water Resources Control Board (State Water Board) as required by the CWA and regulations adopted thereunder. If more stringent water quality standards are promulgated or approved pursuant to CWA section 303, or amendments thereto, the Regional Water Board may revise or modify this Order in accordance with the more stringent standards.

#### VI. PROVISIONS

## A. Standard Provisions

1. The Discharger shall comply with all "Standard Provisions" in Attachment D.

2. The Discharger shall comply with all applicable provisions of the "Regional Standard Provisions, and Monitoring and Reporting Requirements for NPDES Wastewater Discharge Permits" in Attachment G.

## **B.** Monitoring and Reporting

The Discharger shall comply with the MRP (Attachment E) and future revisions thereto and applicable sampling and reporting requirements in Attachments D and G.

## C. Special Provisions

## 1. Reopener Provisions

The Regional Water Board may modify or reopen this Order prior to its expiration date in any of the following circumstances as allowed by law:

- **a.** If present or future investigations demonstrate that the discharges governed by this Order have or will have a reasonable potential to cause or contribute to adverse impacts on water quality or beneficial uses of the receiving waters.
- b. If new or revised water quality objectives or total maximum daily loads (TMDLs) come into effect for San Francisco Bay or contiguous water bodies (whether statewide, regional, or site-specific). In such cases, effluent limitations in this Order may be modified as necessary to reflect the updated water quality objectives and wasteload allocations in the TMDLs. Adoption of the effluent limitations in this Order is not intended to restrict in any way future modifications based on legally-adopted water quality objectives or TMDLs or as otherwise permitted under federal regulations governing NPDES permit modifications.
- **c.** If translator, dilution, or other water quality studies provide a basis for determining that a permit condition should be modified.
- **d.** If State Water Board precedential decisions, new policies, new laws, or new regulations are adopted.
- **e.** If an administrative or judicial decision on a separate NPDES permit or WDRs addresses requirements similar to this discharge.
- **f.** If the Discharger requests adjustments in effluent limits due to the implementation of stormwater diversion pursuant to the Municipal Regional Stormwater Permit (Permit No. CAS612008) for redirecting dry weather and first flush discharges from the storm drain system to the sanitary sewer system as a stormwater pollutant control strategy.
- **g.** Or as otherwise authorized by law.

The Discharger may request a permit modification based on any of the circumstances above. With any such request, the Discharger shall include antidegradation and anti-backsliding analyses.

#### 2. Effluent Characterization Study and Report

a. Study Elements. The Discharger shall characterize and evaluate the discharge from Discharge Point No. 002, as required by the MRP, to verify that the reasonable potential analysis conclusions of this Order remain valid and to inform the next permit reissuance. The Discharger shall evaluate on an annual basis if concentrations of any of the priority pollutants listed in Attachment G, Table B, significantly increase over past performance. The Discharger shall investigate the cause of any such increase. The investigation may include, but need not be limited to, an increase in monitoring frequency, monitoring of internal process streams, and monitoring of influent sources. The Discharger shall establish remedial measures addressing any increase resulting in reasonable potential to cause or contribute to an exceedance of applicable water quality objectives. This requirement may be satisfied through identification of the constituent as a "pollutant of concern" in the Discharger's Pollutant Minimization Program, described in Provision VI.C.3.

## **b.** Reporting Requirements

- **i. Routine Reporting.** The Discharger shall report the pollutants detected at or above applicable water quality objectives (see Fact Sheet Table F-7 for the objectives) in the transmittal letter for the self-monitoring report associated with the month in which samples were collected.
- **ii. Annual Reporting.** The Discharger shall summarize the annual data evaluation and source investigation in the annual self-monitoring report.

## 3. Pollutant Minimization Program

- **a.** The Discharger shall continue to improve its existing Pollutant Minimization Program to promote minimization of pollutant loadings to the treatment plant and therefore to the receiving waters.
- **b.** The Discharger shall submit an annual report no later than February 28 of each calendar year. Each annual report shall include at least the following information:
  - **i. Brief description of treatment plant.** The description shall include the service area and treatment plant processes.
  - **ii. Discussion of current pollutants of concern.** Periodically, the Discharger shall analyze its circumstances to determine which pollutants are currently a problem and which pollutants may be potential future problems. This discussion shall include the reasons for choosing the pollutants.
  - **iii. Identification of sources for pollutants of concern.** This discussion shall include how the Discharger intends to estimate and identify pollutant sources. The Discharger shall include sources or potential sources not directly within the ability or authority of the Discharger to control, such as pollutants in the potable water supply and air deposition.

- **iv. Identification of tasks to reduce the sources of pollutants of concern.** This discussion shall identify and prioritize tasks to address the Discharger's pollutants of concern. The Discharger may implement the tasks by itself or participate in group, regional, or national tasks that address its pollutants of concern. The Discharger is strongly encouraged to participate in group, regional, or national tasks that address its pollutants of concern whenever it is efficient and appropriate to do so. An implementation timeline shall be included for each task.
- v. Outreach to employees. The Discharger shall inform employees about the pollutants of concern, potential sources, and how they might be able to help reduce the discharge of these pollutants of concern into the Facility. The Discharger may provide a forum for employees to provide input.
- vi. Continuation of Public Outreach Program. The Discharger shall prepare a pollution prevention public outreach program for its service area. Outreach may include participation in existing community events, such as county fairs; initiating new community events, such as displays and contests during Pollution Prevention Week; conducting school outreach programs; conducting plant tours; and providing public information in newspaper articles or advertisements, radio or television stories or spots, newsletters, utility bill inserts, or web sites. Information shall be specific to target audiences. The Discharger shall coordinate with other agencies as appropriate.
- vii. Discussion of criteria used to measure Pollutant Minimization Program and task effectiveness. The Discharger shall establish criteria to evaluate the effectiveness of its Pollutant Minimization Program. This discussion shall identify the specific criteria used to measure the effectiveness of each task in Provisions VI.C.3.b.iii, iv, v, and vi.
- **viii. Documentation of efforts and progress.** This discussion shall detail all of the Discharger's Pollutant Minimization Program activities during the reporting year.
- **ix.** Evaluation of Pollutant Minimization Program and task effectiveness. The Discharger shall use the criteria established in Provision VI.C.3.b.vii to evaluate the program and task effectiveness.
- x. Identification of specific tasks and timelines for future efforts. Based on the evaluation, the Discharger shall explain how it intends to continue or change its tasks to more effectively reduce the amount of pollutants flowing to the treatment plant, and subsequently in its effluent.
- c. The Discharger shall develop and conduct a Pollutant Minimization Program as further described below when there is evidence that a priority pollutant is present in the effluent above an effluent limitation (e.g., sample results reported as detected but not quantified [DNQ] when the effluent limitation is less than the method detection limit [MDL], sample results from analytical methods more sensitive than those methods required by this Order, presence of whole effluent toxicity, health advisories for fish consumption, or results of benthic or aquatic organism tissue sampling) and either:
  - i. A sample result is reported as DNQ and the effluent limitation is less than the Reporting Level (RL); or

- **ii.** A sample result is reported as not detected (ND) and the effluent limitation is less than the MDL, using definitions in Attachment A and reporting protocols described in the MRP.
- **d.** If triggered by the reasons set forth in Provision VI.C.3.c, above, the Discharger's Pollutant Minimization Program shall include, but not be limited to, the following actions and submittals:
  - i. Annual review and semi-annual monitoring of potential sources of the reportable priority pollutants, which may include fish tissue monitoring and other bio-uptake sampling, or alternative measures when source monitoring is unlikely to produce useful analytical data;
  - **ii.** Quarterly monitoring for the reportable priority pollutants in the influent to the Facility. The Executive Officer may approve alternative measures when influent monitoring is unlikely to produce useful analytical data;
  - **iii.** Submittal of a control strategy designed to proceed toward the goal of maintaining concentrations of the reportable priority pollutants in the effluent at or below the effluent limitation;
  - **iv.** Implementation of appropriate cost-effective control measures for the reportable priority pollutants, consistent with the control strategy; and
  - **v.** Inclusion of the following specific items within the annual report required by Provision VI.C.3.b above:
    - (a) All Pollutant Minimization Program monitoring results for the previous year;
    - **(b)** List of potential sources of the reportable priority pollutants;
    - (c) Summary of all actions undertaken pursuant to the control strategy; and
    - (d) Description of actions to be taken in the following year.

## 4. Special Provisions for Publicly-Owned Treatment Works

- a. **Pretreatment Program.** The Discharger shall implement and enforce its approved pretreatment program in accordance with federal pretreatment regulations (40 C.F.R. part 403); pretreatment standards promulgated under CWA sections 307(b), 307(c), and 307(d); pretreatment requirements specified under 40 C.F.R. section 122.44(j); and the requirements in Attachment H, "Pretreatment Requirements." The Discharger's responsibilities include, but are not limited to, the following:
  - i. Enforcement of the National Pretreatment Standards of 40 C.F.R. sections 403.5 and 403.6;
  - **ii.** Implementation of its pretreatment program in accordance with legal authorities, policies, procedures, and financial provisions described in the National Pretreatment Program (40 C.F.R. part 403);
  - iii. Submission of reports to the State Water Board and the Regional Water Board as described in Attachment H; and

**iv.** Evaluation of the need to revise local limits under 40 C.F.R. section 403.5(c)(1) and, within 180 days following the effective date of this Order, submission of a report describing the changes, with a plan and schedule for implementation.

## b. Sludge and Biosolids Management

- i. Sludge and biosolids treatment and storage shall not create a nuisance, such as objectionable odors or flies, or result in groundwater contamination.
- **ii.** Sludge and biosolids treatment and storage site shall have facilities adequate to divert surface runoff from adjacent areas, to protect site boundaries from erosion, and to prevent conditions that would cause drainage from the stored materials. Adequate protection is defined as protection from at least a 100-year storm and the highest possible tidal stage that may occur.
- **iii.** This Order does not authorize permanent onsite sludge or biosolids storage or disposal. The Discharger shall file a Report of Waste Discharge and bring the site into compliance with applicable regulations prior to commencement of any such activity.
- **c.** Collection System Management. The Discharger shall properly operate and maintain its collection system (see Attachments D and G, section I.D), report any noncompliance with respect to its collection system (see Attachment D, section V.E.1, and Attachment G, sections V.E.1 and V.E.2), and mitigate any discharges in violation of this Order associated with its collection system (see Attachments D and G, section I.C).

State Water Board Order No. 2006-0003-DWQ, Statewide General Waste Discharge Requirements for Sanitary Sewer Systems, as amended by State Water Board Order No. WQ 2013-0058-EXEC (statewide WDRs), contains requirements for operation and maintenance of collection systems and for reporting and mitigating sanitary sewer overflows. The statewide WDRs clearly and specifically stipulate requirements for operation and maintenance and for reporting and mitigating sanitary sewer overflows. Implementing the requirements for operation and maintenance and mitigation of sanitary sewer overflows set forth in the statewide WDRs (and any subsequent order updating these requirements) shall satisfy the corresponding federal NPDES requirements specified in Attachments D and G of this Order for the collection systems. Following the reporting requirements set forth in the statewide WDRs (and any subsequent order updating these requirements) shall satisfy the NPDES reporting requirements for sanitary sewer overflows specified in Attachments D and G.

## 5. Other Special Provisions

**a. Specific Tasks to Reduce Wet Weather Bypasses.** The Discharger shall implement the following specific tasks to minimize wet weather diversions and reduce blending in accordance with the following tasks and time schedule:

**d. Anaerobically-Digestible Material.** If the Discharger receives hauled-in anaerobically-digestible material for injection into an anaerobic digester, the Discharger shall notify the Regional Water Board and develop and implement Standard Operating Procedures for this activity. The Standard Operating Procedures shall be developed prior to initiation of

hauling. The Standard Operating Procedures shall address material handling, including unloading, screening, or other processing prior to anaerobic digestion; transportation; spill prevention; spill response; avoidance of the introduction of materials that could cause interference, pass through, or upset of the treatment processes; avoidance of prohibited material; vector control; odor control; operation and maintenance; and the disposition of any solid waste segregated from introduction to the digester. The Discharger shall train its staff on the Standard Operating Procedures and maintain records for a minimum of three years for each load received, describing the hauler, waste type, and quantity received. In addition, the Discharger shall maintain records for a minimum of three years for the disposition, location, and quantity of cumulative pre-digestion segregated solid waste hauled offsite.

- **e. Plant Upgrades.** At least 30 days prior to placing any upgraded unit listed in Fact Sheet section II.E into service, the Discharger shall submit the following documentation:
  - i. Documentation that the reliability, capability, and performance of the plant upgrades will maintain compliance with waste discharge requirements (i.e., the Discharger shall evaluate the hydraulic and organic loading capacities of the treatment facilities by appropriate combinations of desk-top analyses and treatment process stress testing to simulate design peak loading conditions under both dry weather and wet weather design flow conditions);
  - **ii.** Certification that plant upgrades have been constructed as designed, have been tested, and are ready for use;
  - **iii.** Demonstration of compliance with all applicable provisions of CEQA (California Public Resources Code Division 13, Chapter 3, Section 21100 et seq.);
  - iv. Updates to the Operations and Maintenance Manual and Contingency Plan to include the plant upgrades; and
  - **v.** Specific date the Discharger proposes to commence use of the upgraded treatment plant.

Under Water Code section 13385(j)(1)(D), the Discharger may, at least 30 days in advance of operating the upgraded treatment plant, submit a startup operations plan. The plan would describe the actions the Discharger will take during a specific period that requires adjusting and testing new treatment plant units, including steps to prevent violations of this Order. If the Discharger pursues this option, it should define the shortest reasonable time required for the period of adjusting and testing, which is not to exceed 90 days for biological treatment units and 30 days for any other treatment unit.

#### ATTACHMENT A – DEFINITIONS

## Arithmetic Mean (µ)

Also called the average, the sum of measured values divided by the number of samples. For ambient water concentrations, the arithmetic mean is calculated as follows:

Arithmetic mean =  $\mu = \Sigma x / n$  where:  $\Sigma x$  is the sum of the measured ambient water concentrations, and n is the number of samples.

## **Average Monthly Effluent Limitation (AMEL)**

The highest allowable average of daily discharges over a calendar month, calculated as the sum of all daily discharges measured during a calendar month divided by the number of daily discharges measured during that month.

## **Average Weekly Effluent Limitation (AWEL)**

The highest allowable average of daily discharges over a calendar week (Sunday through Saturday), calculated as the sum of all daily discharges measured during a calendar week divided by the number of daily discharges measured during that week.

#### **Bioaccumulative**

Taken up by an organism from its surrounding medium through gill membranes, epithelial tissue, or from food and subsequently concentrated and retained in the body of the organism.

#### Carcinogenic

Known to cause cancer in living organisms.

## **Coefficient of Variation**

Measure of data variability calculated as the estimated standard deviation divided by the arithmetic mean of the observed values.

## **Daily Discharge**

Either: (1) the total mass of the constituent discharged over the calendar day (12:00 am through 11:59 pm) or any 24-hour period that reasonably represents a calendar day for purposes of sampling (as specified in the permit) for a constituent with limitations expressed in units of mass; or (2) the unweighted arithmetic mean measurement of the constituent over the day for a constituent with limitations expressed in other units of measurement (e.g., concentration).

The daily discharge may be determined by the analytical results of a composite sample taken over the course of one day (a calendar day or other 24-hour period defined as a day) or by the arithmetic mean of analytical results from one or more grab samples taken over the course of the day.

For composite sampling, if 1 day is defined as a 24-hour period other than a calendar day, the analytical result for the 24-hour period is considered the result for the calendar day in which the 24-hour period ends.

#### **Detected, but Not Quantified (DNQ)**

Sample result less than the RL, but greater than or equal to the laboratory's MDL. Sample results reported as DNQ are estimated concentrations.

Attachment A– Definitions A-1

#### **Dilution Credit**

Amount of dilution granted to a discharge in the calculation of a water quality-based effluent limitation, based on the allowance of a specified mixing zone. It is calculated from the dilution ratio or determined by conducting a mixing zone study or modeling the discharge and receiving water.

#### **Effluent Concentration Allowance (ECA)**

Value derived from the water quality criterion/objective, dilution credit, and ambient background concentration that is used, in conjunction with the CV for the effluent monitoring data, to calculate a long-term average (LTA) discharge concentration. The ECA has the same meaning as wasteload allocation (WLA) as used in U.S. EPA guidance (*Technical Support Document For Water Quality-based Toxics Control*, March 1991, second printing, EPA/505/2-90-001).

#### **Enclosed Bay**

Indentation along the coast that encloses an area of oceanic water within a distinct headlands or harbor works. Enclosed bays include all bays where the narrowest distance between the headlands or outermost harbor works is less than 75 percent of the greatest dimension of the enclosed portion of the bay. Enclosed bays include, but are not limited to, Humboldt Bay, Bodega Harbor, Tomales Bay, Drake's Estero, San Francisco Bay, Morro Bay, Los Angeles-Long Beach Harbor, Upper and Lower Newport Bay, Mission Bay, and San Diego Bay. Enclosed bays do not include inland surface waters or ocean waters.

#### **Estimated Chemical Concentration**

Concentration that results from the confirmed detection of the substance below the ML value by the analytical method.

#### **Estuaries**

Waters, including coastal lagoons, located at the mouths of streams that serve as areas of mixing for fresh and ocean waters. Coastal lagoons and mouths of streams that are temporarily separated from the ocean by sandbars are considered estuaries. Estuarine waters are considered to extend from a bay or the open ocean to a point upstream where there is no significant mixing of fresh water and seawater. Estuarine waters include, but are not limited to, the Sacramento-San Joaquin Delta, as defined in Water Code section 12220, Suisun Bay, Carquinez Strait downstream to the Carquinez Bridge, and appropriate areas of the Smith, Mad, Eel, Noyo, Russian, Klamath, San Diego, and Otay rivers. Estuaries do not include inland surface waters or ocean waters.

#### **Inland Surface Waters**

All surface waters of the state that do not include the ocean, enclosed bays, or estuaries.

#### **Instantaneous Maximum Effluent Limitation**

Highest allowable value for any single grab sample or aliquot (i.e., each grab sample or aliquot is independently compared to the instantaneous maximum limitation).

#### **Instantaneous Minimum Effluent Limitation**

Lowest allowable value for any single grab sample or aliquot (i.e., each grab sample or aliquot is independently compared to the instantaneous minimum limitation).

Attachment A – Definitions A-2

## **Maximum Daily Effluent Limitation (MDEL)**

Highest allowable daily discharge of a pollutant, over a calendar day (or 24-hour period). For pollutants with limitations expressed in units of mass, the daily discharge is calculated as the total mass of the pollutant discharged over the day. For pollutants with limitations expressed in other units of measurement, the daily discharge is calculated as the arithmetic mean measurement of the pollutant over the day.

#### Median

Middle measurement in a set of data. The median of a set of data is found by first arranging the measurements in order of magnitude (either increasing or decreasing order). If the number of measurements (n) is odd, then the median =  $X_{(n+1)/2}$ . If n is even, then the median =  $X_{(n/2)+1}/2$  (i.e., the midpoint between n/2 and n/2+1).

#### **Method Detection Limit (MDL)**

Minimum concentration of a substance that can be reported with 99 percent confidence that the measured concentration is distinguishable from method blank results, as defined in 40 C.F.R. part 136, Attachment B.

#### Minimum Level (ML)

Concentration at which the entire analytical system gives a recognizable signal and acceptable calibration point. The ML is the concentration in a sample that is equivalent to the concentration of the lowest calibration standard analyzed by a specific analytical procedure, assuming that all the method specified sample weights, volumes, and processing steps have been followed.

## **Mixing Zone**

Limited volume of receiving water allocated for mixing with a wastewater discharge where water quality criteria can be exceeded without causing adverse effects to the overall water body.

#### Not Detected (ND)

Sample results less than the laboratory's MDL.

#### **Persistent Pollutants**

Substances for which degradation or decomposition in the environment is nonexistent or very slow.

#### **Pollutant Minimization Program**

Program of waste minimization and pollution prevention actions that include, but are not limited to, product substitution, waste stream recycling, alternative waste management methods, and education of the public and businesses. The goal of the Pollutant Minimization Program is to reduce all potential sources of a priority pollutant through pollutant minimization (control) strategies, including pollution prevention measures as appropriate, to maintain the effluent concentration at or below the water quality-based effluent limitation. Pollution prevention measures may be particularly appropriate for persistent bioaccumulative priority pollutants where there is evidence that beneficial uses are being impacted. Cost effectiveness may be considered when establishing the requirements of a Pollutant Minimization Program. The completion and implementation of a Pollution Prevention Plan, if required pursuant to Water Code section 13263.3(d), is considered to fulfill Pollutant Minimization Program requirements.

Attachment A – Definitions A-3

#### **Pollution Prevention**

Any action that causes a net reduction in the use or generation of a hazardous substance or other pollutant that is discharged into water and includes, but is not limited to, input change, operational improvement, production process change, and product reformulation (as defined in Water Code section 13263.3). Pollution prevention does not include actions that merely shift a pollutant in wastewater from one environmental medium to another environmental medium, unless clear environmental benefits of such an approach are identified to the satisfaction of the State Water Board or Regional Water Board.

#### Reporting Level (RL)

ML (and its associated analytical method) chosen by the Discharger for reporting and compliance determination from the MLs included in this Order, including an additional factor if applicable as discussed herein. The MLs included in this Order correspond to approved analytical methods for reporting a sample result that are selected by the Regional Water Board either from SIP Appendix 4 in accordance with SIP section 2.4.2 or established in accordance with SIP section 2.4.3. The ML is based on the proper application of method-based analytical procedures for sample preparation and the absence of any matrix interferences. Other factors may be applied to the ML depending on the specific sample preparation steps employed. For example, the treatment typically applied in cases where there are matrix-effects is to dilute the sample or sample aliquot by a factor of ten. In such cases, this additional factor must be applied to the ML in the computation of the RL.

## **Source of Drinking Water**

Any water designated as having a municipal or domestic supply (MUN) beneficial use.

## **Standard Deviation (σ)**

Measure of variability calculated as follows:

 $\sigma = (\sum [(x - \mu)^2]/(n-1))^{0.5}$ 

where:

x is the observed value;

 $\mu$  is the arithmetic mean of the observed values; and

n is the number of samples.

## **Toxicity Reduction Evaluation (TRE)**

Study conducted in a step-wise process designed to identify the causative agents of effluent or ambient toxicity, isolate the sources of toxicity, evaluate the effectiveness of toxicity control options, and then confirm the reduction in toxicity. The first steps of the TRE consist of the collection of data relevant to the toxicity, including additional toxicity testing, and an evaluation of facility operations and maintenance practices, and best management practices. A Toxicity Identification Evaluation (TIE) may be required as part of the TRE, if appropriate. A TIE is a set of procedures to identify the specific chemicals responsible for toxicity. These procedures are performed in three phases (characterization, identification, and confirmation) using aquatic organism toxicity tests.

Figure B-1. Topographic Map





Figure B-2. North Bayside System Unit (NBSU) Outfall Map

#### ATTACHMENT D -STANDARD PROVISIONS

#### I. STANDARD PROVISIONS—PERMIT COMPLIANCE

## A. Duty to Comply

- 1. The Discharger must comply with all of the terms, requirements, and conditions of this Order. Any noncompliance constitutes a violation of the Clean Water Act (CWA) and the California Water Code and is grounds for enforcement action; for permit termination, revocation and reissuance, or modification; or denial of a permit renewal application; or a combination thereof. (40 C.F.R. § 122.41(a); Wat. Code §§ 13261, 13263, 13265, 13268, 13000, 13001, 13304, 13350, 13385.)
- 2. The Discharger shall comply with effluent standards or prohibitions established under CWA section 307(a) for toxic pollutants within the time provided in the regulations that establish these standards or prohibitions, even if this Order has not yet been modified to incorporate the requirement. (40 C.F.R. § 122.41(a)(1).)

## B. Need to Halt or Reduce Activity Not a Defense

It shall not be a defense for a Discharger in an enforcement action that it would have been necessary to halt or reduce the permitted activity in order to maintain compliance with the conditions of this Order. (40 C.F.R. § 122.41(c).)

## C. Duty to Mitigate

The Discharger shall take all reasonable steps to minimize or prevent any discharge or sludge use or disposal in violation of this Order that has a reasonable likelihood of adversely affecting human health or the environment. (40 C.F.R. § 122.41(d).)

## D. Proper Operation and Maintenance

The Discharger shall at all times properly operate and maintain all facilities and systems of treatment and control (and related appurtenances) which are installed or used by the Discharger to achieve compliance with the conditions of this Order. Proper operation and maintenance also includes adequate laboratory controls and appropriate quality assurance procedures. This provision requires the operation of backup or auxiliary facilities or similar systems that are installed by a Discharger only when necessary to achieve compliance with the conditions of this Order. (40 C.F.R. § 122.41(e).)

#### E. Property Rights

- 1. This Order does not convey any property rights of any sort or any exclusive privileges. (40 C.F.R. § 122.41(g).)
- 2. The issuance of this Order does not authorize any injury to persons or property or invasion of other private rights, or any infringement of state or local law or regulations. (40 C.F.R. § 122.5(c).)

## F. Inspection and Entry

The Discharger shall allow the Regional Water Board, State Water Board, U.S. EPA, and/or their authorized representatives (including an authorized contractor acting as their representative), upon the presentation of credentials and other documents, as may be required by law, to (33 U.S.C. § 1318(a)(4)(B); 40 C.F.R. § 122.41(i); Wat. Code, §§ 13267, 13383):

- 1. Enter upon the Discharger's premises where a regulated facility or activity is located or conducted, or where records are kept under the conditions of this Order (33 U.S.C. § 1318(a)(4)(B)(i); 40 C.F.R. § 122.41(i)(1); Wat. Code, §§ 13267, 13383);
- 2. Have access to and copy, at reasonable times, any records that must be kept under the conditions of this Order (33 U.S.C. § 1318(a)(4)(B)(ii); 40 C.F.R. § 122.41(i)(2)); Wat. Code, §§ 13267, 13383);
- 3. Inspect and photograph, at reasonable times, any facilities, equipment (including monitoring and control equipment), practices, or operations regulated or required under this Order (33 U.S.C. § 1318(a)(4)(B)(ii); 40 C.F.R. § 122.41(i)(3); Wat. Code, §§ 13267, 13383); and
- **4.** Sample or monitor, at reasonable times, for the purposes of assuring Order compliance or as otherwise authorized by the CWA or the Water Code, any substances or parameters at any location. (33 U.S.C. § 1318(a)(4)(B); 40 C.F.R. § 122.41(i)(4); Wat. Code, §§ 13267, 13383.)

## G. Bypass

#### 1. Definitions

- **a.** "Bypass" means the intentional diversion of waste streams from any portion of a treatment facility. (40 C.F.R. § 122.41(m)(1)(i).)
- **b.** "Severe property damage" means substantial physical damage to property, damage to the treatment facilities, which causes them to become inoperable, or substantial and permanent loss of natural resources that can reasonably be expected to occur in the absence of a bypass. Severe property damage does not mean economic loss caused by delays in production. (40 C.F.R. § 122.41(m)(1)(ii).)
- **2. Bypass not exceeding limitations.** The Discharger may allow any bypass to occur which does not cause exceedances of effluent limitations, but only if it is for essential maintenance to assure efficient operation. These bypasses are not subject to the provisions listed in Standard Provisions Permit Compliance I.G.3, I.G.4, and I.G.5 below. (40 C.F.R. § 122.41(m)(2).)
- **3. Prohibition of bypass.** Bypass is prohibited, and the Regional Water Board may take enforcement action against a Discharger for bypass, unless (40 C.F.R. § 122.41(m)(4)(i)):
  - **a.** Bypass was unavoidable to prevent loss of life, personal injury, or severe property damage (40 C.F.R. § 122.41(m)(4)(i)(A));
  - **b.** There were no feasible alternatives to the bypass, such as the use of auxiliary treatment facilities, retention of untreated wastes, or maintenance during normal periods of

equipment downtime. This condition is not satisfied if adequate back-up equipment should have been installed in the exercise of reasonable engineering judgment to prevent a bypass that occurred during normal periods of equipment downtime or preventive maintenance (40 C.F.R. § 122.41(m)(4)(i)(B)); and

- **c.** The Discharger submitted notice to the Regional Water Board as required under Standard Provisions Permit Compliance I.G.5 below. (40 C.F.R. § 122.41(m)(4)(i)(C).)
- **4. Approval.** The Regional Water Board may approve an anticipated bypass, after considering its adverse effects, if the Regional Water Board determines that it will meet the three conditions listed in Standard Provisions—Permit Compliance I.G.3 above. (40 C.F.R. § 122.41(m)(4)(ii).)

## 5. Notice

- a. Anticipated bypass. If the Discharger knows in advance of the need for a bypass, it shall submit prior notice, if possible at least 10 days before the date of the bypass. The notice shall be sent to the Regional Water Board. As of December 21, 2020, a notice shall also be submitted electronically to the initial recipient defined in Standard Provisions Reporting V.J below. Notices shall comply with 40 C.F.R. part 3, 40 C.F.R. section 122.22, and 40 C.F.R. part 127. (40 C.F.R. § 122.41(m)(3)(i).)
- **b.** Unanticipated bypass. The Discharger shall submit a notice of an unanticipated bypass as required in Standard Provisions Reporting V.E below (24-hour notice). The notice shall be sent to the Regional Water Board. As of December 21, 2020, a notice shall also be submitted electronically to the initial recipient defined in Standard Provisions Reporting V.J below. Notices shall comply with 40 C.F.R. part 3, 40 C.F.R. section 122.22, and 40 C.F.R. part 127. (40 C.F.R. § 122.41(m)(3)(ii).)

## H. Upset

Upset means an exceptional incident in which there is unintentional and temporary noncompliance with technology based permit effluent limitations because of factors beyond the reasonable control of the Discharger. An upset does not include noncompliance to the extent caused by operational error, improperly designed treatment facilities, inadequate treatment facilities, lack of preventive maintenance, or careless or improper operation. (40 C.F.R. § 122.41(n)(1).)

- 1. Effect of an upset. An upset constitutes an affirmative defense to an action brought for noncompliance with such technology based permit effluent limitations if the requirements of Standard Provisions Permit Compliance I.H.2 below are met. No determination made during administrative review of claims that noncompliance was caused by upset, and before an action for noncompliance, is final administrative action subject to judicial review. (40 C.F.R. § 122.41(n)(2).)
- **2.** Conditions necessary for a demonstration of upset. A discharger who wishes to establish the affirmative defense of upset shall demonstrate, through properly signed, contemporaneous operating logs or other relevant evidence that (40 C.F.R. § 122.41(n)(3)):
  - **a.** An upset occurred and that the Discharger can identify the cause(s) of the upset (40 C.F.R. § 122.41(n)(3)(i));

- **b.** The permitted facility was, at the time, being properly operated (40 C.F.R. § 122.41(n)(3)(ii));
- **c.** The Discharger submitted notice of the upset as required in Standard Provisions—Reporting V.E.2.b below (24-hour notice) (40 C.F.R. § 122.41(n)(3)(iii)); and
- **d.** The Discharger complied with any remedial measures required under Standard Provisions—Permit Compliance I.C above. (40 C.F.R. § 122.41(n)(3)(iv).)
- **3. Burden of proof.** In any enforcement proceeding, the Discharger seeking to establish the occurrence of an upset has the burden of proof. (40 C.F.R. § 122.41(n)(4).)

## II. STANDARD PROVISIONS—PERMIT ACTION

#### A. General

This Order may be modified, revoked and reissued, or terminated for cause. The filing of a request by the Discharger for modification, revocation and reissuance, or termination, or a notification of planned changes or anticipated noncompliance does not stay any Order condition. (40 C.F.R. § 122.41(f).)

## **B.** Duty to Reapply

If the Discharger wishes to continue an activity regulated by this Order after the expiration date of this Order, the Discharger must apply for and obtain a new permit. (40 C.F.R. § 122.41(b).)

#### C. Transfers

This Order is not transferable to any person except after notice to the Regional Water Board. The Regional Water Board may require modification or revocation and reissuance of the Order to change the name of the Discharger and incorporate such other requirements as may be necessary under the CWA and the Water Code. (40 C.F.R. §§ 122.41(1)(3), 122.61.)

## III.STANDARD PROVISIONS - MONITORING

- **A**. Samples and measurements taken for the purpose of monitoring shall be representative of the monitored activity. (40 C.F.R. § 122.41(j)(1).)
- **B.** Monitoring must be conducted according to test procedures approved under 40 C.F.R. part 136 for the analyses of pollutants unless another method is required under 40 C.F.R. chapter 1, subchapter N. Monitoring must be conducted according to sufficiently sensitive test methods approved under 40 C.F.R. part 136 for the analysis of pollutants or pollutant parameters or required under 40 C.F.R. chapter 1, subchapter N. For the purposes of this paragraph, a method is sufficiently sensitive when:
  - 1. The method minimum level (ML) is at or below the level of the effluent limitation established in the permit for the measured pollutant or pollutant parameter, and either (a) the method ML is at or below the level of the applicable water quality criterion for the measured pollutant or pollutant parameter, or (b) the method ML is above the applicable water quality criterion but the amount of the pollutant or pollutant parameter in a facility's discharge is

high enough that the method detects and quantifies the level of the pollutant or pollutant parameter in the discharge; or

2. The method has the lowest ML of the analytical methods approved under 40 C.F.R. part 136 or required under 40 C.F.R. chapter 1, subchapter N for the measured pollutant or pollutant parameter.

In the case of pollutants or pollutant parameters for which there are no approved methods under 40 C.F.R. part 136 or otherwise required under 40 C.F.R. chapter 1, subchapter N, monitoring must be conducted according to a test procedure specified in this Order for such pollutants or pollutant parameters. (40 C.F.R. §§ 122.21(e)(3), 122.41(j)(4), 122.44(i)(1)(iv).)

#### IV. STANDARD PROVISIONS—RECORDS

- **A.** The Discharger shall retain records of all monitoring information, including all calibration and maintenance records and all original strip chart recordings for continuous monitoring instrumentation, copies of all reports required by this Order, and records of all data used to complete the application for this Order, for a period of at least three (3) years from the date of the sample, measurement, report or application. This period may be extended by request of the Regional Water Board Executive Officer at any time. (40 C.F.R. § 122.41(j)(2).)
- **B**. Records of monitoring information shall include the following:
  - 1. The date, exact place, and time of sampling or measurements (40 C.F.R. § 122.41(j)(3)(i));
  - **2.** The individual(s) who performed the sampling or measurements (40 C.F.R. § 122.41(j)(3)(ii));
  - 3. The date(s) the analyses were performed (40 C.F.R. § 122.41(j)(3)(iii));
  - **4.** The individual(s) who performed the analyses (40 C.F.R. § 122.41(j)(3)(iv));
  - 5. The analytical techniques or methods used (40 C.F.R. § 122.41(j)(3)(v)); and
  - **6.** The results of such analyses. (40 C.F.R. § 122.41(j)(3)(vi).)
- C. Claims of confidentiality for the following information will be denied (40 C.F.R. § 122.7(b)):
  - 1. The name and address of any permit applicant or Discharger (40 C.F.R. § 122.7(b)(1)); and
  - 2. Permit applications and attachments, permits, and effluent data. (40 C.F.R. § 122.7(b)(2).)

#### V. STANDARD PROVISIONS—REPORTING

## A. Duty to Provide Information

The Discharger shall furnish to the Regional Water Board, State Water Board, or U.S. EPA within a reasonable time, any information which the Regional Water Board, State Water Board, or U.S. EPA may request to determine whether cause exists for modifying, revoking and reissuing, or terminating this Order or to determine compliance with this Order. Upon request, the Discharger

shall also furnish to the Regional Water Board, State Water Board, or U.S. EPA copies of records required to be kept by this Order. (40 C.F.R. § 122.41(h); Wat. Code, §§ 13267, 13383.)

### **B.** Signatory and Certification Requirements

- 1. All applications, reports, or information submitted to the Regional Water Board, State Water Board, and/or U.S. EPA shall be signed and certified in accordance with Standard Provisions—Reporting V.B.2, V.B.3, V.B.4, V.B.5, and V.B.6 below. (40 C.F.R. § 122.41(k).)
- 2. For a corporation, all permit applications shall be signed by a responsible corporate officer. For the purpose of this section, a responsible corporate officer means: (i) a president, secretary, treasurer, or vice-president of the corporation in charge of a principal business function, or any other person who performs similar policy- or decision-making functions for the corporation, or (ii) the manager of one or more manufacturing, production, or operating facilities, provided, the manager is authorized to make management decisions which govern the operation of the regulated facility including having the explicit or implicit duty of making major capital investment recommendations, and initiating and directing other comprehensive measures to assure long term environmental compliance with environmental laws and regulations; the manager can ensure that the necessary systems are established or actions taken to gather complete and accurate information for permit application requirements; and where authority to sign documents has been assigned or delegated to the manager in accordance with corporate procedures. (40 C.F.R. § 122.22(a)(1).)

For a partnership or sole proprietorship, all permit applications shall be signed by a general partner or the proprietor, respectively. (40 C.F.R. § 122.22(a)(2).)

For a municipality, state, federal, or other public agency, all permit applications shall be signed by either a principal executive officer or ranking elected official. For purposes of this provision, a principal executive officer of a federal agency includes (i) the chief executive officer of the agency, or (ii) a senior executive officer having responsibility for the overall operations of a principal geographic unit of the agency (e.g., Regional Administrators of U.S. EPA). (40 C.F.R. § 122.22(a)(3).)

- 3. All reports required by this Order and other information requested by the Regional Water Board, State Water Board, or U.S. EPA shall be signed by a person described in Standard Provisions Reporting V.B.2 above, or by a duly authorized representative of that person. A person is a duly authorized representative only if:
  - **a.** The authorization is made in writing by a person described in Standard Provisions—Reporting V.B.2 above (40 C.F.R. § 122.22(b)(1));
  - **b.** The authorization specifies either an individual or a position having responsibility for the overall operation of the regulated facility or activity such as the position of plant manager, operator of a well or a well field, superintendent, position of equivalent responsibility, or an individual or position having overall responsibility for environmental matters for the company. (A duly authorized representative may thus be either a named individual or any individual occupying a named position.) (40 C.F.R. § 122.22(b)(2)); and

- **c.** The written authorization is submitted to the Regional Water Board and State Water Board. (40 C.F.R. § 122.22(b)(3).)
- **4.** If an authorization under Standard Provisions Reporting V.B.3 above is no longer accurate because a different individual or position has responsibility for the overall operation of the facility, a new authorization satisfying the requirements of Standard Provisions—Reporting V.B.3 above must be submitted to the Regional Water Board and State Water Board prior to or together with any reports, information, or applications, to be signed by an authorized representative. (40 C.F.R. § 122.22(c).)
- **5.** Any person signing a document under Standard Provisions—Reporting V.B.2 or V.B.3 above shall make the following certification:

"I certify under penalty of law that this document and all attachments were prepared under my direction or supervision in accordance with a system designed to assure that qualified personnel properly gather and evaluate the information submitted. Based on my inquiry of the person or persons who manage the system or those persons directly responsible for gathering the information, the information submitted is, to the best of my knowledge and belief, true, accurate, and complete. I am aware that there are significant penalties for submitting false information, including the possibility of fine and imprisonment for knowing violations." (40 C.F.R. § 122.22(d).)

6. Any person providing the electronic signature for documents described in Standard Provisions – V.B.1, V.B.2, or V.B.3 that are submitted electronically shall meet all relevant requirements of Standard Provisions – Reporting V.B, and shall ensure that all relevant requirements of 40 C.F.R. part 3 (Cross-Media Electronic Reporting) and 40 C.F.R. part 127 (NPDES Electronic Reporting Requirements) are met for that submission. (40 C.F.R § 122.22(e).)

## C. Monitoring Reports

- 1. Monitoring results shall be reported at the intervals specified in the Monitoring and Reporting Program in this Order. (40 C.F.R. § 122.22(1)(4).)
- 2. Monitoring results must be reported on a Discharge Monitoring Report (DMR) form or forms provided or specified by the Regional Water Board or State Water Board. As of December 21, 2016, all reports and forms must be submitted electronically to the initial recipient defined in Standard Provisions Reporting V.J and comply with 40 C.F.R. part 3, 40 C.F.R. section 122.22, and 40 C.F.R. part 127. (40 C.F.R. § 122.41(1)(4)(i).)
- 3. If the Discharger monitors any pollutant more frequently than required by this Order using test procedures approved under 40 C.F.R. part 136, or another method required for an industry-specific waste stream under 40 C.F.R. chapter 1, subchapters N or O, the results of such monitoring shall be included in the calculation and reporting of the data submitted in the DMR or sludge reporting form specified by the Regional Water Board. (40 C.F.R. § 122.41(1)(4)(ii).)
- **4.** Calculations for all limitations, which require averaging of measurements, shall utilize an arithmetic mean unless otherwise specified in this Order. (40 C.F.R. § 122.41(l)(4)(iii).)

## **D.** Compliance Schedules

Reports of compliance or noncompliance with, or any progress reports on, interim and final requirements contained in any compliance schedule of this Order, shall be submitted no later than 14 days following each schedule date. (40 C.F.R. § 122.41(l)(5).)

## E. Twenty-Four Hour Reporting

1. The Discharger shall report any noncompliance that may endanger health or the environment. Any information shall be provided orally within 24 hours from the time the Discharger becomes aware of the circumstances. A written report shall also be provided within five (5) days of the time the Discharger becomes aware of the circumstances. The report shall contain a description of the noncompliance and its cause; the period of noncompliance, including exact dates and times, and if the noncompliance has not been corrected, the anticipated time it is expected to continue; and steps taken or planned to reduce, eliminate, and prevent reoccurrence of the noncompliance.

For noncompliance related to combined sewer overflows, sanitary sewer overflows, or bypass events, these reports must include the data described above (with the exception of time of discovery) as well as the type of event (i.e., combined sewer overflow, sanitary sewer overflow, or bypass event), type of overflow structure (e.g., manhole, combined sewer overflow outfall), discharge volume untreated by the treatment works treating domestic sewage, types of human health and environmental impacts of the event, and whether the noncompliance was related to wet weather.

As of December 21, 2020, all reports related to combined sewer overflows, sanitary sewer overflows, or bypass events must be submitted to the Regional Water Board and must be submitted electronically to the initial recipient defined in Standard Provisions – Reporting V.J. The reports shall comply with 40 C.F.R. part 3, 40 C.F.R. section 122.22, and 40 C.F.R. part 127. The Regional Water Board may also require the Discharger to electronically submit reports not related to combined sewer overflows, sanitary sewer overflows, or bypass events under this section. (40 C.F.R. § 122.41(1)(6)(i).)

- 2. The following shall be included as information that must be reported within 24 hours under this paragraph (40 C.F.R. § 122.41(l)(6)(ii)):
  - **a.** Any unanticipated bypass that exceeds any effluent limitation in this Order. (40 C.F.R. § 122.41(1)(6)(ii)(A).)
  - **b.** Any upset that exceeds any effluent limitation in this Order. (40 C.F.R. § 122.41(1)(6)(ii)(B).)
- 3. The Regional Water Board may waive the above-required written report under this provision on a case-by-case basis if an oral report has been received within 24 hours. (40 C.F.R. § 122.41(1)(6)(iii).)

## F. Planned Changes

The Discharger shall give notice to the Regional Water Board as soon as possible of any planned physical alterations or additions to the permitted facility. Notice is required under this provision only when (40 C.F.R. § 122.41(l)(1)):

- 1. The alteration or addition to a permitted facility may meet one of the criteria for determining whether a facility is a new source in 40 C.F.R. section 122.29(b) (40 C.F.R. § 122.41(l)(1)(i)); or
- 2. The alteration or addition could significantly change the nature or increase the quantity of pollutants discharged. This notification applies to pollutants that are not subject to effluent limitations in this Order. (Alternatively, for an existing manufacturing, commercial, mining, or silvicultural discharge as referenced in 40 C.F.R. section 122.42(a), this notification applies to pollutants that are subject neither to effluent limitations in this Order nor to notification requirements under 40 C.F.R. section 122.42(a)(1) (see Additional Provisions—Notification Levels VII.A.1).) (40 C.F.R. § 122.41(l)(1)(ii).)

## **G.** Anticipated Noncompliance

The Discharger shall give advance notice to the Regional Water Board or State Water Board of any planned changes in the permitted facility or activity that may result in noncompliance with this Order's requirements. (40 C.F.R. § 122.41(l)(2).)

## H. Other Noncompliance

The Discharger shall report all instances of noncompliance not reported under Standard Provisions—Reporting V.C, V.D, and V.E above at the time monitoring reports are submitted. The reports shall contain the information listed in Standard Provision—Reporting V.E above. For noncompliance related to combined sewer overflows, sanitary sewer overflows, or bypass events, these reports shall contain the information described in Standard Provision – Reporting V.E and the applicable required data in appendix A to 40 C.F.R. part 127. The Regional Water Board may also require the Discharger to electronically submit reports not related to combined sewer overflows, sanitary sewer overflows, or bypass events under this section. (40 C.F.R. § 122.41(1)(7).)

#### I. Other Information

When the Discharger becomes aware that it failed to submit any relevant facts in a permit application, or submitted incorrect information in a permit application or in any report to the Regional Water Board, State Water Board, or U.S. EPA, the Discharger shall promptly submit such facts or information. (40 C.F.R. § 122.41(1)(8).)

#### J. Initial Recipient for Electronic Reporting Data

The owner, operator, or duly authorized representative is required to electronically submit NPDES information specified in appendix A to 40 C.F.R. part 127 to the initial recipient defined in 40 C.F.R. section 127.2(b). U.S. EPA will identify and publish the list of initial recipients on its website and in the Federal Register, by state and by NPDES data group [see 40 C.F.R. § 127.2(c)]. U.S. EPA will update and maintain this list. (40 C.F.R. § 122.41(l)(9).)

#### VI. STANDARD PROVISIONS - ENFORCEMENT

**A**. The Regional Water Board is authorized to enforce the terms of this permit under several provisions of the Water Code, including, but not limited to, sections 13268, 13385, 13386, and 13387.

#### VII. ADDITIONAL PROVISIONS—NOTIFICATION LEVELS

#### A. Non-Municipal Facilities

Existing manufacturing, commercial, mining, and silvicultural dischargers shall notify the Regional Water Board as soon as they know or have reason to believe (40 C.F.R. § 122.42(a)):

- 1. That any activity has occurred or will occur that would result in the discharge, on a routine or frequent basis, of any toxic pollutant that is not limited in this Order, if that discharge will exceed the highest of the following "notification levels" (40 C.F.R. § 122.42(a)(1)):
  - **a.** 100 micrograms per liter ( $\mu$ g/L) (40 C.F.R. § 122.42(a)(1)(i));
  - b. 200 μg/L for acrolein and acrylonitrile; 500 μg/L for 2,4-dinitrophenol and 2-methyl-4,6-dinitrophenol; and 1 milligram per liter (mg/L) for antimony (40 C.F.R. § 122.42(a)(1)(ii));
  - **c.** Five (5) times the maximum concentration value reported for that pollutant in the Report of Waste Discharge (40 C.F.R. § 122.42(a)(1)(iii)); or
  - **d.** The level established by the Regional Water Board in accordance with section 122.44(f). (40 C.F.R. § 122.42(a)(1)(iv).)
- 2. That any activity has occurred or will occur that would result in the discharge, on a nonroutine or infrequent basis, of any toxic pollutant that is not limited in this Order, if that discharge will exceed the highest of the following "notification levels" (40 C.F.R. § 122.42(a)(2)):
  - **a.** 500 micrograms per liter ( $\mu$ g/L) (40 C.F.R. § 122.42(a)(2)(i));
  - **b.** 1 milligram per liter (mg/L) for antimony (40 C.F.R. § 122.42(a)(2)(ii));
  - **c.** Ten (10) times the maximum concentration value reported for that pollutant in the Report of Waste Discharge (40 C.F.R. § 122.42(a)(2)(iii)); or
  - **d.** The level established by the Regional Water Board in accordance with section 122.44(f). (40 C.F.R. § 122.42(a)(2)(iv).)

### **B.** Publicly-Owned Treatment Works (POTWs)

All POTWs shall provide adequate notice to the Regional Water Board of the following (40 C.F.R. § 122.42(b)):

1. Any new introduction of pollutants into the POTW from an indirect discharger that would be subject to CWA sections 301 or 306 if it were directly discharging those pollutants (40 C.F.R. § 122.42(b)(1)); and

- 2. Any substantial change in the volume or character of pollutants being introduced into that POTW by a source introducing pollutants into the POTW at the time of adoption of this Order. (40 C.F.R. § 122.42(b)(2).)
- **3.** Adequate notice shall include information on the quality and quantity of effluent introduced into the POTW as well as any anticipated impact of the change on the quantity or quality of effluent to be discharged from the POTW. (40 C.F.R. § 122.42(b)(3).)

### ATTACHMENT E – MONITORING AND REPORTING PROGRAM (MRP)

Clean Water Act section 308 and 40 C.F.R. sections 122.41(h), 122.41(j)-(l), 122.44(i), and 122.48 require that all NPDES permits specify monitoring and reporting requirements. Water Code sections 13267 and 13383 also authorize the Regional Water Board to establish monitoring, inspection, entry, reporting, and recordkeeping requirements. This MRP establishes monitoring, reporting, and recordkeeping requirements that implement federal and State laws and regulations.

#### I. GENERAL MONITORING PROVISIONS

- **A.** The Discharger shall comply with this MRP. The Executive Officer may amend this MRP pursuant to 40 C.F.R. sections 122.62, 122.63, and 124.5. If any discrepancies exist between this MRP and the "Regional Standard Provisions, and Monitoring and Reporting Requirements (Supplement to Attachment D) for NPDES Wastewater Discharge Permits" (Attachment G), this MRP shall prevail.
- **B.** The Discharger shall conduct all monitoring in accordance with Attachment D, section III, as supplemented by Attachment G. Equivalent test methods must be more sensitive than those specified in 40 C.F.R. section 136 and must be specified in this permit.
- C. The Discharger shall ensure that results of the Discharge Monitoring Report-Quality Assurance (DMR-QA) Study or most recent Water Pollution Performance Evaluation Study are submitted annually to the State Water Board at the following address:

**D.** The Discharger shall implement a Quality Assurance-Quality Control Program for any onsite field tests (e.g., turbidity, pH, temperature, dissolved oxygen, conductivity, disinfectant residual) analyzed by a noncertified laboratory. The Discharger shall keep a manual onsite containing the steps followed in this program and must demonstrate sufficient capability to adequately perform these field tests (e.g., qualified and trained employees, properly calibrated and maintained field instruments). The program shall conform to U.S. EPA guidelines or other approved procedures.

#### II. MONITORING LOCATIONS

The Discharger shall establish the following monitoring locations to demonstrate compliance with the effluent limitations, discharge specifications, and other requirements in this Order:

The Discharger may elect to use a continuous on-line monitoring system for measuring or determining that residual dechlorinating agent is present. This monitoring system may be used to prove that anomalous residual chlorine exceedances measured by on-line chlorine analyzers are false positives and are not valid total residual chlorine detections because it is chemically improbable to have chlorine present in the presence of sodium bisulfite. If Regional Water Board staff finds convincing evidence that chlorine residual exceedances are false positives, the exceedances are not violations of this Order's total chlorine residual limit.

- The Discharger may, at its option, analyze for cyanide as weak acid dissociable cyanide using protocols specified in 40 C.F.R. Part 136, or an equivalent method in the latest Standard Method edition.
- [6] The Discharger may, at its option, collect cyanide samples at Monitoring Location EFF-002. If so, the Discharger shall indicate so in its self-monitoring reports.
- [7] Results may be reported as either MPN/100 mL if the laboratory method used provides results in MPN/100 mL or CFU/100 mL if the laboratory method used provides results in CFU/100 mL.

- [6] The Discharger may, at its option, collect cyanide samples at Monitoring Location EFF-002. If so, the Discharger shall indicate so in its self-monitoring reports.
- Results may be reported as either MPN/100 mL if the laboratory method used provides results in MPN/100 mL or CFU/100 mL if the laboratory method used provides results in CFU/100 mL.

### V. TOXICITY TESTING REQUIREMENTS

#### A. Acute Toxicity

1. Compliance with the acute toxicity effluent limitations shall be evaluated at Monitoring Location EFF-001 by measuring survival of test organisms exposed to 96-hour continuous flow-through bioassays. Effluent samples may be before disinfection for toxicity tests.

- **2.** Test organisms shall be rainbow trout (*Onchorhynchus mykiss*). Alternatively, the Executive Officer may specify a more sensitive organism or, if testing a particular organism proves unworkable, the most sensitive organism available.
- **3.** All bioassays shall be performed according to the most up-to-date protocols in 40 C.F.R. part 136, currently *Methods for Measuring the Acute Toxicity of Effluents and Receiving Water to Freshwater and Marine Organisms*, 5<sup>th</sup> Edition (EPA-821-R-02-012). If these protocols prove unworkable, the Executive Officer and the Environmental Laboratory Accreditation Program may grant exceptions in writing upon the Discharger's request with justification.
- **4.** If the Discharger demonstrates that specific identifiable substances in the discharge are rapidly rendered harmless upon discharge to the receiving water, compliance with the acute toxicity limit may be determined after test samples are adjusted to remove the influence of those substances. Written acknowledgement that the Executive Officer concurs with the Discharger's demonstration and that the adjustment will not remove the influence of other substances must be obtained prior to any such adjustment. The Discharger may adjust the pH of acute toxicity samples prior to performing bioassays to minimize ammonia toxicity interference.
- 5. Bioassay monitoring shall include, on a daily basis, pH, dissolved oxygen, ammonia (if toxicity is observed), temperature, hardness, and alkalinity. These results shall be reported. If final or intermediate results of an acute bioassay test indicate a violation or threatened violation (e.g., the percentage of surviving test organisms is less than 70 percent), the Discharger shall initiate a new test as soon as practical and shall investigate the cause of the mortalities and report its findings in the next self-monitoring report. The Discharger shall repeat the test until a test fish survival rate of 90 percent or greater is observed. If the control fish survival rate is less than 90 percent, the bioassay test shall be restarted with new fish and shall continue as soon as practical until an acceptable test is completed (i.e., control fish survival rate is 90 percent or greater).

#### **B.** Chronic Toxicity

### 1. Monitoring Requirements

- **a. Sampling.** The Discharger shall collect 24-hour composite effluent samples at Monitoring Location EFF-001 for critical life stage toxicity testing as indicated below. Effluent samples may be before disinfection for toxicity tests. For toxicity tests requiring renewals, the Discharger shall collect 24-hour composite samples on consecutive or alternating days.
- **b. Test Species.** The test species shall be mysid shrimp (*Americamysis bahia*) unless a more sensitive species is identified. If using this species proves unworkable, the Executive Officer may specify a different species in writing upon the Discharger's request with justification.

The Discharger shall conduct a screening chronic toxicity test as described in Appendix E-1, or as described in applicable State Water Board plan provisions that become effective after adoption of this Order, following any significant change in the

nature of the effluent. If there is no significant change in the nature of the effluent, the Discharger shall conduct a screening test and submit the results with its application for permit reissuance. Upon completion of the chronic toxicity screening, the Discharger shall use the most sensitive species to conduct subsequent monitoring.

- **c. Frequency.** Chronic toxicity monitoring shall be as specified below:
  - i. The Discharger shall monitor routinely twice per year.
  - ii. The Discharger shall accelerate monitoring to monthly after exceeding a single-sample maximum of 10 TU<sub>c</sub>. Based on the TU<sub>c</sub> results, the Executive Officer may specify a different frequency for accelerated monitoring to ensure that accelerated monitoring provides useful information.
  - **iii.** The Discharger shall return to routine monitoring if accelerated monitoring does not exceed the trigger in ii, above.
  - **iv.** If accelerated monitoring confirms consistent toxicity in excess of the trigger in ii, above, the Discharger shall continue accelerated monitoring and initiate toxicity reduction evaluation (TRE) procedures in accordance with section V.B.3, below.
  - v. The Discharger shall return to routine monitoring after implementing appropriate elements of the TRE, and either the toxicity drops below the trigger in ii, above, or, based on the TRE results, the Executive Officer determines that accelerated monitoring would no longer provide useful information.
  - vi. Monitoring conducted pursuant to a TRE shall satisfy the requirements for routine and accelerated monitoring while the TRE is underway.
- d. Methodology. Sample collection, handling, and preservation shall be in accordance with U.S. EPA protocols. Bioassays shall be conducted in compliance with the most recently promulgated test methods, as shown in Appendix E-2. These are Short-Term Methods for Estimating the Chronic Toxicity of Effluents and Receiving Waters to West Coast Marine and Estuarine Organisms, currently 1<sup>st</sup> edition (EPA/600/R-95-136), Short-Term Methods for Estimating the Chronic Toxicity of Effluents and Receiving Waters to Marine and Estuarine Organisms, currently 3<sup>rd</sup> edition (EPA-821-R-02-014) and Short-Term Methods for Estimating the Chronic Toxicity of Effluents and Receiving Waters to Freshwater Organisms, currently 4<sup>th</sup> edition (EPA-821-R2-02-013). If these protocols prove unworkable, the Executive Officer and the Environmental Laboratory Accreditation Program may grant exceptions in writing upon the Discharger's request with justification.

If the Discharger demonstrates that specific identifiable substances in the discharge are rapidly rendered harmless upon discharge to the receiving water, compliance with the chronic toxicity limit may be determined after test samples are adjusted to remove the influence of those substances. The adjustment shall not remove the influence of other substances. Written acknowledgement that the Executive Officer concurs with the Discharger's demonstration must be obtained prior to any such adjustment.

e. Dilution Series. The Discharger shall conduct tests at 40%, 20%, 10%, 5%, and 2.5%. The "%" represents percent effluent as discharged. Test sample pH may be controlled to the level of the effluent sample as received prior to being salted up.

### 2. Reporting Requirements

The Discharger shall provide toxicity test results with self-monitoring reports and shall include the following, at a minimum, for each test:

- a. Sample date
- **b.** Test initiation date
- **c.** Test species
- **d.** End point values for each dilution (e.g., number of young, growth rate, percent survival)
- e. No Observable Effect Level (NOEL) values in percent effluent. The NOEL shall equal the IC<sub>25</sub> or EC<sub>25</sub> (see MRP Appendix E-1). If the IC<sub>25</sub> or EC<sub>25</sub> cannot be statistically determined, the NOEL shall equal the No Observable Effect Concentration (NOEC) derived using hypothesis testing. The NOEC is the maximum percent effluent concentration that causes no observable effect on test organisms based on a critical life stage toxicity test.
- **f.** IC<sub>15</sub>, IC<sub>25</sub>, IC<sub>40</sub>, and IC<sub>50</sub> values (or EC<sub>15</sub>, EC<sub>25</sub>, EC<sub>40</sub>, and EC<sub>50</sub>) as percent effluent
- g. TU values (100/NOEL and upper and lower confidence intervals)
- **h.** Mean percent mortality (±s.d.) after 96 hours in 100% effluent (if applicable)
- i.  $IC_{50}$  or  $EC_{50}$  values for reference toxicant tests
- **j.** Available water quality measurements for each test (e.g., pH, dissolved oxygen, temperature, conductivity, hardness, salinity, ammonia).

### 3. Toxicity Reduction Evaluation (TRE)

- **a.** The Discharger shall prepare a generic TRE work plan within 90 days of the effective date of this Order to be ready to respond to toxicity events. The Discharger shall review and update the work plan as necessary so that it remains current and applicable to the discharge and discharge facilities.
- **b.** Within 30 days of exceeding the chronic toxicity trigger in section V.B.1.c.ii, above, the Discharger shall submit a TRE work plan, which shall be the generic work plan revised as appropriate for this toxicity event after consideration of available discharge data.
- **c.** Within 30 days of completing an accelerated monitoring test observed to exceed the trigger in section V.B.1.c.ii, above, the Discharger shall initiate a TRE in accordance with a TRE work plan that incorporates any and all Executive Officer comments.

- **d.** The TRE shall be specific to the discharge and be in accordance with current technical guidance and reference materials, including U.S. EPA guidance materials. The Discharger shall conduct the TRE as a tiered evaluation as summarized below:
  - i. Tier 1 shall consist of basic data collection (routine and accelerated monitoring).
  - **ii.** Tier 2 shall consist of evaluation of treatment process, including operational practices and in-plant process chemicals.
  - iii. Tier 3 shall consist of a toxicity identification evaluation (TIE).
  - iv. Tier 4 shall consist of a toxicity source evaluation.
  - v. Tier 5 shall consist of a toxicity control evaluation, including options for modifications of in-plant treatment processes.
  - **vi.** Tier 6 shall consist of implementation of selected toxicity control measures, and follow-up monitoring and confirmation of implementation success.
- **e.** The Discharger may end the TRE at any stage if monitoring finds there is no longer consistent toxicity (i.e., compliance with the trigger in section V.B.1.c.ii).
- **f.** The objective of the TIE shall be to identify the substance or combination of substances causing the observed toxicity. The Discharger shall employ all reasonable efforts using currently available TIE methodologies.
- **g.** As toxic substances are identified or characterized, the Discharger shall continue the TRE by determining the sources and evaluating alternative strategies for reducing or eliminating the toxic substances from the discharge. The Discharger shall take all reasonable steps to reduce toxicity to levels below the chronic toxicity trigger.
- **h.** Many recommended TRE elements parallel required or recommended efforts related to source control, pollution prevention, and stormwater control programs. TRE efforts should be coordinated with such efforts. To prevent duplication of efforts, evidence of complying with requirements or recommended efforts of such programs may be acceptable to demonstrate compliance with TRE requirements.

### VI. RECEIVING WATER MONITORING REQUIREMENTS

The Discharger shall continue to participate in the Regional Monitoring Program (RMP), which collects data on pollutants and toxicity in San Francisco Bay water, sediment, and biota.

### VII. PRETREATMENT AND BIOSOLIDS MONITORING REQUIREMENTS

The Discharger shall comply with the following pretreatment monitoring requirements for influent at Monitoring Location INF-001, effluent at Monitoring Location EFF-001, and biosolids at Monitoring Location BIO-001. The Discharger shall report summaries of analytical results in annual and semi-annual pretreatment reports in accordance with Attachment H. If instructed to do so, the Discharger shall report biosolids analytical results with its electronic self-monitoring reports by manual entry, by EDF/CDF, or as an attached file.

### VIII. REPORTING REQUIREMENTS

# A. General Monitoring and Reporting Requirements

The Discharger shall comply with all Standard Provisions (Attachments D and G) related to monitoring, reporting, and recordkeeping.

### **B.** Self-Monitoring Reports (SMRs)

1. SMR Format. The Discharger shall electronically submit SMRs using the State Water Board's California Integrated Water Quality System (CIWQS) website (waterboards.ca.gov/water\_issues/programs/ciwqs). The CIWQS website will provide additional information for SMR submittal in the event of a planned service interruption for electronic submittal.

- **2. SMR Due Dates and Contents.** The Discharger shall submit SMRs by the due dates, and with the contents, specified below:
  - a. Monthly SMRs Monthly SMRs shall be due 30 days after the end of each calendar month, covering that calendar month. The monthly SMR shall contain the applicable items described in sections V.B and V.C of both Attachments D and G of this Order. See Provision VI.C.2 (Effluent Characterization Study and Report) of this Order for information that must also be reported with monthly SMRs.

Monthly SMRs shall include all new monitoring results obtained since the last SMR was submitted. If the Discharger monitors any pollutant more frequently than required by this Order, the Discharger shall include the results of such monitoring in the calculations and reporting for the SMR.

- b. Annual SMR Annual SMRs shall be due February 1 each year, covering the previous calendar year. The annual SMR shall contain the items described in Attachment G section V.C.1.f. See also Provisions VI.C.2 (Effluent Characterization Study and Report), VI.C.5.a (Specific Tasks to Reduce Blending), and VI.C.5.d (Anaerobically-Digestible Material) of the Order for requirements to submit reports with annual SMRs.
- **3. Specifications for Submitting SMRs to CIWQS** The Discharger shall submit analytical results and other information using one of the following methods:

  - **5. RL and MDL Reporting.** The Discharger shall report with each sample result the Reporting Level (RL) and Method Detection Limit (MDL) as determined by the procedure in 40 C.F.R. part 136. The Discharger shall report the results of analytical determinations for the presence of chemical constituents in a sample using the following reporting protocols:
    - **a.** Sample results greater than or equal to the RL shall be reported as measured by the laboratory (i.e., the measured chemical concentration in the sample).
    - **b.** Sample results less than the RL, but greater than or equal to the laboratory's MDL, shall be reported as "Detected, but Not Quantified," or DNQ. The estimated chemical concentration of the sample shall also be reported.
      - For purposes of data collection, the laboratory shall write the estimated chemical concentration next to DNQ. The laboratory may, if such information is available, include numerical estimates of the data quality for the reported result. Numerical estimates of data quality may be percent accuracy (+/- a percentage of the reported value), numerical ranges (low to high), or any other means the laboratory considers appropriate.
    - **c.** Sample results less than the laboratory's MDL shall be reported as "Not Detected", or ND.
    - **d.** The Discharger shall instruct laboratories to establish calibration standards so that the minimum level (ML) value (or its equivalent if there is differential treatment of samples relative to calibration standards) is the lowest calibration standard. At no time is the Discharger to use analytical data derived from extrapolation beyond the lowest point of the calibration curve.
  - **6. Compliance Determination.** Compliance with effluent limitations for priority pollutants shall be determined using sample reporting protocols defined above and in the Fact Sheet and Attachments A, D, and G. For purposes of reporting and administrative enforcement by the Regional Water Board and State Water Board, the Discharger shall be deemed out of compliance with effluent limitations if the concentration of the priority pollutant in the monitoring sample is greater than the effluent limitation and greater than or equal to the RL.

# **C.** Discharge Monitoring Reports (DMRs)

DMRs are U.S. EPA reporting requirements. The Discharger shall electronically certify and submit DMRs together with SMRs using the Electronic Self-Monitoring Reports module eSMR 2.5 or the latest upgraded version. Electronic DMR submittal shall be in addition to electronic SMR submittal. Information about electronic DMR submittal is available at the DMR website at waterboards.ca.gov/water\_issues/programs/discharge\_monitoring.

# APPENDIX E-1 CHRONIC TOXICITY DEFINITION OF TERMS AND SCREENING PHASE REQUIREMENTS

#### I. Definition of Terms

- **A**. No observed effect level (NOEL) for compliance determination is equal to IC<sub>25</sub> or EC<sub>25</sub>. If the IC<sub>25</sub> or EC<sub>25</sub> cannot be statistically determined, the NOEL shall be equal to the NOEC derived using hypothesis testing.
- **B.** Effective concentration (EC) is a point estimate of the toxicant concentration that would cause an adverse effect on a quantal, "all or nothing," response (such as death, immobilization, or serious incapacitation) in a given percent of the test organisms. If the effect is death or immobility, the term lethal concentration (LC) may be used. EC values may be calculated using point estimation techniques such as probit, logit, and Spearman-Karber. EC<sub>25</sub> is the concentration of toxicant (in percent effluent) that causes a response in 25 percent of the test organisms.
- C. <u>Inhibition concentration</u> (IC) is a point estimate of the toxicant concentration that would cause a given percent reduction in a nonlethal, nonquantal biological measurement, such as growth. For example, an IC<sub>25</sub> is the estimated concentration of toxicant that would cause a 25 percent reduction in average young per female or growth. IC values may be calculated using a linear interpolation method such as U.S. EPA's Bootstrap Procedure.
- **D**. No observed effect concentration (NOEC) is the highest tested concentration of an effluent or a toxicant at which no adverse effects are observed on the aquatic test organisms at a specific time of observation. It is determined using hypothesis testing.

# **II. Chronic Toxicity Screening Phase Requirements**

- **A**. The Discharger shall perform screening phase monitoring:
  - 1. Subsequent to any significant change in the nature of the effluent discharged through changes in sources or treatment, except those changes resulting from reductions in pollutant concentrations attributable to source control efforts, or
  - 2. Prior to permit reissuance. Screening phase monitoring data shall be included in the NPDES permit application for reissuance. The information shall be as recent as possible, but may be based on screening phase monitoring conducted within 5 years before the permit expiration date.
- **B**. Design of the screening phase shall, at a minimum, consist of the following elements:
  - **1.** Use of test species specified in Appendix E-2, attached, and use of the protocols referenced in those tables.

### **2.** Two stages:

**a.** <u>Stage 1</u> shall consist of a minimum of one battery of tests conducted concurrently. Selection of the type of test species and minimum number of tests shall be based on Appendix E-2 (attached).

- **b.** Stage 2 shall consist of a minimum of two test batteries conducted at a monthly frequency using the three most sensitive species based on the Stage 1 test results.
- **3.** Appropriate controls.
- **4.** Concurrent reference toxicant tests.
- **5.** Dilution series of 100%, 40%, 20%, 10%, 5%, and 2.5%, where "%" is percent effluent as discharged, or as otherwise approved by the Executive Officer if different dilution ratios are needed to reflect discharge conditions.
- **C**. The Discharger shall submit a screening phase proposal. The proposal shall address each of the elements listed above. If within 30 days, the Executive Officer does not comment, the Discharger shall commence with screening phase monitoring.

**A.** The cities of South San Francisco and San Bruno and the North Bayside System Unit (NBSU) (together, the Discharger) discharge treated wastewater into the deepwater channel of Lower San

Francisco Bay. The cities of South San Francisco and San Bruno jointly own the Water Quality Control Plant, a publicly-owned treatment works. Operation and maintenance of the plant is the sole responsibility of the City of South San Francisco. Each city also owns and operates its own wastewater collection system. The plant provides secondary treatment of wastewater from the cities of South San Francisco and San Bruno, the town of Colma, and a small part of the City of Daly City, and discharges the effluent to the NBSU outfall force main.

The NBSU is a joint powers authority that includes the cities of Burlingame, Millbrae, South San Francisco, and San Bruno, and the San Francisco International Airport. The NBSU agencies share discharge capacity rights and own the outfall force main, the combined effluent pumping station, the effluent dechlorination facilities, and the deepwater outfall. The City of South San Francisco operates and maintains the NBSU effluent pumping facilities. The cities of Burlingame and Millbrae, and the San Francisco International Airport, own and are responsible for their own effluent force mains that transport treated wastewater to the Facility. For the purposes of this Order, the plant, the Discharger's collection systems, and the NBSU outfall force main, combined effluent pumping station, dechlorination facilities, and deepwater outfall are collectively referred to as the "Facility."

For the purposes of this Order, references to the "discharger" or "permittee" in applicable federal and State laws, regulation, plans, or policy are held to be equivalent to references to the Discharger herein.

- **B.** The Discharger is regulated pursuant to National Pollutant Discharge Elimination System (NPDES) Permit No. CA0038130. The Discharger was previously subject to Order No. R2-2014-0012 (previous order). The Discharger filed a Report of Waste Discharge and submitted an application for reissuance of its Waste Discharge Requirements (WDRs) and NPDES permit on August 31, 2018.
  - The Discharger is authorized to discharge subject to WDRs in this Order at the discharge location described in Table 2 of this Order. Regulations in 40 C.F.R. section 122.46 limit the duration of NPDES permits to a fixed term not to exceed five years. Accordingly, Table 3 of this Order limits the effective period for the discharge authorization. Pursuant to California Code of Regulations, title 23, section 2235.4, the terms and conditions of an expired permit are automatically continued pending reissuance of the permit if the Discharger complies with all requirements for continuation of expired permits. (See 40 C.F.R § 122.6[d].)
- C. Order No. R2-2016-0008 amended the previous order to provide for an alternate monitoring program and remains in effect with this Order. The discharge is also regulated under NPDES Permit Nos. CA0038849 and CA0038873, which establish requirements on mercury and polychlorinated biphenyls (PCBs) and nutrients from wastewater discharges to San Francisco Bay. This Order does not affect those permits.
- **D.** When applicable, State law requires dischargers to file a petition with the State Water Resources Control Board (State Water Board), Division of Water Rights, and receive approval for any change in the point of discharge, place of use, or purpose of use of treated wastewater that decreases the flow in any portion of a watercourse. The State Water Board retains separate jurisdictional authority to enforce such requirements under Water Code section 1211. This is not an NPDES permit requirement.

#### II. FACILITY DESCRIPTION

#### A. Wastewater and Biosolids Treatment

- **1. Location and Service Area**. The plant is located at 195 Belle Air Road in the City of South San Francisco. It provides secondary wastewater treatment of domestic, commercial, and industrial wastewater for the cities of South San Francisco and San Bruno, the Town of Colma, and portions of Daly City. The plant serves a population of about 113,500.
- 2. Collection System. The City of South San Francisco wastewater collection system and City of San Bruno wastewater collection system are covered by this Order and convey wastewater to the plant. The South San Francisco collection system consists of approximately 148 miles of gravity sewers and force mains and seven pump stations. The San Bruno collection system consists of approximately 77 miles of gravity sewers and force mains, 20 miles of lower laterals, and six pump stations. The Town of Colma and City of Daly City operate satellite collection systems that discharge transmit wastewater to the South San Francisco collection system.
- **3. Wastewater Treatment**. The plant receives untreated wastewater from three force main pump stations. The influent flows through bar screens and two grit removal systems. During normal dry weather operations, it is treated with ferric chloride and polymer for flocculation and pumped to a flow splitter for distribution to primary clarifiers, where grease, floating solids, and settable solids are removed.

The primary-treated wastewater typically flows by gravity to five aeration basins as two separate flow streams. Another four aeration basins remain in stand-by mode. They are scheduled for retrofitting and mainly used for wet weather flows. The wastewater is combined in the aeration basins with return activated sludge from secondary clarifiers. It then flows by gravity through the aeration basins to secondary clarifiers for sedimentation and floating solids removal. During wet weather, when influent flow greatly exceeds the peak secondary treatment design capacity (currently 30 MGD), primary effluent may be routed around the aeration basins and secondary clarifiers and blended with secondary-treated effluent. These bypasses are subject to Discharge Prohibition III.C of this Order and Attachment D section I.G.

The secondary-treated wastewater flows by gravity to two chlorine contact basins where it is mixed with sodium hypochlorite for disinfection. After disinfection, it flows by gravity to the NBSU effluent pumping station wet well (Discharge Point No. 001), where it is blended with chlorinated effluent from the cities of Burlingame and Millbrae, and the San Francisco International Airport. It is then mixed with sodium bisulfite to neutralize the residual chlorine. The combined effluent is pumped through the NBSU outfall (Discharge Point No. 002) and discharged to Lower San Francisco Bay about one mile offshore from Oyster Point.

The flow schematic in Attachment C shows these steps. The plant has an average dry weather capacity of 13 MGD and a peak wet weather capacity of 62 MGD. From June 2014 through October 2018, the plant treated a daily average of 8.28 MGD, with the highest reported average daily flow being 36 MGD. Wet weather diversions, or blending, occurred five time

during the previous order term, with volumes of blended effluent ranging from 0.83 to 15.34 MGD.

- 4. Sludge and Biosolids Management. Sludge from the primary and secondary clarification operations is processed using anaerobic digestion. The process consists of gravity and mechanical thickeners or waste activated sludge thickening, mesophilic anaerobic digesters, and belt filter presses for dewatering. The digested and dewatered biosolids are hauled offsite to a permitted landfill.
- **5. Stormwater Management**. All stormwater at the plant is collected and directed to the headworks for treatment; therefore, no additional stormwater requirements are necessary.

### **B.** Discharge Point and Receiving Waters

Treated effluent flows through the 60-inch NBSU forcemain into Lower San Francisco Bay at Discharge Point No. 002 via a 620-foot diffuser composed of 66 ports (3-inch diameter) spaced 7 feet apart and 28 ports (2.8-inch diameter) spaced 6 feet apart. The location of the outfall is northeast of Point San Bruno, approximately 5,300 feet offshore at depth 20 feet below mean lower low water. The NBSU operates and maintains the outfall, and regular inspections occur on a 10-year schedule. The most recent inspection took place in May 2015. Divers found all diffuser ports to be performing in accordance with their specifications but noted that the fasteners securing the end gate needed to be replaced. Repairs were completed in July 2015.

When the plant's effluent flowrate exceeds 35 MGD (engineered contractual limit for the NBSU pipeline), fully treated effluent is pumped to a 7 million-gallon effluent storage pond. On occasion, when onsite storage basins are full, an emergency discharge through a shallow-water outfall could occur. Also, if major plant systems were to fail or the NBSU force main were to be damaged, disinfected effluent could be dechlorinated and discharged through the shallow-water outfall. The outfall would discharge to the Colma Creek tidal slough adjacent to the plant. This Order does not authorize such discharges, which would be bypasses subject to Discharge Prohibition III.C and Attachment D section I.G of this Order. The Discharger used the shallow-water outfall once during the previous order term (December 2014).

#### C. Previous Requirements and Monitoring Data

The table below presents the previous order's effluent limitations and representative monitoring data from the previous order term:

### **D.** Compliance Summary

- **1. Treatment plant.** The Discharger did not violate its numeric effluent limitations during the previous permit term.
- 2. Collection Systems. The table below shows the Discharger's collection system's sanitary sewer overflow (SSO) rates (total SSOs per 100 miles of collection system) for Category 1 SSOs over the last five years, the lengths and ages of the collection systems, and comparisons to Category 1 SSO rates for the San Francisco Bay Region and the State. Category 1 SSOs are those that reach waters of the United States, and thus may violate Prohibition III.E of this Order.

The Category 1 SSO rates for the Discharger's collection system were similar to the average rates derived from all miles of pipeline of collection systems in the San Francisco Bay Region. There were at most two Category 1 SSOs per year. The average age of the Discharger's collection system is approximately 52 years, which is slightly older than other collection systems in the San Francisco Bay Region.

The Discharger and its satellite collection system agencies maintain sewer master plans, which identify collection system projects and ongoing maintenance activities. These programs include ongoing repair, replacement, rehabilitation, cleaning, and maintenance projects that each collection system will conduct to reduce inflow and infiltration and the need for wet weather bypasses. In 2018, the Discharger completed a Wet Weather Alternatives Analysis Report that evaluated the extent to which the Discharger is maximizing its ability to reduce inflow and infiltration through the entire collection system, including municipal satellite collection systems. Provision VI.C.5.a of this Order requires the Discharger to clean and inspect its collection system and to complete at least \$5.0 million of sewer pipe rehabilitation and improvements on its collection system.

### E. Planned Changes

The Discharger is planning the projects summarized below to reduce wet weather bypasses. These projects were originally set for the previous order term but were delayed due to design changes and funding. The Discharger may need to obtain necessary permits or permit modifications to implement the changes. The Discharger plans to complete the following projects by 2022:

- Reestablish a sewer lateral program for the city of South San Francisco to inspect and repair private sewer laterals during point of sale and evaluate the feasibility of providing financial assistance to property owners for private sewer lateral repair or replacement;
- Improve electrical reliability by replacing the generator and switchgear, replacing elevated bus duct, and installing a new generator building;
- Replace two old digesters with a single recuperative thickening digester;
- Rehabilitate and repair the bar screen bypass, motorized operators at flow split, and the blower building;

- Construct a new secondary clarifier and increase secondary capacity from 30 MGD to 40 MGD; and
- Rehabilitate aeration basins for use during wet weather flows.

This Order authorizes these changes subject to conditions set forth in Provision VI.C.5.c.

### III. APPLICABLE PLANS, POLICIES, AND REGULATIONS

### A. Legal Authorities

This Order serves as WDRs pursuant to California Water Code article 4, chapter 4, division 7 (commencing with § 13260) for discharges to waters of the State. This Order is also issued pursuant to Clean Water Act (CWA) section 402 and implementing regulations adopted by U.S. EPA, and Water Code chapter 5.5, division 7 (commencing with § 13370). It shall serve as an NPDES permit authorizing the Discharger to discharge into waters of the United States at the discharge location described in Table 2 subject to the WDRs in this Order.

# B. California Environmental Quality Act

Under Water Code section 13389, this action to adopt an NPDES permit is exempt from the provisions of the California Environmental Quality Act (CEQA), Public Resources Code division 13, chapter 3 (commencing with § 21100).

# C. State and Federal Regulations, Policies, and Plans

1. Water Quality Control Plan. The Regional Water Board adopted the *Water Quality Control Plan for the San Francisco Bay Basin* (Basin Plan), which designates beneficial uses, establishes water quality objectives, and contains implementation programs and policies to achieve those objectives for all waters addressed through the plan. Requirements in this Order implement the Basin Plan. In addition, this Order implements State Water Board Resolution No. 88-63, which established State policy that all waters, with certain exceptions, should be considered suitable or potentially suitable for municipal or domestic supply. Because of the marine influence on San Francisco Bay, total dissolved solids levels exceed 3,000 mg/L; therefore, San Francisco Bay meets an exception to State Water Board Resolution No. 88-63. Beneficial uses applicable to Lower San Francisco Bay are as follows:

- **2. Bacteria.** The State Water Board adopted the *Water Quality Control Plan for Inland Surface Waters, Enclosed Bays, and Estuaries of California Part 3, Bacteria Provisions and a Water Quality Standards Variance Policy* on August 7, 2018, and it became effective on March 22, 2019. This plan establishes new enterococcus bacteria water quality objectives and related implementation provisions for discharges to marine and estuarine receiving waters that support the water contact recreation beneficial use.
- **3. Sediment Quality.** The State Water Board adopted the *Water Quality Control Plan for Enclosed Bays and Estuaries Part 1, Sediment Quality* on September 16, 2008, and it became effective on August 25, 2009. The State Water Board adopted amendments to the plan on June 5, 2018, that became effective on March 11, 2019. This plan supersedes other narrative sediment quality objectives, and establishes new sediment quality objectives and related implementation provisions for specifically defined sediments in most bays and estuaries.
- **4.** National Toxics Rule (NTR) and California Toxics Rule (CTR). U.S. EPA adopted the NTR on December 22, 1992, and amended it on May 4, 1995, and November 9, 1999. About 40 criteria in the NTR apply in California. On May 18, 2000, U.S. EPA adopted the CTR. The CTR promulgated new toxics criteria for California and incorporated the previously adopted NTR criteria that applied in the State. U.S. EPA amended the CTR on February 13, 2001. These rules contain water quality criteria for priority pollutants.
- 5. State Implementation Policy. On March 2, 2000, the State Water Board adopted the *Policy for Implementation of Toxics Standards for Inland Surface Waters, Enclosed Bays, and Estuaries of California* (State Implementation Policy or SIP). The SIP became effective on April 28, 2000, with respect to the priority pollutant criteria U.S. EPA promulgated for California through the NTR and the priority pollutant objectives the Regional Water Board established in the Basin Plan. The SIP became effective on May 18, 2000, with respect to the priority pollutant criteria U.S. EPA promulgated through the CTR. The State Water Board adopted amendments to the SIP on February 24, 2005, that became effective on July 13, 2005. The SIP establishes implementation provisions for priority pollutant criteria and objectives, and provisions for chronic toxicity control. Requirements of this Order implement the SIP.
- **6. Antidegradation Policy.** Federal regulations at 40 C.F.R. section 131.12 require that state water quality standards include an antidegradation policy consistent with the federal policy. The State Water Board established California's antidegradation policy through State Water Board Resolution No. 68-16, *Statement of Policy with Respect to Maintaining High Quality of Waters in California*, which is deemed to incorporate the federal antidegradation policy where the federal policy applies under federal law. Resolution No. 68-16 requires that existing water quality be maintained unless degradation is justified based on specific findings. The Basin Plan implements, and incorporates by reference, both the State and federal antidegradation policies. Permitted discharges must be consistent with the antidegradation provisions of 40 C.F.R. section 131.12 and State Water Board Resolution No. 68-16. (See Fact Sheet § IV.D.1.)
- 7. Anti-Backsliding Requirements. CWA sections 402(o) and 303(d)(4) and 40 C.F.R. section 122.44(l) restrict backsliding in NPDES permits. These anti-backsliding provisions require that effluent limitations in a reissued permit be as stringent as those in the previous permit, with some exceptions in which limitations may be relaxed. (See Fact Sheet § IV.D.2.)

- 8. Endangered Species Act Requirements. This Order does not authorize any act that results in the taking of a threatened or endangered species or any act that is now prohibited, or becomes prohibited in the future, under either the California Endangered Species Act (Fish and Game Code §§ 2050 to 2097) or the Federal Endangered Species Act (16 U.S.C.A. §§ 1531 to 1544). This Order requires compliance with effluent limits, receiving water limits, and other requirements to protect the beneficial uses of waters of the State, including protecting rare, threatened, or endangered species. The Discharger is responsible for meeting all applicable Endangered Species Act requirements.
- 9. Sludge and Biosolids. U.S. EPA administers 40 C.F.R. part 503, Standards for the Use or Disposal of Sewage Sludge, which regulates the final use or disposal of sewage sludge generated during the treatment of domestic sewage in a municipal wastewater treatment facility. This Order does not authorize any act that violates those requirements. The Discharger is responsible for meeting all applicable requirements of 40 C.F.R. part 503.

### D. Impaired Waters on CWA 303(d) List

On April 6, 2018, U.S. EPA approved a revised list of impaired waters pursuant to CWA section 303(d), which requires identification of specific water bodies where it is expected that water quality standards will not be met after implementation of technology-based effluent limitations on point sources. Where it has not done so already, the Regional Water Board plans to adopt total maximum daily loads (TMDLs) for pollutants on the 303(d) list. TMDLs establish wasteload allocations for point sources and load allocations for nonpoint sources and are established to achieve water quality standards.

Lower San Francisco Bay is listed as impaired by mercury, PCBs, dioxin-like PCBs, chlordane, DDT, dieldrin, invasive species, trash, and dioxin and furan compounds. On February 12, 2008, U.S. EPA approved a TMDL for mercury in San Francisco Bay. On March 29, 2010, U.S. EPA approved a TMDL for PCBs in San Francisco Bay. The mercury and PCBs TMDLs apply to this discharge and are implemented through NPDES Permit No. CA0038849.

As shown in Fact Sheet section IV.C.3, the discharge is not a significant source of chlordane, DDT, or dieldrin because these pollutants have not been detected in the discharge. The discharge is not a source of invasive species because it is disinfected. It is not a source of trash because it is screened and treated to secondary treatment standards. This Order contains dioxin-TEQ effluent limitations to ensure that dioxins and furans in effluent are kept below water quality objectives.

### IV. RATIONALE FOR EFFLUENT LIMITATIONS AND DISCHARGE SPECIFICATIONS

The CWA requires point source dischargers to control the amount of conventional, non-conventional, and toxic pollutants discharged into waters of the United States. The control of pollutants discharged is established through effluent limitations and other requirements in NPDES permits. There are two principal bases for effluent limitations: 40 C.F.R. section 122.44(a) requires that permits include applicable technology-based limitations and standards; and 40 C.F.R. section 122.44(d) requires that permits include water quality-based effluent limitations to attain and maintain applicable numeric and narrative water quality criteria to protect the beneficial uses of receiving waters.

### A. Discharge Prohibitions

- 1. Discharge Prohibition III.A (No discharge other than as described in this Order): This prohibition is based on 40 C.F.R. section 122.21(a) and Water Code section 13260, which require filing an application and Report of Waste Discharge before a discharge can occur. Discharges not described in the application and Report of Waste Discharge, and subsequently in this Order, are prohibited.
- **2. Discharge Prohibition III.B** (**No discharge without at least 63:1 initial dilution**): The water quality-based effluent limitations and reasonable potential analysis for chronic toxicity in this Order are based on the mixing zones and dilution credits explained in Fact Sheet section IV.C.4.b and Table F-8. This prohibition is necessary to ensure that this Order's effluent limitations remain protective of water quality.
- 3. Discharge Prohibition III.C (No bypass): This prohibition is based on 40 C.F.R. section 122.41(m) (see Attachment D § I.G). Bypass is prohibited; however, bypass is approved for the portion of the flow greater than the wet weather capacity subject to the following conditions: (1) the peak wet weather influent flow volume exceeds the wet weather capacity (currently 30 MGD); (2) the discharge complies with the Order's effluent and receiving water limitations; (3) the Discharger fully complies with Provision VI.C.5.a; (4) the City of San Bruno continues to implement a transfer of title private sewer lateral inspection ordinance, and the City of South San Francisco implements a transfer of title private sewer lateral inspection ordinance by January 1, 2021; and the Facility is operated as designed and in accordance with the Operation and Maintenance Manual developed for the Facility (i.e., the Discharger must optimize storage and use of equalization units, and fully utilize the biological treatment units). Under these conditions, excess flows may bypass biological treatment and be blended with effluent receiving biological treatment. All flows must be disinfected prior to discharge.

The Discharger meets the criteria required for the Regional Water Board to approve these bypasses as follows (see Attachment D section I.G.3):

- Bypass is unavoidable to prevent loss of life, personal injury, or severe property damage. Bypass is unavoidable during periods of heavy rain to prevent damage to the biological treatment units and effluent conveyance system. When primary effluent flow is greater than 30 MGD (the maximum biological treatment capacity), bypassing some flows around biological treatment prevents the washout of solids and the microbial population from the biological treatment system.
- There are no feasible alternatives to the bypass. Provision VI.C.5.a requires the Discharger to implement feasible measures to minimize and eventually eliminate wet weather bypasses. During the term of the previous order, the Discharger developed a Wet Weather Improvement Plan with measurable goals to reduce wet weather bypasses. The Discharger maintains substantial secondary treatment and onsite storage capacity, and is increasing its secondary treatment capacity to 40 MGD (from the current 30 MGD) by adding a fourth secondary clarifier. The Discharger is also rehabilitating aeration basins that are currently offline. These improvements are scheduled to be completed by 2022. Moreover, the Discharger plans to complete \$5.0 million of collection system projects over the coming permit term.

The City of South San Francisco does not currently have a transfer of title private sewer lateral inspection program to reduce wet weather infiltration and inflow from private sewer laterals within its service area. The City of San Bruno and many other jurisdictions have such an ordinance; therefore, it is feasible for the City of South San Francisco to adopt one as well. For this reason, the approval to bypass when blending is conditioned on the City of South San Francisco implementing a private sewer lateral inspection ordinance by January 1, 2021.

• The Discharger provided notice at least ten days before the date of the bypass. The Discharger provided notice of these anticipated wet weather bypasses with its Report of Waste Discharge on August 31, 2018.

The Regional Water Board may approve anticipated bypasses after considering their adverse effects. In this case, adverse effects are anticipated to be minimal because the bypasses must comply with all effluent limits. Furthermore, based on past performance, bypasses will occur rarely and only during peak wet weather events (see Fact Sheet § II.A.3), when tidal mixing will greatly dilute discharges to Lower San Francisco Bay.

- 4. Discharge Prohibition III.D (No average dry weather flow in excess of design capacity): This Order prohibits average dry weather influent flows greater than the plant's design average dry weather treatment capacity (i.e., its historical and tested treatment reliability) of 13.0 MGD. Exceeding this flow could result in lower treatment reliability and greater potential to violate water quality requirements.
- 5. Discharge Prohibition III.E (No sanitary sewer overflows to waters of the United States): Basin Plan Table 4-1, Discharge Prohibition 15, and the CWA prohibit the discharge of wastewater to surface waters, except as authorized under an NPDES permit. Publicly-owned treatment works must achieve secondary treatment at a minimum and any more stringent limitations necessary to meet water quality standards (33 U.S.C. § 1311[b][1][B] and [C]). A sanitary sewer overflow that results in the discharge of raw sewage or wastewater not meeting this Order's effluent limitations to waters of the United States is therefore prohibited under the Basin Plan and the CWA.

#### **B.** Technology-Based Effluent Limitations

#### 1. Scope and Authority

CWA section 301(b) and 40 C.F.R. section 122.44 require that permits include conditions meeting technology-based requirements, at a minimum, and any more stringent effluent limitations necessary to meet water quality standards. The discharges authorized by this Order must meet minimum federal technology-based requirements based on the secondary treatment standards at 40 C.F.R. section 133 as summarized below. In addition, the 30-day average percent removal for biochemical oxygen demand (BOD<sub>5</sub>) (or carbonaceous biochemical demand, CBOD<sub>5</sub>) and total suspended solids (TSS), by concentration, is not to be less than 85 percent. Also, the pH is to be within 6.0 and 9.0. The Basin Plan contains additional requirements for certain pollutants.

#### 2. Effluent Limitations

- **a. BOD**<sub>5</sub> and **TSS**. The BOD<sub>5</sub> and TSS effluent limitations, including the 85 percent removal requirements, are based on the secondary treatment standards and Basin Plan Table 4-2.
- **b.** Oil and Grease. The oil and grease effluent limitations are based on Basin Plan Table 4-2.
- **c. pH.** The pH effluent limitations are based on the secondary treatment standards and Basin Plan Table 4-2.
- **d.** Chlorine Residual. The total residual chlorine effluent limitation is based on Basin Plan Table 4-2. The Monitoring and Reporting Program (MRP, Attachment E) provides an allowance for determining false positives when using continuous devices based on the fact that continuous instruments occasionally have anomalous spikes, and it is chemically improbable to have free chlorine in the presence of sodium bisulfite. The allowance for using only on-the-hour measurements for mandatory minimum penalty assessment purposes under Water Code section 13385.1 is based on a 2004 strategy developed between the Regional Water Board and the Bay Area Clean Water Agencies.

### C. Water Quality-Based Effluent Limitations (WQBELs)

#### 1. Scope and Authority

This Order contains WQBELs that protect beneficial uses. CWA section 301(b) and 40 C.F.R. section 122.44(d) require that permits include limitations more stringent than federal technology-based requirements where necessary to achieve applicable water quality standards. According to 40 C.F.R. section 122.44(d)(1)(i), permits must include effluent limitations for all pollutants that are or may be discharged at levels that have a reasonable potential to cause or contribute to an exceedance of a water quality standard, including numeric and narrative objectives within a standard. Where reasonable potential has been established for a pollutant, but there is no numeric criterion or objective, WQBELs must be established using (1) U.S. EPA criteria guidance under CWA section 304(a), supplemented where necessary by other relevant information; (2) an indicator parameter for the pollutant of concern; or (3) a calculated numeric water quality criterion, such as a proposed state criterion or policy interpreting a narrative

criterion, supplemented with relevant information (40 C.F.R. § 122.44 [d][1][vi]). The process for determining reasonable potential and calculating WQBELs is intended to achieve applicable water quality objectives and criteria, and to protect designated uses of receiving waters as specified in the Basin Plan.

# 2. Beneficial Uses and Water Quality Criteria and Objectives

Discharge Point No. 002 discharges to Lower San Francisco Bay. Fact Sheet section III.C.1, above, identifies the beneficial uses of Lower San Francisco Bay. Water quality criteria and objectives to protect these beneficial uses are described below.

- **a. Basin Plan Objectives.** The Basin Plan specifies numerous water quality objectives, including numeric objectives for 10 priority pollutants and un-ionized ammonia, and narrative objectives for bioaccumulation and toxicity.
  - i. Ammonia. Basin Plan section 3.3.20 contains water quality objectives for un-ionized ammonia of 0.025 mg/L (as nitrogen) as an annual median and 0.4 mg/L (as nitrogen) as a maximum for Lower San Francisco Bay. Effluent and receiving water data are available for total ammonia, but not un-ionized ammonia, because (1) sampling and laboratory methods are unavailable to analyze for un-ionized ammonia, and (2) the fraction of total ammonia that exists in the toxic un-ionized form depends on pH, salinity, and temperature of the receiving water.

To translate the un-ionized ammonia objectives into total ammonia criteria, pH, salinity, and temperature data were obtained from the Regional Monitoring Program (RMP) station nearest the outfall (Oyster Point monitoring station, BB30). The unionized fraction of the total ammonia was calculated using the following equation, which applies to waters with salinities greater than 10 parts per thousand (Ambient Water Quality Criteria for Ammonia (Saltwater)—1989, EPA Publication 440/5-88-004, 1989):

For salinity > 10 ppt: fraction of NH<sub>3</sub> = 
$$\frac{1}{1+10^{(pK-pH)}}$$

Where:

pK = 9.245 + 0.116\*(I) + 0.0324\*(298-T) + 0.0415\*(P)/T

I = the molal ionic strength of saltwater = 19.9273\*(S)/(1000-1.005109\*S)

S = salinity (parts per thousand)

T = temperature in Kelvin

P = pressure (one atmosphere)

The 90th percentile and median un-ionized ammonia fractions were then used to express the maximum and annual average un-ionized objectives as acute and chronic total ammonia criteria. This approach is consistent with U.S. EPA guidance on translating dissolved metal water quality objectives to total recoverable metal water quality criteria (U.S. EPA, 1996, *The Metals Translator: Guidance for Calculating a Total Recoverable Limit form a Dissolved Criterion*, EPA Publication 823-B96-007). The equivalent acute and chronic total ammonia criteria are 14 mg/L and 1.5 mg/L (as nitrogen).

ii. Dioxin-TEQ. The narrative bioaccumulation objective (Basin Plan § 3.3.2) states, "Many pollutants can accumulate on particulates, in sediments, or bioaccumulate in fish and other aquatic organisms. Controllable water quality factors shall not cause a detrimental increase in concentrations of toxic substances found in bottom sediments or aquatic life. Effects on aquatic organisms, wildlife, and human health will be considered." Because it is the consensus of the scientific community that dioxins and furans associate with particulates, accumulate in sediments, and bioaccumulate in the fatty tissue of fish and other organisms, the Basin Plan's narrative bioaccumulation water quality objective applies to these pollutants. Elevated levels of dioxins and furans in San Francisco Bay fish tissue demonstrate that the narrative bioaccumulation water quality objective is not being met. U.S. EPA has therefore placed Lower San Francisco Bay on its 303(d) list of receiving waters where water quality objectives are not being met after imposition of applicable technology-based requirements.

When the CTR was promulgated, U.S. EPA stated its support for the regulation of dioxin and dioxin-like compounds through the use of toxicity equivalencies (TEQs). U.S. EPA stated, "For California waters, if the discharge of dioxin or dioxin-like compounds has reasonable potential to cause or contribute to a violation of a narrative criterion, numeric water quality-based effluent limits for dioxin or dioxin-like compounds should be included in NPDES permits and should be expressed using a TEQ scheme" (Fed. Reg. Vol. 65, No. 97, pages 31695-31696, May 18, 2000). This Order uses a TEQ scheme based on a set of toxicity equivalency factors (TEFs) the World Health Organization developed in 2005, and a set of bioaccumulation equivalency factors (BEFs) U.S. EPA developed for the Great Lakes region (40 C.F.R. § 132, Appendix F) to convert the concentration of any congener of dioxin or furan into an equivalent concentration of 2,3,7,8-tetrachlorinated dibenzo-p-dioxin (2,3,7,8-TCDD). Although the 2005 World Health Organization scheme includes TEFs for dioxin-like PCBs, they are not included in this Order's TEQ scheme. The CTR has established a specific water quality criterion for PCBs, and dioxin-like PCBs are included in the analysis of total PCBs.

The CTR establishes a numeric water quality objective for 2,3,7,8-TCDD of  $1.4 \times 10^{-8} \, \mu g/L$  for the protection of human health when aquatic organisms are consumed. This CTR criterion is used as a criterion for dioxin TEQ because dioxin-TEQ represents a toxicity-weighted concentration equivalent to 2,3,7,8-TCDD, thus translating the narrative bioaccumulation objective into a numeric criterion.

**iii. Chronic Toxicity**. The narrative toxicity objective (Basin Plan § 3.3.18) states, "All waters shall be maintained free of toxic substances in concentrations that are lethal to or that produce other detrimental responses in aquatic organisms... There shall be no chronic toxicity in ambient waters. Chronic toxicity is a detrimental biological effect on growth rate, reproduction, fertilization success, larval development, population abundance, community composition, or any other relevant measure of the health of an organism, population, or community. Attainment of this objective will be determined by analyses of indicator organisms, species diversity, population density, growth anomalies, or toxicity tests..., or other methods selected by the Water Board."

For this Order, this narrative objective is translated into a numeric criterion of 1.0 chronic toxicity unit (TU<sub>c</sub>). At 1.0 TU<sub>c</sub>, there is no observable detrimental effect when the indicator organism is exposed to 100 percent effluent; therefore, 1.0 TU<sub>c</sub> is a direct translation of the narrative objective into a number. Moreover, in U.S. EPA's *Technical Support Document for Water Quality-based Toxics Control* (EPA/505/2-90-001; see section 3.3.3, "Step 3: Decision Criteria for Permit Limit Development"), U.S. EPA recommends that 1.0 TU<sub>c</sub> be used as a criterion continuous concentration (typically a four-day average). It further states that reasonable potential is shown where an effluent is projected to cause an excursion above the criterion continuous concentration. This document applies here as guidance because it directly addresses effluent characterization for toxicity.

- b. CTR Criteria. The CTR specifies numeric aquatic life and human health criteria for numerous priority pollutants. These criteria apply to inland surface waters and enclosed bays and estuaries. Some human health criteria are for consumption of "water and organisms" and others are for consumption of "organisms only." The criteria applicable to "organisms only" apply to Lower San Francisco Bay because it is not a source of drinking water.
- **c. NTR Criteria.** The NTR establishes numeric aquatic life and human health criteria for a number of toxic pollutants for San Francisco Bay waters upstream to and including Suisun Bay and the Sacramento-San Joaquin Delta. The NTR criteria apply to Lower San Francisco Bay.
- **d. Bacteria Water Quality Objectives.** The *Water Quality Control Plan for Inland Surface Waters, Enclosed Bays, and Estuaries of California Part 3, Bacteria Provisions and a Water Quality Standards Variance Policy* establishes enterococci bacteria water quality objectives to limit cases of gastrointestinal illness from water contact recreation. The enterococci bacteria objectives apply to marine and estuarine waters.
- **e. Sediment Quality Objectives.** The *Water Quality Control Plan for Enclosed Bays and Estuaries Part 1, Sediment Quality* contains the following narrative water quality objectives:
  - i. "Pollutants in sediments shall not be present in quantities that, alone or in combination, are toxic to benthic communities in bays and estuaries of California." This objective is to be implemented by integrating three lines of evidence: sediment toxicity, benthic community condition, and sediment chemistry. The policy requires that if the Regional Water Board determines that a discharge has reasonable potential to cause or contribute to an exceedance of this objective, it is to impose the objective as a receiving water limit.
  - **ii.** "Pollutants shall not be present in sediments at levels that will bioaccumulate in aquatic life to levels that are harmful to human health in bays and estuaries of California." This objective is to be implemented by a three-tiered procedure based on pollutant concentrations in sediment and fish tissue.
  - iii. "Pollutants shall not be present in sediment at levels that alone or in combination are toxic to wildlife and resident finfish by direct exposure or bioaccumulate in aquatic

life at levels that are harmful to wildlife or resident finfish by indirect exposure in bays and estuaries of California." This objective is to be implemented on a case-by-case basis, based upon an ecological risk assessment.

f. Receiving Water Salinity. Basin Plan section 4.6.2 (like the CTR and NTR) states that the salinity characteristics (i.e., freshwater vs. saltwater) of the receiving water are to be considered in determining the applicable water quality objectives. Freshwater criteria apply to discharges to waters with salinities equal to or less than one part per thousand (ppt) at least 95 percent of the time. Saltwater criteria apply to discharges to waters with salinities equal to or greater than 10 ppt at least 95 percent of the time in a normal water year. For discharges to water with salinities in between these two categories, or tidally-influenced freshwaters that support estuarine beneficial uses, the water quality objectives are the lower of the salt or freshwater criteria (the latter calculated based on ambient hardness) for each substance.

The receiving water for the Facility's discharge to Lower San Francisco Bay is a saltwater environment based on salinity data collected through the RMP at the Oyster Point monitoring station (BB30) between 1993 and 2001. During that period, the receiving water's salinity was greater than 10 ppt in over 95 percent of the samples. Therefore, the reasonable potential analysis and effluent limitations in this Order are based on saltwater water quality criteria and objectives.

g. Site-Specific Metals Translators. Effluent limitations for metals must be expressed as total recoverable metal (40 C.F.R. § 122.45[c]). Since the water quality objectives for metals are typically expressed as dissolved metal, translators must be used to convert metals concentrations from dissolved to total recoverable and vice versa. The CTR contains default translators; however, site-specific conditions, such as water temperature, pH, total suspended solids, and organic carbon may affect the form of metal (dissolved, non-filterable, or otherwise) present and therefore available to cause toxicity. In general, dissolved metals are more available and more toxic to aquatic life than other forms. Site-specific translators can account for site-specific conditions, thereby preventing overly stringent or under-protective water quality objectives.

CTR default translators were used for all metals other than copper and nickel. Basin Plan Table 7.2.1-2 sets forth site-specific copper translators. The Clean Estuary Partnership's *North of Dumbarton Bridge Copper and Nickel Development and Selection of Final Translators* (March 2005) contains site-specific nickel translators. These translators are listed in the table below:

3. Need for Water Quality-Based Effluent Limitations (Reasonable Potential Analysis)

Assessing whether a pollutant has reasonable potential to exceed a water quality objective is the fundamental step in determining whether a WQBEL is required.

**a. Available Information.** The reasonable potential analysis for this Order is based on effluent monitoring data the Discharger collected from June 2014 through October 2018, and ambient background data summarized in *San Francisco Bay California Toxics Rule Priority Pollutant Ambient Water Monitoring Report* (2017), which includes data collected through the RMP at the Yerba Buena monitoring station (BC10) from March 1993 through August 2015, supplemented by additional Bay Area Clean Water Agencies data from *San Francisco Bay Ambient Water Monitoring Interim Report* (2003) and *Ambient Water Monitoring: Final CTR Sampling Update* (2004).

SIP section 1.4.3 requires that background water quality data be representative of the ambient receiving water that will mix with the discharge. For the priority pollutants, the Yerba Buena RMP monitoring station (BC10), relative to other RMP stations, best fits SIP guidance for establishing background conditions at Discharge Point No. 002. For ammonia, the nearby Oyster Point RMP monitoring station (BB30), relative to other RMP locations, best fits SIP guidance for establishing background conditions because the ammonia WQBELs are based on actual dilution at the edge of the initial mixing zone and data from monitoring station BB30 best represents water quality at the edge of the initial mixing zone.

This Order does not contain WQBELs for constituents that do not demonstrate reasonable potential; however, the MRP still requires monitoring for those pollutants. If concentrations are found to have increased significantly, Provision VI.C.2 of the Order requires the Discharger to investigate the sources of the increases and implement remedial measures if the increases pose a threat to receiving water quality.

# b. Priority Pollutants, Ammonia, and Dioxin-TEQ

- i. Methodology. SIP section 1.3 sets forth the methodology used for this Order for assessing whether a priority pollutant has reasonable potential to exceed a water quality objective. SIP section 1.3 applies to priority pollutants and is used here for dioxin-TEQ and ammonia as guidance. The analysis begins with identifying the maximum effluent concentration (MEC) observed for each pollutant based on available effluent concentration data and the ambient background concentration (B). SIP section 1.4.3 states that ambient background concentrations are either the maximum ambient concentration observed or, for water quality objectives intended to protect human health, the arithmetic mean of observed concentrations. There are three triggers in determining reasonable potential:
  - (a) **Trigger 1** is activated if the maximum effluent concentration is greater than or equal to the lowest applicable water quality objective (MEC ≥ water quality objective).
  - (b) **Trigger 2** is activated if the ambient background concentration observed in the receiving water is greater than the lowest applicable water quality objective (B > water quality objective) *and* the pollutant is detected in any effluent sample.
  - (c) **Trigger 3** is activated if a review of other information indicates that a WQBEL is needed to protect beneficial uses.

ii. Analysis. The maximum effluent concentrations, most stringent applicable water quality criteria and objectives, and ambient background concentrations used in the analysis are presented in the following table, along with the reasonable potential analysis results (yes, no, or unknown) for each pollutant. Basin Plan sections 7.2.1.2 and 4.7.2.2 require copper and cyanide WQBELs for all individual NPDES permits for municipal wastewater treatment facilities that discharge to San Francisco Bay. Dioxin-TEQ has reasonable potential because and Lower San Francisco Bay is 303(d)-listed for dioxin-TEQ and elevated levels of dioxins and furans are found in San Francisco Bay fish tissue.

  - **c. Acute Toxicity.** Basin Plan section 4.5.5.3.1 requires acute toxicity monitoring and limitations, implying there is reasonable potential for the discharge to cause or contribute to exceedances of the acute toxicity water quality objective.
  - **d. Chronic Toxicity.** There is no reasonable potential for chronic toxicity in the receiving water, and no WQBEL is required. The *Technical Support Document for Water Quality-based Toxics Control* allows for dilution credits to be considered when conducting a reasonable potential analysis. This Order establishes a chronic toxicity dilution credit of 63:1 (D = 62) based on initial dilution (see Fact Sheet § IV.C.4.b below). This is conservative because the translated criterion for chronic toxicity is expressed as a four-day average and the dilution was calculated using a maximum four-day average flow. Basin Plan section 4.5.5.3.2 allows chronic toxicity dilution credits "comparable to those allowed for numeric chemical-specific objectives." For ammonia, Fact Sheet section IV.C.4.b.iii establishes a chronic condition dilution credit of 125:1 and an acute condition dilution credit of 37:1.

The Discharger conducted chronic toxicity tests twice per year during the previous order term. The maximum single-sample chronic toxicity result was  $10.7~\mathrm{TU_c}$ . Applying the dilution credit of 63:1 to  $10.7~\mathrm{TU_c}$ , the resulting toxicity is less than  $1.0~\mathrm{TU_c}$ , which is also less than the translated chronic toxicity objective  $(1.0~\mathrm{TU_c})$ .

- e. Fecal Coliform Bacteria. Basin Plan Table 4-2A requires total coliform effluent limitations for discharges to receiving waters that support the shellfish harvesting beneficial use. Footnote c allows substitution with fecal coliform limits provided that doing so will not result in unacceptable adverse impacts on beneficial uses (i.e., shellfish harvesting).
- **f.** Enterococcus Bacteria. The Water Quality Control Plan for Inland Surface Waters, Enclosed Bays, and Estuaries of California Part 3, Bacteria Provisions and a Water Quality Standards Variance Policy requires enterococcus bacteria effluent limitations for discharges to marine and estuarine receiving waters that support the water contact recreation (REC1) beneficial use.

**g. Sediment Quality.** Pollutants in some receiving water sediments may be present in quantities that alone or in combination are toxic to benthic communities. However, to date there is no evidence directly linking compromised sediment conditions to the discharges subject to this Order; therefore, the Regional Water Board cannot draw a conclusion about reasonable potential for these discharges to cause or contribute to exceedances of the sediment quality objectives. Nevertheless, the Discharger continues to participate in the RMP, which routinely monitors San Francisco Bay sediment and seeks to identify stressors responsible for degraded sediment quality.

# 4. Water Quality-Based Effluent Limitations (WQBELs)

WQBELs were developed for the pollutants determined to have reasonable potential to cause or contribute to exceedances of water quality objectives. With the exception of acute toxicity, fecal coliform bacteria, and enterococcus bacteria (discussed below), the WQBEL calculations are based on the procedures in SIP section 1.4.

- **a. WQBEL Expression.** NPDES regulations at 40 C.F.R. section 122.45(d) require that permit limits for publicly-owned treatment works be expressed as average weekly and average monthly limits, unless impracticable. This Order contains daily limits instead of weekly limits because daily limits better protect against acute water quality effects and are necessary to prevent fish kills or mortality to aquatic organisms. Weekly limits could allow acute and chronic toxicity to occur over shorter periods (acute and chronic aquatic life criteria are typically expressed as one-hour and four-day averages).
- **b.** Mixing Zones and Dilution Credits. SIP section 1.4.2 allows mixing zones and dilution credits under certain circumstances. The Discharger submitted a study titled Near-field Mixing Zone and Dilution Analysis for the North Bayside System Unit Outfall Diffuser to Lower San Francisco Bay (May 18, 2018) that estimates the minimum initial dilution at Discharge Point No. 002 under several scenarios using the U.S. EPA-supported CORMIX model. Modelling was based on the average dry-weather effluent flow with the median ambient velocity during low Delta outflows (chronic conditions for ammonia), the maximum design effluent flow with the average ambient velocity 30 minutes before and after slack tide during low Delta outflows (acute conditions for ammonia), and the maximum four-day average effluent flow with the minimum four-day average ambient velocity during low Delta outflows (chronic toxicity). The study found that the plume is buoyant and rapidly mixes through the water column. Vertical mixing occurs before the momentum of the discharge fully dissipates. As the plume continues to spread and the remaining momentum of the discharge dissipates, dilution continues to occur but at a much slower rate. The following table summarizes the modelling results for dilution at the edge of the plume at the point where the dilution rate slows significantly:

  - i. Bioaccumulative Pollutants. For certain bioaccumulative pollutants, dilution credit is significantly restricted or denied. Specifically, these pollutants include dioxin and furan compounds, which appear on the CWA section 303(d) list for Lower San Francisco Bay because, based on available data on the concentrations of these pollutants in aquatic organisms, sediment, and the water column, they impair beneficial uses. The following factors suggest insufficient assimilative capacity in San Francisco Bay for these pollutants.

Tissue samples taken from San Francisco Bay fish show the presence of these pollutants at concentrations greater than screening levels (*Contaminant Concentrations in Fish from San Francisco Bay*, May 1997). The results of a 1994 San Francisco Bay pilot study, presented in *Contaminated Levels in Fish Tissue from San Francisco Bay* (Regional Water Board, 1994) also show elevated levels of chemical contaminants in fish tissues. The Office of Environmental Health and Hazard Assessment completed a preliminary review of the data in the 1994 report and in December 1994 issued an interim consumption advisory covering certain fish species in San Francisco Bay due to the levels of some of these pollutants. The Office of Environmental Health and Hazard Assessment updated this advisory in a May 2011 report, *Health Advisory and Safe Eating Guidelines for San Francisco Bay Fish and Shellfish*, which still suggests insufficient assimilative capacity in San Francisco Bay for 303(d)-listed pollutants. Therefore, dilution credits are denied for bioaccumulative pollutants on the 303(d) list for which data are lacking on sources

and significant uncertainty exists about how different sources contribute to bioaccumulation.

- ii. Non-Bioaccumulative Pollutants (except ammonia and chronic toxicity). For non-bioaccumulative pollutants (except ammonia and chronic toxicity), a conservative dilution credit of 10:1 (D = 9) has been assigned. The 10:1 dilution credit is based, in part, on Basin Plan Prohibition 1 (Table 4-1), which prohibits discharges with less than 10:1 dilution. SIP section 1.4.2 allows for limiting the dilution credit. The dilution credit is limited for the following reasons:
  - (a) San Francisco Bay is a complex estuarine system with highly variable and seasonal upstream freshwater inflows and diurnal tidal saltwater inputs. SIP section 1.4.3 allows background conditions to be determined on a discharge-by-discharge or water body-by-water body basis. A water body-by-water body approach is taken here due to inherent uncertainties in characterizing ambient background conditions in a complex estuarine system on a discharge-by-discharge basis.
  - (b) Because of the complex hydrology of San Francisco Bay, there are uncertainties in accurately determining an appropriate mixing zone. The models used to predict dilution do not consider the three-dimensional nature of San Francisco Bay currents resulting from the interaction of tidal flushes and seasonal fresh water outflows. Being heavier and colder than fresh water, ocean salt water enters San Francisco Bay on a twice-daily tidal cycle, generally beneath the warmer fresh water that flows seaward. When these waters mix and interact, complex circulation patterns occur due to the varying densities of the fresh and ocean waters. The locations of this mixing and interaction change depending on the strength of each tide. Additionally, sediment loads from the Central Valley change on a long-term basis, affecting the depth of different parts of San Francisco Bay, resulting in alteration of flow patterns, mixing, and dilution at the outfall.
- iii. Ammonia. For ammonia, a conservative estimate of actual initial dilution was used to calculate the effluent limitations. This is justified because ammonia, a non-persistent pollutant, quickly disperses and degrades to a non-toxic state, and cumulative toxicity is unlikely. This Order uses the 125:1 dilution ratio (D = 124) to calculate WQBELs based on the chronic water quality objective because that objective is an annual median; the dilution ratio associated with the permitted average dry weather flow best represents long-term (chronic) conditions. This Order uses the 37:1 dilution ratio (D = 36) to calculate WQBELs based on the acute water quality objective because that objective is a maximum; the dilution associated with the peak wet weather flow, or effluent forcemain capacity, conservatively represents short-term (acute) conditions.
- iv. Chronic Toxicity. This Order establishes a chronic toxicity dilution credit of 63:1 (D = 62) based on initial dilution. This is conservative because the translated criterion for chronic toxicity is expressed as a four-day average and the dilution was calculated using a maximum four-day average flow.

**c. WQBEL Calculations.** The following table shows the WQBEL calculations for copper, cyanide, dioxin-TEQ, and ammonia. The copper and cyanide WQBELs are calculated as required by SIP section 1.4. This same methodology is used as guidance to calculate the dioxin-TEQ and ammonia WQBELs.

**d. Acute Toxicity**. This Order includes acute toxicity effluent limitations based on Basin Plan Table 4-3. Based on Basin Plan section 3.3.20, if the Discharger can demonstrate

that ammonia causes acute toxicity in excess of the acute toxicity limitations in this Order, and that the ammonia in the discharge complies with the ammonia effluent limitations in this Order, then such toxicity does not constitute a violation of the effluent limitations for whole effluent acute toxicity.

e. Fecal Coliform Bacteria. This Order retains the fecal coliform effluent limitations from the previous order. Basin Plan Table 4-2A requires limitations for total coliform bacteria for discharges to receiving waters with the shellfish harvesting beneficial use. Basin Plan Table 4-2A, footnote c, allows substituting total coliform bacteria limitations with fecal coliform bacteria limitations provided that it can be conclusively demonstrated that the substitution will not result in unacceptable adverse impacts on the beneficial uses.

Shellfish beds may be present along the shore. However, the NBSU outfall is located approximately 5,300 feet offshore and discharges effluent through a deepwater diffuser. The discharge achieves a minimum dilution ratio of 63:1 at a distance of about 100 feet from the diffuser. Due to the outfall's distance from the shore, the buoyant nature of the discharge, and the initial dilution modeled, the discharge is not expected to affect shoreline fecal coliform densities. Compliance with fecal coliform effluent limits in this Order would result in fecal coliform densities well below the water quality objectives required to protect shellfish harvesting.

**f.** Enterococcus Bacteria. The enterococcus effluent limitations are based on the Water Quality Control Plan for Inland Surface Waters, Enclosed Bays, and Estuaries of California – Part 3, Bacteria Provisions and a Water Quality Standards Variance Policy.

# **D.** Discharge Requirement Considerations

- 1. Antidegradation. This Order complies with the antidegradation provisions of 40 C.F.R. section 131.12 and State Water Board Resolution 68-16. It does not authorize lowering water quality as compared to the level of discharge authorized in the previous order, which is the baseline by which to measure whether degradation will occur. This Order does not allow for an increased flow, a reduced level of treatment, or increased effluent limitations relative to the previous order.
- **2. Anti-backsliding.** This Order complies with the anti-backsliding provisions of CWA sections 402(o) and 303(d)(4), and 40 C.F.R. section 122.44(l), which generally require effluent limitations in a reissued permit to be as stringent as those in the previous order. The requirements of this Order are at least as stringent as those in the previous order.
- 3. Stringency of Requirements for Individual Pollutants. This Order contains both technology-based and WQBELs for individual pollutants. The technology-based requirements implement minimum, applicable federal technology-based requirements. In addition, this Order contains more stringent effluent limitations as necessary to meet water quality standards. Collectively, this Order's restrictions on individual pollutants are no more stringent than required to implement CWA requirements.

This Order's WQBELs have been derived to implement water quality objectives that protect beneficial uses. The beneficial uses and water quality objectives have been approved pursuant to federal law and are the applicable federal water quality standards. To the extent

that WQBELs were derived from the CTR, the CTR is the applicable standard pursuant to 40 C.F.R. section 131.38. The procedures for calculating these WQBELs are based on the CTR, as implemented in accordance with the SIP, which U.S. EPA approved on May 18, 2000. U.S. EPA approved most Basin Plan beneficial uses and water quality objectives prior to May 30, 2000. Beneficial uses and water quality objectives submitted to U.S. EPA prior to May 30, 2000, but not approved by U.S. EPA before that date, are nonetheless "applicable water quality standards for purposes of the CWA" pursuant to 40 C.F.R. section 131.21(c)(1). U.S. EPA approved the remaining beneficial uses and water quality objectives, so they are applicable water quality standards pursuant to 40 C.F.R. section 131.21(c)(2).

# V. RATIONALE FOR RECEIVING WATER LIMITATIONS

The receiving water limitations in sections V.A and V.B of the Order are based on Basin Plan narrative and numeric water quality objectives. The receiving water limitation in section V.C of the Order requires compliance with federal and State water quality standards in accordance with the CWA and regulations adopted thereunder.

# VI. RATIONALE FOR PROVISIONS

# A. Standard Provisions

Attachment D contains standard provisions that apply to all NPDES permits in accordance with 40 C.F.R. section 122.41 and additional conditions applicable to specific categories of permits in accordance with 40 C.F.R. section 122.42. The Discharger must comply with these provisions. The conditions set forth in 40 C.F.R. sections 122.41(a)(1) and (b) through (n) apply to all state-issued NPDES permits and must be incorporated into permits either expressly or by reference.

In accordance with 40 C.F.R. section 123.25(a)(12), states may omit or modify conditions to impose more stringent requirements. Attachment G contains standard provisions that supplement the federal standard provisions in Attachment D. This Order omits the federal conditions that address enforcement authority specified in 40 C.F.R. sections 122.41(j)(5) and (k)(2) because the State's enforcement authority under the Water Code is more stringent. In lieu of these conditions, this Order incorporates Water Code section 13387(e) by reference.

# **B.** Monitoring and Reporting

CWA section 308 and 40 C.F.R. sections 122.41(h), 122.41(j)-(l), 122.44(i), and 122.48 require that NPDES permits specify monitoring and reporting requirements. Water Code sections 13267 and 13383 also authorize the Regional Water Board to establish monitoring, inspection, entry, reporting, and recordkeeping requirements. The MRP establishes monitoring, reporting, and recordkeeping requirements that implement federal and State requirements. For more background regarding these requirements, see Fact Sheet section VII. Regional Water Board Order No. R2-2016-0008 allows the Discharger to opt into certain alternative monitoring requirements.

# C. Special Provisions

# 1. Reopener Provisions

These provisions are based on 40 C.F.R. sections 122.62 and 122.63 and allow modification of this Order and its effluent limitations as necessary in response to updated water quality objectives, regulations, or other new and relevant information that may become available in the future, and other circumstances as allowed by law.

# 2. Effluent Characterization Study and Report

This Order does not include effluent limitations for priority pollutants that do not demonstrate reasonable potential, but this provision requires the Discharger to evaluate monitoring data to verify that the reasonable potential analysis conclusions of this Order remain valid. This requirement is authorized pursuant to 40 C.F.R. section 122.41(h) and Water Code section 13267 and is necessary to inform the next permit reissuance and to ensure that the Discharger takes timely steps in response to any unanticipated change in effluent quality during the term of this Order.

# 3. Pollutant Minimization Program

This provision is based on Basin Plan section 4.13.2 and SIP section 2.4.5.

# 4. Special Provisions for Publicly Owned Treatment Works

- **a. Pretreatment Program**. This provision is based on 40 C.F.R. part 403. The Discharger implements a pretreatment program due to the nature and volume of industrial influent to the plant. This provision lists the Discharger's responsibilities regarding its pretreatment program and requires compliance with the provisions in Attachment H, "Pretreatment Requirements."
- **b. Sludge and Biosolids Management.** This provision is based on Basin Plan section 4.17. "Sludge" refers to the solid, semisolid, and liquid residue removed during primary, secondary, and advanced wastewater treatment processes. "Biosolids" refers to sludge that has been treated and may be beneficially reused.
- c. Collection System Management. The City of South San Francisco and City of San Bruno collection systems are part of the Facility regulated through this Order (see Fact Sheet § II.A.2). This provision requires compliance with Attachments D and G and states that these requirements may be satisfied by separately complying with State Water Board Order No. 2006-0003-DWQ, Statewide General Waste Discharge Requirements for Sanitary Sewer Systems, as amended by State Water Board Order No. WQ 2013-0058-EXEC and any subsequent order updating these requirements. These statewide WDRs require public agencies that own or operate sanitary sewer systems with one or more miles of sewer lines to enroll for coverage and comply with requirements to develop sanitary sewer management plans and report sanitary sewer overflows, among other provisions and prohibitions. The statewide WDRs contain requirements for operation and maintenance of collection systems and for reporting and mitigating sanitary sewer overflows that are more extensive and, therefore, more stringent than the standard

provisions in Attachments D and G. Compliance with the statewide WDRs will satisfy the corresponding requirements in Attachments D and G.

# 5. Other Special Provisions

- a. Specific Tasks to Reduce Wet Weather Bypasses. This provision requires the Discharger to implement feasible measures to minimize and eventually eliminate wet weather bypasses consistent with Attachment D section I.G.3 and 40 CFR 122.41(m). The Discharger submitted a No Feasible Alternatives Analysis (Utility Analysis) with its permit reissuance application to determine whether any feasible alternatives are available to reduce wet weather bypasses (see Fact Sheet § IV.A.3). The analysis indicated that further capital improvements, beyond the current upgrades being made to increase secondary treatment capacity and onsite storage, would be cost-prohibitive and are therefore infeasible. The Discharger will also minimize wet weather bypasses by implementing collection system improvements to reduce inflow and infiltration. Furthermore, this Order requires the City of South San Francisco to develop a transfer of title private sewer lateral ordinance based on a review of Bay Area communities that have successfully adopted measures requiring inspection of private sewer laterals. The City of San Bruno and many other jurisdictions already have such an ordinance; therefore, it is feasible for the City of South San Francisco to adopt one as well. If the City of South San Francisco chooses not to implement all feasible measures to minimize and eventually eliminate wet weather bypasses, the wet weather bypasses cannot be approved. If the Discharger seeks to continue bypassing peak wet weather flows around the biological treatment units during the next permit term, this Order requires the Discharger to reconsider possible feasible alternatives by assessing the elements described in U.S. EPA's proposed *Peak Wet Weather Policy* (December 2005), used here as guidance.
- b. Copper Action Plan. This provision is based on Basin Plan section 7.2.1.2 and is necessary to ensure that use of copper site-specific objectives is consistent with antidegradation policies. The Discharger submitted an updated inventory of potential copper sources with its annual pollution minimization program report on February 27, 2018. This Order requires the Discharger to implement pretreatment, source control and pollution prevention for identified sources. Additional actions may be necessary depending on the three-year rolling mean copper concentration in Central or Lower San Francisco Bay (north of Hayward Shoals). Data the San Francisco Estuary Institute compiled for 2011-2015 indicate no degradation of San Francisco Bay water quality with respect to copper (<a href="http://www.sfei.org/content/copper-site-specific-objective-3-year-rolling-averages">http://www.sfei.org/content/copper-site-specific-objective-3-year-rolling-averages</a>).
- c. Cyanide Action Plan. This provision is based on Basin Plan section 4.7.2.2 and is necessary to ensure that use of cyanide site-specific objectives is consistent with antidegradation policies. The threshold for considering influent cyanide concentrations to indicate a possible "significant cyanide discharge" in the Discharger's service area is set at 14  $\mu$ g/L. This concentration is almost twice the maximum cyanide concentration (6.9  $\mu$ g/L) found in the treatment plant influent during the previous order term. Because the Discharger has observed no influent cyanide concentrations greater than 6.9  $\mu$ g/L, if influent concentrations twice this level were observed, there could be a significant cyanide source.

d. Anaerobically-Digestible Material. Standard Operating Procedures are required for dischargers that accept hauled waste food, fats, oil, and grease for injection into anaerobic digesters. The development and implementation of Standard Operating Procedures for management of these materials is intended to allow the California Department of Resources Recycling and Recovery to exempt operations from separate and redundant permitting programs. If the Discharger does not accept fats, oil, and grease for resource recovery purposes, it is not required to develop and implement Standard Operating Procedures.

Some POTWs choose to accept organic material, such as waste food, fats, oils, and grease, into their anaerobic digesters to increase production of methane and other biogases for energy production and to prevent such materials from being discharged into the collection system and potentially causing sanitary sewer overflows. The California Department of Resources Recycling and Recovery has proposed to exclude POTWs from Process Facility/Transfer Station permit requirements when the same activities are regulated under WDRs or NPDES permits. The proposed exclusion is restricted to anaerobically digestible materials that have been prescreened, slurried, processed, and conveyed in a closed system for co-digestion with regular sewage sludge. The exclusion is based on the facility developing Standard Operating Procedures for proper handling, processing, tracking, and management.

**e. Plant Upgrades.** This provision is based on 40 C.F.R. section 122.41(l). It specifies conditions that must be met before the Discharger brings its upgraded treatment plant online. It is necessary for the Regional Water Board to know when the upgraded plant begins treating wastewater and to ensure that the plant upgrades can effectively and reliably comply with the requirements of this Order.

# VII. RATIONALE FOR MONITORING AND REPORTING PROGRAM (MRP)

Attachment E contains the MRP for this Order. It specifies sampling stations, pollutants to be monitored (including all parameters for which effluent limitations are specified), monitoring frequencies, and reporting requirements. The following provides the rationale for these requirements:

# A. Monitoring Requirements Rationale

- 1. Influent Monitoring. Influent flow monitoring is necessary to understand Facility operations and to evaluate compliance with Prohibition III.D, which prohibits average dry weather influent flow greater than 13.0 MGD. Influent BOD<sub>5</sub> and TSS monitoring is necessary to evaluate compliance with this Order's 85 percent removal requirements. Basin Plan section 4.7.2.2 requires cyanide monitoring because this Order is based on site-specific cyanide water quality objectives.
- **2. Effluent Monitoring.** Effluent flow monitoring is necessary to understand Facility operations. Monitoring for other parameters is necessary to evaluate compliance with this Order's effluent limitations and to conduct future reasonable potential analyses. Monitoring during wet weather bypasses of biological treatment (blending) is to be reported separately from routine monitoring results so the data can be distinguished.

**3. Toxicity Testing**. Acute and chronic toxicity tests are necessary to evaluate compliance with this Order's effluent limitations and to conduct future reasonable potential analyses. Chronic toxicity tests are also necessary to evaluate whether chronic toxicity exceeds the trigger for accelerated monitoring and Toxicity Reduction Evaluations based on Basin Plan sections 4.5.5.3.2 and 4.5.5.3.3 and Basin Plan Table 4-5.

Because the Discharger elected to participate in the Alternate Monitoring and Reporting Requirements for Municipal Wastewater Dischargers for the Purpose of Adding Support to the San Francisco Bay Regional Monitoring Program (Order No. R2-2016-0008) and there was no significant change in the nature of the effluent, the Discharger did not conduct a chronic toxicity screening phase study for this permit reissuance. The MRP specifies that the mysid shrimp (Mysidopsis bahia) is to be used for chronic toxicity testing unless a more sensitive species is identified.

- **4. Receiving Water Monitoring.** RMP participation is necessary to characterize the receiving water and the effects of the discharge has on it. The RMP involves collecting data on pollutants and toxicity in San Francisco Bay water, sediment, and biota.
- **5. Pretreatment and Biosolids Monitoring.** The pretreatment and biosolids monitoring requirements for influent, effluent, and biosolids are necessary to evaluate compliance with the Discharger's pretreatment program. Biosolids monitoring is also required pursuant to 40 C.F.R. part 503.
- **6. Other Monitoring Requirements.** Pursuant to CWA section 308, U.S. EPA requires dischargers to participate in a Discharge Monitoring Report-Quality Assurance (DMR-QA) Study Program. The program annually evaluates the analytical abilities of laboratories that perform or support NPDES permit-required monitoring. The program applies to discharger laboratories and contract laboratories. There are two options to comply: (1) dischargers can obtain and analyze DMR-QA samples, or (2) pursuant to a waiver U.S. EPA issued to the State Water Board, dischargers can submit results from the most recent Water Pollution Performance Evaluation Study. Dischargers must submit results annually to the State Water Board, which then forwards the results to U.S. EPA.
- **B.** Monitoring Requirements Summary. The table below summarizes routine monitoring requirements. The Discharger shall support the Regional Monitoring Program to collect data for receiving water. This table is for informational purposes only. The actual requirements are specified in the MRP and elsewhere in this Order.

# VIII. PUBLIC PARTICIPATION

The Regional Water Board considered the issuance of WDRs that will serve as an NPDES permit for the Facility. As a step in the WDR adoption process, Regional Water Board staff developed tentative WDRs and encouraged public participation in the WDR adoption process.

- **A. Notification of Interested Parties.** The Regional Water Board notified the Discharger and interested agencies and persons of its intent to prescribe WDRs for the discharge and provided an opportunity to submit written comments and recommendations. Notification was provided through the *San Mateo County Times*. The public had access to the agenda and any changes in dates and locations through the Regional Water Board's website at <a href="https://www.waterboards.ca.gov/sanfranciscobay">waterboards.ca.gov/sanfranciscobay</a>.
- **B.** Written Comments. Interested persons were invited to submit written comments concerning the tentative WDRs as explained through the notification process. Comments were to be submitted either in person or by mail to the Executive Office at the Regional Water Board at 1515 Clay Street, Suite 1400, Oakland, California 94612, to the attention of Gaurav Mittal.

For full staff response and Regional Water Board consideration, the written comments were due at the Regional Water Board office by 5:00 p.m. on June 3, 2019.

**C. Public Hearing.** The Regional Water Board held a public hearing on the tentative WDRs during its regular meeting at the following date and time, and at the following location:

# REGIONAL STANDARD PROVISIONS, AND MONITORING AND REPORTING REQUIREMENTS

# **APPLICABILITY**

This document supplements the requirements of Federal Standard Provisions (Attachment D). For clarity, these provisions are arranged using to the same headings as those used in Attachment D.

# I. STANDARD PROVISIONS - PERMIT COMPLIANCE

- **A. Duty to Comply** Not Supplemented
- **B.** Need to Halt or Reduce Activity Not a Defense Not Supplemented
- **C. Duty to Mitigate** Supplement to Attachment D, Provision I.C.
  - 1. Contingency Plan. The Discharger shall maintain a Contingency Plan as prudent in accordance with current facility emergency planning. The Contingency Plan shall describe procedures to ensure that existing facilities remain in, or are rapidly returned to, operation in the event of a process failure or emergency incident, such as employee strike, strike by suppliers of chemicals or maintenance services, power outage, vandalism, earthquake, or fire. The Discharger may combine the Contingency Plan and Spill Prevention Plan (see Provision I.C.2, below) into one document. In accordance with Regional Water Board Resolution No. 74-10, discharge in violation of the permit where the Discharger has failed to develop and implement a Contingency Plan as described below may be the basis for considering the discharge a willful and negligent violation of the permit pursuant to California Water Code section 13387. The Contingency Plan shall, at a minimum, provide for the following:
    - a. Sufficient personnel for continued facility operation and maintenance during employee strikes or strikes against contractors providing services;
    - b. Maintenance of adequate chemicals or other supplies, and spare parts necessary for continued facility operations;
    - c. Emergency standby power;
    - d. Protection against vandalism;
    - e. Expeditious action to repair failures of, or damage to, equipment, including any sewer lines;
    - f. Reporting of spills and discharges of untreated or inadequately treated wastes, including measures taken to clean up the effects of such discharges; and
    - g. Maintenance, replacement, and surveillance of physical condition of equipment and facilities, including any sewer lines.

- **2. Spill Prevention Plan.** The Discharger shall maintain a Spill Prevention Plan to prevent accidental discharges and to minimize the effects of any such discharges. The Spill Prevention Plan shall do the following:
  - a. Identify the possible sources of accidental discharge, untreated or partially-treated waste bypass, and polluted drainage;
  - b. State when current facilities and procedures became operational and evaluate their effectiveness; and
  - **c.** Predict the effectiveness of any proposed facilities and procedures and provide an implementation schedule with interim and final dates when the proposed facilities and procedures will be constructed, implemented, or operational.
- D. Proper Operation and Maintenance Supplement to Attachment D, Provision I.D
  - 1. Operation and Maintenance Manual. The Discharger shall maintain an Operation and Maintenance Manual to provide the plant and regulatory personnel with a source of information describing all equipment, recommended operational strategies, process control monitoring, and maintenance activities. To remain a useful and relevant document, the Operation and Maintenance Manual shall be kept updated to reflect significant changes in treatment facility equipment and operational practices. The Operation and Maintenance Manual shall be maintained in usable condition and be available for reference and use by all relevant personnel and Regional Water Board staff.
  - 2. Wastewater Facilities Status Report. The Discharger shall maintain a Wastewater Facilities Status Report and regularly review, revise, or update it, as necessary. This report shall document how the Discharger operates and maintains its wastewater collection, treatment, and disposal facilities to ensure that all facilities are adequately staffed, supervised, financed, operated, maintained, repaired, and upgraded as necessary to provide adequate and reliable transport, treatment, and disposal of all wastewater from both existing and planned future wastewater sources under the Discharger's service responsibilities.
  - 3. Proper Supervision and Operation of Publicly-Owned Treatment Works (POTWs). POTWs shall be supervised and operated by persons possessing certificates of appropriate grade pursuant to Title 23, section 3680, of the California Code of Regulations.
- **E. Property Rights** Not Supplemented
- **F.** Inspection and Entry Not Supplemented
- **G.** Bypass Not Supplemented
- **H.** Upset Not Supplemented

# **I.** Other – Addition to Attachment D

- 1. Neither the treatment nor the discharge of pollutants shall create pollution, contamination, or nuisance as defined by California Water Code section 13050.
- 2. Collection, treatment, storage, and disposal systems shall be operated in a manner that precludes public contact with wastewater. If public contact with wastewater could reasonably occur on public property, warning signs shall be posted.
- 3. If the Discharger submits a timely and complete Report of Waste Discharge for permit reissuance, this permit shall continue in force and effect until the permit is reissued or the Regional Water Board rescinds the permit.

# II. STANDARD PROVISIONS – PERMIT ACTION – Not Supplemented

# III.STANDARD PROVISIONS - MONITORING

- A. Sampling and Analyses Supplement to Attachment D, Provisions III.A and III.B
  - 1. Certified Laboratories. Water and waste analyses shall be performed by a laboratory certified for these analyses in accordance with California Water Code section 13176.
  - **2. Minimum Levels.** For the 126 priority pollutants, the Discharger should use the analytical methods listed in Table B unless the Monitoring and Reporting Program (MRP, Attachment E) requires a particular method or minimum level (ML). All monitoring instruments and equipment shall be properly calibrated and maintained to ensure accuracy of measurements.
  - **3. Monitoring Frequency.** The MRP specifies the minimum sampling and analysis schedule.

# a. Sample Collection Timing

- i. The Discharger shall collect influent samples on varying days selected at random and shall not include any plant recirculation or other sidestream wastes, unless otherwise stipulated in the MRP. The Executive Officer may approve an alternative influent sampling plan if it is representative of plant influent and complies with all other permit requirements.
- ii. The Discharger shall collect effluent samples on days coincident with influent sampling, unless otherwise stipulated by the MRP. If influent sampling is not required, the Discharger shall collect effluent samples on varying days selected at random, unless otherwise stipulated in the MRP. The Executive Officer may approve an alternative effluent sampling plan if it is representative of plant discharge and in compliance with all other permit requirements.

- **iii.** The Discharger shall collect effluent grab samples during periods of daytime maximum peak flows (or peak flows through secondary treatment units for facilities that recycle effluent).
- **iv.** Effluent sampling for conventional pollutants shall occur on at least one day of any multiple-day bioassay the MRP requires. During the course of the bioassay, on at least one day, the Discharger shall collect and retain samples of the discharge. In the event that a bioassay result does not comply with effluent limitations, the Discharger shall analyze the retained samples for pollutants that could be toxic to aquatic life and for which it has effluent limitations.
  - (a) The Discharger shall perform bioassays on final effluent samples; when chlorine is used for disinfection, bioassays shall be performed on effluent after chlorination and dechlorination; and
  - (b) The Discharger shall analyze for total ammonia nitrogen and calculate the amount of un-ionized ammonia whenever test results fail to meet effluent limitations.

# b. Conditions Triggering Accelerated Monitoring

- i. Average Monthly Effluent Limitation Exceedance. If the results from two consecutive samples of a constituent monitored in a particular month exceed the average monthly effluent limitation for any parameter (or if the required sampling frequency is once per month or less and the monthly sample exceeds the average monthly effluent limitation), the Discharger shall, within 24 hours after the results are received, increase its sampling frequency to daily until the results from the additional sampling show that the parameter complies with the average monthly effluent limitation.
- **ii. Maximum Daily Effluent Limitation Exceedance.** If a sample result exceeds a maximum daily effluent limitation, the Discharger shall, within 24 hours after the result is received, increase its sampling frequency to daily until the results from two samples collected on consecutive days show compliance with the maximum daily effluent limitation.
- iii. Acute Toxicity. If final or intermediate results of an acute bioassay indicate a violation or threatened violation (e.g., the percentage of surviving test organisms of any single acute bioassay is less than 70 percent), the Discharger shall initiate a new test as soon as practical or as described in applicable State Water Board plan provisions that become effective after adoption of these Regional Standard Provisions. The Discharger shall investigate the cause of the mortalities and report its findings in the next self-monitoring report.
- iv. Chlorine. The Discharger shall calibrate chlorine residual analyzers against grab samples as frequently as necessary to maintain accurate control and reliable operation. If an effluent violation is detected, the Discharger shall collect grab samples at least every 30 minutes until compliance with the limitation is achieved, unless the Discharger monitors chlorine residual continuously. In such cases, the Discharger shall continue to conduct continuous monitoring.

- reatment facility, it shall monitor flows and collect samples at affected discharge points and analyze samples for all constituents with effluent limitations on a daily basis for the duration of the bypass. The Discharger need not accelerate chronic toxicity monitoring. The Discharger also need not collect and analyze samples for mercury, dioxin-TEQ, and PCBs after the first day of the bypass. The Discharger may satisfy the accelerated acute toxicity monitoring requirement by conducting a flow-through test or static renewal test that captures the duration of the bypass (regardless of the method specified in the MRP). If bypassing disinfection units only, the Discharger shall only monitor bacteria indicators daily.
  - (a) Bypass for Essential Maintenance. If a Discharger bypasses a treatment unit for essential maintenance pursuant to Attachment D section I.G.2, the Executive Officer may reduce the accelerated monitoring requirements above if the Discharger (i) monitors effluent at affected discharge points on the first day of the bypass for all constituents with effluent limitations, except chronic toxicity; and (ii) identifies and implements measures to ensure that the bypass will continue to comply with effluent limitations.
  - (b) Approved Wet Weather Bypasses. If a Discharger bypasses a treatment unit or permitted outfall during wet weather with Executive Officer approval pursuant to Attachment D section I.G.4, the Discharger shall monitor flows and collect and retain samples for affected discharge points on a daily basis for the duration of the bypass. The Discharger shall analyze daily for TSS using 24-hour composites (or more frequent increments) and for bacteria indicators with effluent limitations using grab samples. If TSS exceeds 45 mg/L in any composite sample, the Discharger shall also analyze daily the retained samples for all other constituents with effluent limitations, except oil and grease, mercury, PCBs, dioxin-TEQ, and acute and chronic toxicity. Additionally, at least once each year, the Discharger shall analyze the retained samples for one approved bypass for all other constituents with effluent limitations, except oil and grease, mercury, PCBs, dioxin-TEQ, and acute and chronic toxicity. This monitoring shall be in addition to the minimum monitoring specified in the MRP.

# **B. Standard Observations** – Addition to Attachment D

- 1. Receiving Water Observations. The following requirements only apply when the MRP requires standard observations of receiving waters. Standard observations shall include the following:
  - **a.** Floating and Suspended Materials (e.g., oil, grease, algae, and other macroscopic particulate matter) presence or absence, source, and size of affected area.
  - **b.** Discoloration and Turbidity color, source, and size of affected area.
  - **c. Odor** presence or absence, characterization, source, and distance of travel.
  - **d. Beneficial Water Use** estimated number of water-associated waterfowl or wildlife, fisherpeople, and other recreational activities.

- **e. Hydrographic Condition** time and height of high and low tides (corrected to nearest National Oceanic and Atmospheric Administration location for the sampling date and time).
- **f.** Weather Conditions wind direction, air temperature, and total precipitation during five days prior to observation.
- **2. Wastewater Effluent Observations.** The following requirements only apply when the MRP requires standard observations of wastewater effluent. Standard observations shall include the following:
  - **a.** Floating and Suspended Material of Wastewater Origin (e.g., oil, grease, algae, and other macroscopic particulate matter) presence or absence.
  - **b.** Odor presence or absence, characterization, source, distance of travel, and wind direction.
- **3. Beach and Shoreline Observations.** The following requirements only apply when the MRP requires standard observations of beaches or shorelines. Standard observations shall include the following:
  - **a. Material of Wastewater Origin** presence or absence, description of material, estimated size of affected area, and source.
  - **b. Beneficial Use** estimate of number of people participating in recreational water contact, non-water contact, and fishing activities.
- **4.** Waste Treatment and/or Disposal Facility Periphery Observations. The following requirements only apply when the MRP requires standard observations of the periphery of waste treatment or disposal facilities. Standard observations shall include the following:
  - **a.** Odor presence or absence, characterization, source, and distance of travel.
  - **b.** Weather Conditions wind direction and estimated velocity.

# IV. STANDARD PROVISIONS – RECORDS

A. Records to be Maintained – Supplement to Attachment D, Provision IV.A

The Discharger shall maintain records in a manner and at a location (e.g., the wastewater treatment plant or the Discharger's offices) such that the records are accessible to Regional Water Board staff. The minimum retention period specified in Attachment D, Provision IV, shall be extended during the course of any unresolved litigation regarding permit-related discharges, or when requested by Regional Water Board or U.S. EPA, Region IX, staff.

A copy of the permit shall be maintained at the discharge facility and be available at all times to operating personnel.

# **B.** Records of Monitoring – Supplement to Attachment D, Provision IV.B

Monitoring records shall include the following:

- **1. Analytical Information.** Records shall include analytical method detection limits, minimum levels, reporting levels, and related quantification parameters.
- **2. Disinfection Process.** For the disinfection process, records shall include the following:
  - **a.** For bacteriological analyses:
    - i. Wastewater flow rate at the time of sample collection; and
    - **ii.** Required statistical parameters for cumulative bacterial values (e.g., moving median or geometric mean for the number of samples or sampling period identified in the MRP).
  - **b.** For the chlorination process (when chlorine is used for disinfection), at least daily average values for the following:
    - i. Chlorine residual of treated wastewater as it enters the chlorine contact basin (mg/L);
    - ii. Chlorine dosage (kg/day); and
    - iii. Dechlorination chemical dosage (kg/day).
- **3.** Wastewater Treatment Process Solids. For each treatment unit process that involves solids removal from the wastewater stream, records shall include the following:
  - **a.** Total volume or mass of solids removed from each collection unit (e.g., grit, skimmings, undigested biosolids, or combination) for each calendar month or other time period as appropriate, but not to exceed annually; and
  - **b.** Final disposition of such solids (e.g., landfill, other subsequent treatment unit).
- **4. Treatment Process Bypasses.** For all treatment process bypasses, including wet weather blending, records shall include the following:
  - **a.** Chronological log of treatment process bypasses;
  - **b.** Identification of treatment processes bypassed;
  - **c.** Beginning and ending dates and times of bypasses;
  - d. Bypass durations;
  - e. Estimated bypass volumes; and
  - **f.** Description of, or reference to other reports describing, the bypasses, their cause, the corrective actions taken (except for wet weather blending explicitly approved within the permit and in compliance with any related permit conditions), and any additional monitoring conducted.

- **5. Treatment Plant Overflows.** The Discharger shall retain a chronological log of overflows at the treatment plant, including the headworks and all units and appurtenances downstream, and records supporting the information provided in accordance with Provision V.E.2, below.

- C. Monitoring Reports Supplement to Attachment D, Provision V.C
  - 1. **Self-Monitoring Reports.** For each reporting period established in the MRP, the Discharger shall submit a self-monitoring report to the Regional Water Board in accordance with the requirements listed in the MRP and below:
    - **a. Transmittal Letter.** Each self-monitoring report shall be submitted with a transmittal letter that includes the following:
      - i. Identification of all violations of effluent limitations or other waste discharge requirements found during the reporting period;
      - **ii.** Details regarding the violations, such as parameters, magnitude, test results, frequency, and dates;
      - iii. Causes of the violations;
      - **iv.** Corrective actions taken or planned to resolve violations and prevent recurrences, and dates or time schedules for implementation (the Discharger may refer to previously submitted reports that address the corrective actions);
      - v. Explanation for any data invalidation. Data should not be submitted in a self-monitoring report if it does not meet quality assurance/quality control standards. However, if the Discharger wishes to invalidate a measurement after submitting it in a self-monitoring report, the Discharger shall identify the measurement suspected to be invalid and state the Discharger's intent to submit, within 60 days, a formal request to invalidate the measurement. The formal request shall include the original measurement in question, the reason for invalidating the measurement, all relevant documentation that supports invalidation (e.g., laboratory sheet, log entry, test results), and a discussion of the corrective actions taken or planned (with a time schedule for completion) to prevent recurrence of the sampling or measurement problem;

- **vi.** Description of blending, if any. If the Discharger blends, it shall describe the duration of blending events and certify whether the blending complied with all conditions for blending;
- **vii.** Description of other bypasses, if any. If the Discharger bypasses any treatment units (other than blending), it shall describe the duration of the bypasses and effluent quality during those times; and
- **viii.** Signature. The transmittal letter shall be signed in accordance with Attachment D, Provision V.B.
- **b.** Compliance Evaluation Summary. Each self-monitoring report shall include a compliance evaluation summary that addresses each parameter for which the permit specifies effluent limitations, the number of samples taken during the monitoring period, and the number of samples that exceed the effluent limitations.
- **c. More Frequent Monitoring.** If the Discharger monitors any pollutant more frequently than required by the MRP, the Discharger shall include the results of such monitoring in the calculation and reporting of the data submitted in the self-monitoring report.

# d. Analysis Results

- **i. Tabulation.** Each self-monitoring report shall include tabulations of all required analyses and observations, including parameters, dates, times, sample stations, types of samples, test results, method detection limits, method minimum levels, and method reporting levels (if applicable), signed by the laboratory director or other responsible official.
- **ii. Multiple Samples.** Unless the MRP specifies otherwise, when determining compliance with effluent limitations (other than instantaneous effluent limitations) and more than one sample result is available, the Discharger shall compute the arithmetic mean. If the data set contains one or more results that are "Detected, but Not Quantified (DNQ) or "Not Detected" (ND), the Discharger shall instead compute the median in accordance with the following procedure:
  - (a) The data set shall be ranked from low to high, reported ND determinations lowest, DNQ determinations next, followed by quantified values (if any). The order of the individual ND or DNQ determinations is unimportant.
  - (b) The median of the data set shall be determined. If the data set has an odd number of data points, the median is the middle value. If the data set has an even number of data points, the median is the average of the two values around the middle, unless one or both of these values is ND or DNQ, in which case the median shall be the lower of the two results (where DNQ is lower than a quantified value and ND is lower than DNQ).
- **iii. Duplicate Samples.** The Discharger shall report the average of duplicate sample analyses when reporting for a single sample result (or the median if one or more of the duplicates is DNQ or ND [see Provision V.C.1.c.ii, above]). For bacteria indicators, the Discharger shall report the geometric mean of the duplicate analyses.

iv. Dioxin-TEQ. The Discharger shall report for each dioxin and furan congener the analytical results of effluent monitoring, including the reporting level, the method detection limit, and the measured concentration. The Discharger shall report all measured values of individual congeners, including data qualifiers. When calculating dioxin-TEQ, the Discharger shall set congener concentrations below the minimum levels (MLs) to zero. The Discharger shall calculate and report dioxin-TEQ using the following formula, where the MLs, toxicity equivalency factors (TEFs), and bioaccumulation equivalency factors (BEFs) are as provided in Table A:

e. Results Not Yet Available. The Discharger shall make all reasonable efforts to obtain analytical data for required parameter sampling in a timely manner. Certain analyses may require additional time to complete analytical processes and report results. In these cases, the Discharger shall describe the circumstances in the self-monitoring report and include the data for these parameters and relevant discussions of any violations in the next self-monitoring report due after the results are available.

- **f. Annual Self-Monitoring Reports.** By the date specified in the MRP, the Discharger shall submit an annual self-monitoring report covering the previous calendar year. The report shall contain the following:
  - i. Comprehensive discussion of treatment plant performance, including documentation of any blending or other bypass events, and compliance with the permit. This discussion shall include any corrective actions taken or planned, such as changes to facility equipment or operation practices that may be needed to achieve compliance, and any other actions taken or planned that are intended to improve the performance and reliability of wastewater collection, treatment, or disposal practices;
  - ii. List of approved analyses, including the following:
    - (a) List of analyses for which the Discharger is certified;
    - (b) List of analyses performed for the Discharger by a separate certified laboratory (copies of reports signed by the laboratory director of that laboratory need not be submitted but shall be retained onsite); and
    - (c) List of "waived" analyses, as approved;
  - **iii.** Plan view drawing or map showing the Discharger's facility, flow routing, and sampling and observation station locations; and
  - iv. Results of facility report reviews. The Discharger shall regularly review, revise, and update, as necessary, the Operation and Maintenance Manual, Contingency Plan, Spill Prevention Plan, and Wastewater Facilities Status Report so these documents remain useful and relevant to current practices. At a minimum, reviews shall be conducted annually. The Discharger shall describe or summarize its review and evaluation procedures, recommended or planned actions, and estimated time schedule for implementing these actions. The Discharger shall complete changes to these documents to ensure that they remain up-to-date.
- **D.** Compliance Schedules Not supplemented
- **E.** Twenty-Four Hour Reporting Supplement to Attachment D, Provision V.E
  - 1. Oil or Other Hazardous Material Spills
    - **a.** Within 24 hours of becoming aware of a spill of oil or other hazardous material not contained onsite and completely cleaned up, the Discharger shall report as follows:
      - i. If the spill exceeds reportable quantities for hazardous materials listed in 40 C.F.R. part 302. The Discharger shall call the California Office of Emergency Services (800-852-7550).
      - **ii.** If the spill does not exceed reportable quantities for hazardous materials listed in 40 C.F.R., part 302, the Discharger shall call the Regional Water Board (510-622-2369).

- **b.** The Discharger shall submit a written report to the Regional Water Board within five working days following either of the above telephone notifications unless directed otherwise by Regional Water Board staff. A report submitted electronically is acceptable. The written report shall include the following:
  - i. Date and time of spill, and duration if known;
  - ii. Location of spill (street address or description of location);
  - iii. Nature of material spilled;
  - iv. Quantity of material spilled;
  - v. Receiving water body affected, if any;
  - vi. Cause of spill;
  - vii. Estimated size of affected area;
  - viii. Observed impacts to receiving waters (e.g., oil sheen, fish kill, water discoloration);
  - ix. Corrective actions taken to contain, minimize, or clean up the spill;
  - **x.** Future corrective actions planned to prevent recurrence, and implementation schedule; and
  - xi. Persons or agencies notified.

## 2. Unauthorized Municipal Wastewater Treatment Plant Discharges<sup>1</sup>

- **a. Two-Hour Notification.** For any unauthorized discharge that enters a drainage channel or surface water, the Discharger shall, as soon as possible, but not later than two hours after becoming aware of the discharge, notify the California Office of Emergency Services (800-852-7550) and the local health officer or director of environmental health with jurisdiction over the affected water body. Notification shall include the following:
  - i. Incident description and cause;
  - ii. Location of threatened or involved waterways or storm drains;
  - iii. Date and time that the unauthorized discharge started;
  - **iv.** Estimated quantity and duration of the unauthorized discharge (to the extent known), and estimated amount recovered:

California Code of Regulations, Title 23, section 2250(b), defines an unauthorized discharge to be a discharge, not regulated by waste discharge requirements, of treated, partially-treated, or untreated wastewater resulting from the intentional or unintentional diversion of wastewater from a collection, treatment, or disposal system.

- **v.** Level of treatment prior to discharge (e.g., raw wastewater, primary-treated wastewater, or undisinfected secondary-treated wastewater); and
- vi. Identity of person reporting the unauthorized discharge.
- **b. Five-Day Written Report.** Within five business days following the two-hour notification, the Discharger shall submit a written report that includes, in addition to the information listed in Provision V.E.2.a, above, the following:
  - i. Methods used to delineate the geographical extent of the unauthorized discharge within receiving waters;
  - ii. Efforts implemented to minimize public exposure to the unauthorized discharge;
  - **iii.** Visual observations of the impacts (if any) noted in the receiving waters (e.g., fish kill, discoloration of receiving water) and extent of sampling if conducted;
  - iv. Corrective measures taken to minimize the impact of the unauthorized discharge;
  - **v.** Measures to be taken to minimize the potential for a similar unauthorized discharge in the future;
  - vi. Summary of Spill Prevention Plan or Operation and Maintenance Manual modifications to be made, if necessary, to minimize the potential for future unauthorized discharges; and
  - vii. Quantity and duration of the unauthorized discharge, and the amount recovered.

#### VIII. DEFINITIONS – Addition to Attachment D

More definitions can be found in Attachment A of this NPDES Permit.

#### A. Arithmetic Calculations –

**1. Geometric Mean**. The antilog of the log mean or the back-transformed mean of the logarithmically transformed variables, which is equivalent to the multiplication of the antilogarithms. The geometric mean can be calculated with either of the following equations:

Where "N" is the number of data points for the period analyzed and "C" is the concentration for each of the "N" data points.

**3. Mass Emission Rate.** The rate of discharge expressed in mass. The mass emission rate is obtained from the following calculation for any calendar day:

Mass emission rate (lb/day) = 
$$\frac{8.345}{N} \sum_{i=1}^{N} Q_i C_i$$

Mass emission rate (kg/day) = 
$$\frac{3.785}{N} \sum_{i=1}^{N} Q_i C_i$$

In which "N" is the number of samples analyzed in any calendar day and "Q<sub>i</sub>" and "C<sub>i</sub>" are the flow rate (MGD) and the constituent concentration (mg/L) associated with each of the "N" grab samples that may be taken in any calendar day. If a composite sample is taken, "C<sub>i</sub>" is the concentration measured in the composite sample and "Q<sub>i</sub>" is the average flow rate occurring during the period over which the samples are composited. The daily concentration of a constituent measured over any calendar day shall be determined from the flow-weighted average of the same constituent in the combined waste streams as follows:

= Average daily concentration =  $\frac{1}{Q_i} \sum_{i=1}^{N} Q_i C_i$ 

In which "N" is the number of component waste streams and "Q" and "C" are the flow rate (MGD) and the constituent concentration (mg/L) associated with each of the "N" waste streams. " $Q_t$ " is the total flow rate of the combined waste streams.

**4. Removal Efficiency.** The ratio of pollutants removed by the treatment facilities to pollutants entering the treatment facilities (expressed as a percentage). The Discharger shall determine removal efficiencies using monthly averages (by calendar month unless otherwise specified) of pollutant concentration of influent and effluent samples collected at about the same time and using the following equation (or its equivalent):

Removal Efficiency (%) =  $100 \times [1-(Effluent Concentration/Influent Concentration)]$ 

- **B. Blending** the practice of bypassing biological treatment units and recombining the bypass wastewater with biologically-treated wastewater.
- C. Composite Sample a sample composed of individual grab samples collected manually or by an automatic sampling device on the basis of time or flow as specified in the MRP. For flow-based composites, the proportion of each grab sample included in the composite sample shall be within plus or minus five percent (+/-5%) of the representative flow of the waste stream being measured at the time of grab sample collection. Alternatively, equal volume grab samples may be individually analyzed with the flow-weighted average calculated by averaging flow-weighted ratios of each grab sample analytical result. Grab samples comprising time-based composite samples shall be collected at intervals not greater than those specified in the MRP. The quantity of each grab sample comprising a time-based composite sample shall be a set of flow proportional volumes as specified in the MRP. If a particular time-based or flow-based composite sampling protocol is not specified in the MRP, the Discharger shall determine and implement the most representative protocol.
- **D. Duplicate Sample** a second sample taken from the same source and at the same time as an initial sample (such samples are typically analyzed identically to measure analytical variability).
- **E. Grab Sample** an individual sample collected during a short period not exceeding 15 minutes. Grab samples represent only the condition that exists at the time the sample is collected.
- **F. Overflow** the intentional or unintentional spilling or forcing out of untreated or partially-treated waste from a transport system (e.g., through manholes, at pump stations, or at collection points) upstream of the treatment plant headworks or from any part of a treatment plant.
- **G. Priority Pollutants** those constituents referred to in 40 C.F.R. part 122 as promulgated in the Federal Register, Vol. 65, No. 97, Thursday, May 18, 2000, also known as the California Toxics Rule.
- **H.** Untreated waste raw wastewater.

## **Attachment H: Pretreatment Program Provisions**

**A.** The Discharger shall be responsible and liable for the performance of all Control Authority pretreatment requirements contained in 40 CFR 403, including any regulatory revisions to Part 403. Where a Part 403 revision is promulgated after the effective date of the Discharger's permit and places mandatory actions upon the Discharger as Control Authority but does not specify a timetable for completion of the actions, the Discharger shall complete the required actions within six months from the issuance date of this permit or six months from the effective date of the Part 403 revisions, whichever comes later.

(If the Discharger cannot complete the required actions within the above six-month period due to the need to process local adoption of sewer use ordinance modifications or other substantial pretreatment program modifications, the Discharger shall notify the Executive Officer in writing at least 60 days prior to the six-month deadline. The written notification shall include a summary of completed required actions, an explanation for why the six month deadline cannot be met, and a proposed timeframe to complete the rest of the required actions as soon as practical but not later than within twelve months of the issuance date of this permit or twelve months of the effective date of the Part 403 revisions, whichever comes later. The Executive Officer will notify the Discharger in writing within 30 days of receiving the request if the extension is not approved.)

The United States Environmental Protection Agency (U.S. EPA), the State and/or other appropriate parties may initiate enforcement action against a nondomestic user for noncompliance with applicable standards and requirements as provided in the Clean Water Act (Act).

- **B.** The Discharger shall enforce the requirements promulgated under Sections 307(b), 307(c), 307(d) and 402(b) of the Act with timely, appropriate and effective enforcement actions. The Discharger shall cause nondomestic users subject to Federal Categorical Standards to achieve compliance no later than the date specified in those requirements or, in the case of a new nondomestic user, upon commencement of the discharge.
- **C.** The Discharger shall perform the pretreatment functions as required in 40 CFR 403 and amendments or modifications thereto including, but not limited to:
  - 1. Implement the necessary legal authorities to fully implement the pretreatment regulations as provided in 40 CFR 403.8(f)(1);
  - 2. Implement the programmatic functions as provided in 40 CFR 403.8(f)(2);
  - **3.** Publish an annual list of nondomestic users in significant noncompliance as provided per 40 CFR 403.8(f)(2)(viii);
  - **4.** Provide for the requisite funding and personnel to implement the pretreatment program as provided in 40 CFR 403.8(f)(3); and
  - **5.** Enforce the national pretreatment standards for prohibited discharges and categorical standards as provided in 40 CFR 403.5 and 403.6, respectively.

- **D.** The Discharger shall submit annually a report to U.S. EPA Region 9, the State Water Board and the Regional Water Board describing its pretreatment program activities over the previous calendar year. In the event that the Discharger is not in compliance with any conditions or requirements of the Pretreatment Program, the Discharger shall also include the reasons for noncompliance and a plan and schedule for achieving compliance. The report shall contain, but is not limited to, the information specified in Appendix H-1 entitled, "Requirements for Pretreatment Annual Reports." The annual report is due each year on February 28.
- E. The Discharger shall submit a pretreatment semiannual report to U.S. EPA Region 9, the State Water Board and the Regional Water Board describing the status of its significant industrial users (SIUs). The report shall contain, but is not limited to, information specified in Appendix H-2 entitled, "Requirements for Pretreatment Semiannual Reports." The semiannual report is due July 31 for the period January through June. The information for the period July through December of each year shall be included in the Annual Report identified in Appendix H-1. The Executive Officer may exempt the Discharger from the semiannual reporting requirements on a case by case basis subject to State Water Board and U.S. EPA's comment and approval.
- **F.** The Discharger shall conduct the monitoring of its treatment plant's influent, effluent, and sludge (biosolids) as described in Appendix H-4 entitled, "Requirements for Influent, Effluent and Sludge (Biosolids) Monitoring." (The term "biosolids," as used in this Attachment, shall have the same meaning as wastewater treatment plant "sludge" and will be used from this point forward.) The Discharger shall evaluate the results of the sampling and analysis during the preparation of the semiannual and annual reports to identify any trends. Signing the certification statement used to transmit the reports shall be deemed to certify the Discharger has completed this data evaluation. A tabulation of the data shall be included in the pretreatment annual report as specified in Appendix H-4. The Executive Officer may require more or less frequent monitoring on a case by case basis.

#### **APPENDIX H-1**

## REQUIREMENTS FOR PRETREATMENT ANNUAL REPORTS

The Pretreatment Annual Report is due each year on February 28 and shall contain activities conducted during the previous calendar year. The purpose of the Annual Report is to:

- Describe the status of the Discharger's pretreatment program; and
- Report on the effectiveness of the program, as determined by comparing the results of the preceding year's program implementation.

The report shall contain, at a minimum, the following information:

#### A. Cover Sheet

The cover sheet shall include:

- 1. The name(s) and National Pollutant Discharge Elimination Discharge System (NPDES) permit number(s) of the Discharger(s) that is part of the Pretreatment Program;
- 2. The name, address and telephone number of a pretreatment contact person;
- **3.** The period covered in the report;
- **4.** A statement of truthfulness; and
- 5. The dated signature of a principal executive officer, ranking elected official, or other duly authorized employee who is responsible for overall operation of the publicly-owned treatment works (POTW) (40 CFR 403.12(m)).

#### **B.** Introduction

This section shall include:

- 1. Any pertinent background information related to the Discharger and/or the nondomestic user base of the area;
- 2. List of applicable interagency agreements used to implement the Discharger's pretreatment program (e.g., Memoranda of Understanding (MOU) with satellite sanitary sewer collection systems); and
- **3.** A status summary of the tasks required by a Pretreatment Compliance Inspection (PCI), Pretreatment Compliance Audit (PCA), Cleanup and Abatement Order (CAO), or other pretreatment-related enforcement actions required by the Regional Water Board or the U.S. EPA. A more detailed discussion can be referenced and included in the section entitled, "Program Changes," if needed.

#### C. Definitions

This section shall include a list of key terms and their definitions that the Discharger uses to describe or characterize elements of its pretreatment program, or the Discharger may provide a reference to its website if the applicable definitions are available on-line.

#### D. Discussion of Upset, Interference and Pass Through

This section shall include a discussion of Upset, Interference or Pass Through incidents, if any, at the Discharger's treatment plant(s) that the Discharger knows of or suspects were caused by nondomestic user discharges. Each incident shall be described, at a minimum, consisting of the following information:

- 1. A description of what occurred;
- 2. A description of what was done to identify the source;
- **3.** The name and address of the nondomestic user responsible;
- **4.** The reason(s) why the incident occurred;
- **5.** A description of the corrective actions taken; and
- **6.** An examination of the local and federal discharge limits and requirements for the purposes of determining whether any additional limits or changes to existing requirements may be necessary to prevent other Upset, Interference or Pass Through incidents.

#### E. Influent, Effluent and Biosolids Monitoring Results

The Discharger shall evaluate the influent, effluent and biosolids monitoring results as specified in Appendix H-4 in preparation of this report. The Discharger shall retain the analytical laboratory reports with the Quality Assurance and Quality Control (QA/QC) data validation and make these reports available upon request.

This section shall include:

- **1.** Description of the sampling procedures and an analysis of the results (see Appendix H-4 for specific requirements);
- **2.** Tabular summary of the compounds detected (compounds measured above the detection limit for the analytical method used) for the monitoring data generated during the reporting year as specified in Appendix H-4;
- **3.** Discussion of the investigation findings into any contributing sources of the compounds that exceed NPDES limits; and
- **4.** Graphical representation of the influent and effluent metal monitoring data for the past five years with a discussion of any trends.

#### F. Inspection, Sampling and Enforcement Programs

This section shall include at a minimum the following information:

- 1. Inspections: Summary of the inspection program (e.g., criteria for determining the frequency of inspections and inspection procedures);
- **2.** Sampling Events: Summary of the sampling program (e.g., criteria for determining the frequency of sampling and chain of custody procedures); and
- **3.** Enforcement: Summary of Enforcement Response Plan (ERP) implementation including dates for adoption, last revision and submission to the Regional Water Board.

#### G. Updated List of Regulated SIUs

This section shall contain a list of all of the federal categories that apply to SIUs regulated by the Discharger. The specific categories shall be listed including the applicable 40 CFR subpart and section, and pretreatment standards (both maximum and average limits). Local limits developed by the Discharger shall be presented in a table including the applicability of the local limits to SIUs. If local limits do not apply uniformly to SIUs, specify the applicability in the tables listing the categorical industrial users (CIUs) and non-categorical SIUs.   - f. Information, calculations and data used to determine the limits for those CIUs for which a combined waste stream formula is applied.
- 2. Non-categorical SIUs Include a table that alphabetically lists the SIUs not subject to any federal categorical standards that were regulated by the Discharger as of the end of the reporting period. This list shall include:
  - a. Name;

- b. Address;
- c. A brief description of the type of business;
- d. Identify all deletions and additions keyed to the list submitted in the previous annual report. All deletions shall be briefly explained (e.g., closure, name change, ownership change, reclassification, declassification); and
- e. Indicate the applicable discharge limits (e.g., different from local limits) to which the SIUs are subject and reference to the location where the applicable limits (e.g., local discharge limits) are presented in the report.

#### H. SIU (categorical and non-categorical) Compliance Activities

## J. Pretreatment Program Changes

This section shall contain a description of any significant changes in the Pretreatment Program during the past year including, but not limited to:

- 1. Legal authority;
- 2. Local limits;
- 3. Monitoring/inspection program and frequency;
- 4. Enforcement protocol;
- 5. Program's administrative structure;
- 6. Staffing level;
- 7. Resource requirements;
- 8. Funding mechanism;
- 9. If the manager of the Discharger's pretreatment program changed, a revised organizational chart shall be included; and
- 10. If any element(s) of the program is in the process of being modified, this intention shall also be indicated.

## K. Pretreatment Program Budget

This section shall present the budget spent on the Pretreatment Program. The budget, either by the calendar or fiscal year, shall show the total expenses required to implement the pretreatment program. A brief discussion of the source(s) of funding shall be provided. In addition, the Discharger shall make available upon request specific details on its pretreatment program expense amounts such as for personnel, equipment, and chemical analyses.

## L. Public Participation Summary

This section shall include a copy of the public notice as required in 40 CFR 403.8(f)(2)(viii). If a notice was not published, the reason shall be stated.

## M. Biosolids Storage and Disposal Practice

This section shall describe how treated biosolids are stored and ultimately disposed. If a biosolids storage area is used, it shall be described in detail including its location, containment features and biosolids handling procedures.

#### N. Other Pollutant Reduction Activities

This section shall include a brief description of any programs the Discharger implements to reduce pollutants from nondomestic users that are not classified as SIUs. If the Discharger submits any of this program information in an Annual Pollution Prevention Report, reference to this other report shall satisfy this reporting requirement.

## O. Other Subjects

Other information related to the Pretreatment Program that does not fit into any of the above categories should be included in this section.

## P. Permit Compliance System (PCS) Data Entry Form

The annual report shall include the PCS Data Entry Form. This form shall summarize the enforcement actions taken against SIUs in the past year. This form shall include the following information:

- 1. Discharger's name,
- 2. NPDES Permit number,
- 3. Period covered by the report,
- 4. Number of SIUs in significant noncompliance (SNC) that are on a pretreatment compliance schedule.
- 5. Number of notices of violation and administrative Orders issued against SIUs,
- 6. Number of civil and criminal judicial actions against SIUs,
- 7. Number of SIUs that have been published as a result of being in SNC, and
- 8. Number of SIUs from which penalties have been collected.

#### **APPENDIX H-2**

## REQUIREMENTS FOR JANUARY-JUNE PRETREATMENT SEMIANNUAL REPORT

The pretreatment semiannual report is due on July 31 for pretreatment program activities conducted from January through June unless an exception has been granted by the Regional Water Board's Executive Officer (e.g., pretreatment programs without any SIUs may qualify for an exception to the pretreatment semiannual report). Pretreatment activities conducted from July through December of each year shall be included in the Pretreatment Annual Report as specified in Appendix H-1. The pretreatment semiannual report shall contain, at a minimum the following information:

## A. Influent, Effluent and Biosolids Monitoring

The influent, effluent and biosolids monitoring results shall be evaluated in preparation of this report. The Discharger shall retain analytical laboratory reports with the QA/QC data validation and make these reports available upon request. The Discharger shall also make available upon request a description of its influent, effluent and biosolids sampling procedures. Violations of any parameter that exceed NPDES limits shall be identified and reported. The contributing source(s) of the parameters that exceed NPDES limits shall be investigated and discussed.

## B. Significant Industrial User (SIU) Compliance Status

This section shall contain a list of all SIUs that were not in consistent compliance with all pretreatment standards/limits or requirements for the reporting period. For the reported SIUs, the compliance status for the previous semiannual reporting period shall be included. Once the SIU has determined to be out of compliance, the SIU shall be included in subsequent reports until consistent compliance has been achieved. A brief description detailing the actions that the SIU undertook to come back into compliance shall be provided.

For each SIU on the list, the following information shall be provided:

- 1. Name and facility address of the SIU;
- 2. Indicate if the SIU is subject to Federal Categorical Standards; if so, specify the category including the subpart that applies;
- 3. For SIUs subject to Federal Categorical Standards, indicate if the violation is of a categorical or local standard:
- 4. Indicate the compliance status of the SIU for the two quarters of the reporting period; and
- 5. For violations/noncompliance identified in the reporting period, provide:
  - a. The date(s) of violation(s);
  - b. The parameters and corresponding concentrations exceeding the limits and the discharge limits for these parameters; and

c. A brief summary of the noncompliant event(s) and the steps that are being taken to achieve compliance.

## C. Discharger's Compliance with Pretreatment Program Requirements

This section shall contain a discussion of the Discharger's compliance status with the Pretreatment Program Requirements as indicated in the latest Pretreatment Compliance Audit (PCA) Report or Pretreatment Compliance Inspection (PCI) Report. It shall contain a summary of the following information:

- 1. Date of latest PCA or PCI report;
- 2. Date of the Discharger's response;
- 3. List of unresolved issues; and
- 4. Plan(s) and schedule for resolving the remaining issues.

#### **APPENDIX H-3**

## SIGNATURE REQUIREMENTS FOR PRETREATMENT ANNUAL AND SEMIANNUAL REPORTS

The pretreatment annual and semiannual reports shall be signed by a principal executive officer, ranking elected official, or other duly authorized employee who is responsible for the overall operation of the Discharger (POTW - 40 CFR section 403.12[m]). Signed copies of the reports shall be submitted to the State Water Board and the Regional Water Board through the electronic self-monitoring report (eSMR) module of the California Integrated Water Quality System (CIWQS). Signed copies of the reports shall also be submitted electronically to U.S. EPA at R9Pretreatment@epa.gov or as instructed otherwise.

#### **APPENDIX H-4**

## REQUIREMENTS FOR INFLUENT, EFFLUENT AND BIOSOLIDS MONITORING

The Discharger shall conduct sampling of its treatment plant's influent, effluent and biosolids at the frequency shown in **the pretreatment requirements table** of the Monitoring and Reporting Program (MRP, Attachment E). When sampling periods coincide, one set of test results, reported separately, may be used for those parameters that are required to be monitored by both the influent and effluent monitoring requirements of the MRP and the Pretreatment Program. The Pretreatment Program monitoring reports as required in Appendices H-1 and H-2 shall be transmitted to the Pretreatment Program Coordinator.

## A. Reduction of Monitoring Frequency

The minimum frequency of Pretreatment Program influent, effluent, and biosolids monitoring shall be dependent on the number of SIUs identified in the Discharger's Pretreatment Program as indicated in Table H-1.

Number of SIUs	Minimum Frequency								
< 5	Once every five years								
> 5 and $< 50$	Once every year

If the Discharger's required monitoring frequency is greater than the minimum specified in Table H-1, the Discharger may request a reduced monitoring frequency for that constituent(s) as part of its application for permit reissuance if it meets the following criteria:

The monitoring data for the constituent(s) consistently show non-detect (ND) levels for the effluent monitoring and very low (i.e., near ND) levels for influent and biosolids monitoring for a minimum of eight previous years' worth of data.

The Discharger's request shall include tabular summaries of the data and a description of the trends in the industrial, commercial, and residential customers in the Discharger's service area that demonstrate control over the sources of the constituent(s). The Regional Water Board may grant a reduced monitoring frequency in the reissued permit after considering the information provided by the Discharger and any other relevant information.

## **B.** Influent and Effluent Monitoring

The Discharger shall monitor for the parameters using the required sampling and test methods listed in **the pretreatment table** of the MRP. Any test method substitutions must have received prior written Executive Officer approval. Influent and effluent sampling locations shall be the same as those sites specified in the MRP.

The influent and effluent samples should be taken at staggered times to account for treatment plant detention time. Appropriately staggered sampling is considered consistent with the requirement for

collection of effluent samples coincident with influent samples in Section III.A.3.a(2) of Attachment G. All samples must be representative of daily operations. Sampling and analysis shall be performed in accordance with the techniques prescribed in 40 CFR 136 and amendments thereto. For effluent monitoring, the reporting limits for the individual parameters shall be at or below the minimum levels (MLs) as stated in the Policy for Implementation of Toxics Standards for Inland Surface Waters, Enclosed Bays, and Estuaries of California (2000) [also known as the State Implementation Policy (SIP)]; any revisions to the MLs shall be adhered to. If a parameter does not have a stated ML, then the Discharger shall conduct the analysis using the lowest commercially available and reasonably achievable detection levels.

The following report elements should be used to submit the influent and effluent monitoring results. A similarly structured format may be used but will be subject to Regional Water Board approval. The monitoring reports shall be submitted with the Pretreatment Annual Report identified in Appendix H-1.

- 1. Sampling Procedures, Sample Dechlorination, Sample Compositing, and Data Validation (applicable quality assurance/quality control) shall be performed in accordance with the techniques prescribed in 40 CFR 136 and amendments thereto. The Discharger shall make available upon request its sampling procedures including methods of dechlorination, compositing, and data validation.
- 2. A tabulation of the test results for the detected parameters shall be provided.
- 3. Discussion of Results The report shall include a complete discussion of the test results for the detected parameters. If any pollutants are detected in sufficient concentration to upset, interfere or pass through plant operations, the type of pollutant(s) and potential source(s) shall be noted, along with a plan of action to control, eliminate, and/or monitor the pollutant(s). Any apparent generation and/or destruction of pollutants attributable to chlorination/dechlorination sampling and analysis practices shall be noted.

## C. Biosolids Monitoring

Biosolids should be sampled in a manner that will be representative of the biosolids generated from the influent and effluent monitoring events except as noted in (3. below. The same parameters required for influent and effluent analysis shall be included in the biosolids analysis. The biosolids analyzed shall be a composite sample of the biosolids for final disposal consisting of:

- 1. Biosolids lagoons -20 grab samples collected at representative equidistant intervals (grid pattern) and composited as a single grab, or
- 2. Dried stockpile -20 grab samples collected at various representative locations and depths and composited as a single grab, or
- 3. Dewatered biosolids daily composite of 4 representative grab samples each day for 5 days taken at equal intervals during the daily operating shift taken from a) the dewatering units or b) each truckload, and shall be combined into a single 5- day composite.

The U.S. EPA manual, POTW Sludge Sampling and Analysis Guidance Document, August 1989, containing detailed sampling protocols specific to biosolids is recommended as a guidance for sampling procedures. The U.S. EPA manual Analytical Methods of the National Sewage Sludge Survey, September 1990, containing detailed analytical protocols specific to biosolids, is recommended as a guidance for analytical methods.

In determining if the biosolids are a hazardous waste, the Discharger shall adhere to Article 2, "Criteria for Identifying the Characteristics of Hazardous Waste," and Article 3, "Characteristics of Hazardous Waste," of Title 22, California Code of Regulations, sections 66261.10 to 66261.24 and all amendments thereto.

The following report elements should be used to submit the biosolids monitoring results. A similarly structured form may be used but will be subject to Regional Water Board approval. The results shall be submitted with the Pretreatment Annual Report identified in Appendix H-1.

- Sampling Procedures and Data Validation (applicable quality assurance/quality control) shall be performed in accordance with the techniques prescribed in 40 CFR 136 and amendments thereto. The Discharger shall make available upon request its biosolids sampling procedures and data validation methods.
- Test Results Tabulate the test results for the detected parameters and include the percent solids.
- Discussion of Results Include a complete discussion of test results for the detected parameters. If the detected pollutant(s) is reasonably deemed to have an adverse effect on biosolids disposal, a plan of action to control, eliminate, and/or monitor the pollutant(s) and the known or potential source(s) shall be included. Any apparent generation and/or destruction of pollutants attributable to chlorination/dechlorination sampling and analysis practices shall be noted.

The Discharger shall also provide a summary table presenting any influent, effluent or biosolids monitoring data for non-priority pollutants that the Discharger believes may be causing or contributing to interference, pass through or adversely impacting biosolids quality.

#### Dear Mr. Mittal:

The City of South San Francisco (City) reviewed the Tentative Order (TO) NPDES Permit No. CA0038130 for the South San Francisco/San Bruno Water Quality Control Plant (WQCP) issued by the San Francisco Bay Regional Water Quality Control Board (Regional Water Board) on May 2, 2019. The following comments are submitted before the June 3, 2019, deadline for inclusion consideration in the final adopted NPDES permit for the WQCP. Requested revisions to the text of the TO, are shown as an <u>underline</u>. Suggested deletions are shown as <u>strikethrough</u>.

## Comment No. 1. City of South San Francisco Private Sewer Lateral Ordinance

The City understands the importance of having a <u>transfer of title</u> private sewer lateral (PSL) inspection ordinance to improve the condition of PSLs and reduce sources of inflow and infiltration into the publicly owned collection system. As written, the TO provides authorization for wet weather bypasses if the City implements a <u>transfer of title</u> PSL inspection ordinance by January 1, 2021. The City is committed to developing and proposing such an ordinance for adoption by September 1, 2020, as required by Task 4 of Table 5 (Specific Tasks to Reduce Wet Weather Bypasses). However, the City Council controls the adoption of an ordinance. Staff

will recommend implementation of a <u>revised PSL inspection</u> ordinance for adoption to the City Council. To account for a scenario where staff proposes a <u>transfer of title</u> PSL inspection ordinance to City Council, but the ordinance is not adopted or implemented by January 1, 2021, the City requests the following changes to the TO. With these changes, the conditions for wet weather bypass approval will be consistent with the requirements specified in Table 5.

## **Provision III.C.4 (Page 4)**

**4.** The City of San Bruno continues to implement a private sewer lateral inspection ordinance, and the City of South San Francisco implements proposes a private sewer lateral inspection ordinance for adoption by its City Council by January 1, 2021, September 1, 2020; and

## Provision VI.C.5.a., Table 5, Task 4 (Page 13)

## 4. Propose and Implement Private Sewer Lateral Ordinance for Adoption

Develop a private sewer lateral inspection ordinance for the City of South San Francisco based on a review of Bay Area communities that have successfully adopted measures requiring inspection of private sewer laterals (e.g., upon ownership change). The Discharger shall propose the draft ordinance for adoption by the City of South San Francisco City Council and notify the Regional Water Board at least 30 days before presenting the proposal to the City Council.

Compliance Date: September 1, 2020

## Provision IV.A.3. (Page F-12 to F-13)

- 3. Discharge Prohibition III.C (No bypass): This prohibition is based on 40 C.F.R. section 122.41(m) (see Attachment D § I.G). Bypass is prohibited; however, bypass is approved for the portion of the flow greater than the wet weather capacity subject to the following conditions: (1) the peak wet weather influent flow volume exceeds the wet weather capacity (currently 30 MGD); (2) the discharge complies with the Order's effluent and receiving water limitations; (3) the Discharger fully complies with Provision VI.C.5.a; (4) the City of San Bruno continues to implement a transfer of title private sewer lateral inspection ordinance, and the City of South San Francisco proposes implements a transfer of title private sewer lateral inspection ordinance for adoption by January 1, 2021 September 1, 2020; and the Facility is operated as designed and in accordance with the Operation and Maintenance Manual developed for the Facility (i.e., the Discharger must optimize storage and use of equalization units, and fully utilize the biological treatment units).
  - ...The City of South San Francisco <u>does not currently have a transfer of title private sewer lateral inspection program</u> to reduce wet weather infiltration and inflow from private sewer laterals within its service area. The City of San Bruno and many other jurisdictions have such an ordinance; therefore, it is feasible for the City of South San Francisco to adopt one as well. For this reason, the approval to bypass when blending is conditioned on the City of South San Francisco <u>implementing</u> proposing a private sewer lateral inspection ordinance <u>for adoption</u> by <u>January 1, 2021</u>, <u>September 1, 2020</u>.

## **Provision VI.C.5.a.** (Page F-32)

a. Specific Tasks to Reduce Wet Weather Bypasses. ... The Discharger will also minimize wet weather bypasses by implementing collection system improvements to reduce inflow and infiltration. Furthermore, this Order requires the City of South San Francisco to develop a <u>transfer of title</u> private sewer lateral ordinance based on a review of Bay Area communities that have successfully adopted measures requiring inspection of private sewer laterals (e.g., upon ownership change). The City of San Bruno and many other jurisdictions already have such an ordinance; therefore, a similar PSL ordinance is also feasible for staff to <u>propose</u> to the City Council for <u>adoption</u>...

#### Comment No. 2. NBSU Facilities Definition and Clarification

The TO covers operation of the WQCP, the City of South San Francisco collection system, the City of San Bruno collection system, and the North Bayside System Unit (NBSU) facilities as named in Table 1 (Discharger Information). The NBSU Agreement<sup>1</sup> describes the facilities owned by the NBSU and states that the City is responsible for the operation and maintenance of the NBSU facilities. The other NBSU members are responsible for the facilities that collect, treat, and deliver wastewater to the WQCP. The City requests the following revisions to the Fact Sheet to clarify ownership and ownership responsibilities for the various facilities associated with the NBSU system.

## **Provision I.A.** (Page F-4)

A. The cities of South San Francisco and San Bruno and the North Bayside System Unit (NBSU) (together, the Discharger) discharge treated wastewater into the deepwater channel of Lower San Francisco Bay. The cities of South San Francisco and San Bruno jointly own the Water Quality Control Plant, a publicly-owned treatment works. Operation and maintenance of the plant is the sole responsibility of the City of South San Francisco. Each city also owns and operates its own individual wastewater collection system. The plant provides secondary treatment of wastewater from the city of South San Francisco, city of San Bruno, the town of Colma, and minimal parts of the city of Daly City and discharges the effluent through the NBSU outfall force main.

The NBSU is a joint powers authority that includes the cities of Burlingame, Millbrae, South San Francisco, and San Bruno, and the San Francisco International Airport. The NBSU agencies share discharge capacity rights and own-and operate the outfall effluent force main, the combined effluent pumping station, the effluent dechlorination facilities, and the deepwater outfall. The City of South San Francisco is responsible for operations and maintenance of the NBSU effluent pumping facilities. The city of Burlingame, the city of Millbrae, and the San Francisco International Airport own and are responsible for operation and maintenance of their

treatment plants and the effluent force mains that transport treated wastewater to the South San Francisco/San Bruno Water Quality Control Plant. For this Order, the plant, the Discharger's collection systems, and the NBSU outfall force main, combined effluent pumping station, dechlorination facilities, and deepwater outfall are collectively referred to as the "Facility."

## Comment No. 3. References to Statewide General WDRs Order No. 2006-0003-DWQ

The TO requires the City of South San Francisco and the City of San Bruno to properly operate and maintain their respective collection systems. The demonstration is based on compliance with the Statewide General Waste Discharge Requirements (WDRs) for Sanitary Sewer Systems (Order No. 2006-0003-DWQ, as amended). The Statewide General WDRs were developed to implement state law, but are used to satisfy federal operations and maintenance requirements (Attachment D, Provision I.D.). The City requests the following revisions to ensure state law permit requirements are not incorporated by reference into a federally enforceable NPDES permit and for consistency with language provided in Fact Sheet Provision VI.C.4.c.

## **Provision VI.C.4.c.** (Page 12)

c. Collection System Management. ... State Water Board Order No. 2006-0003-DWQ, Statewide General Waste Discharge Requirements for Sanitary Sewer Systems, as amended by State Water Board Order No. WQ 2013-0058-EXEC (statewide WDRs), contains requirements for operation and maintenance of collection systems and for reporting and mitigating sanitary sewer overflows. While the Dischargers must separately comply with both the statewide WDRs and this Order, the statewide WDRs clearly and specifically stipulate requirements for operation and maintenance and for reporting and mitigating sanitary sewer overflows. Implementing the requirements for operation and maintenance and mitigation of sanitary sewer overflows shall satisfy the corresponding federal NPDES requirements specified in Attachment D and G of this Order for the collection systems.

## Comment No. 4. Cost Requirement for Sewer Rehabilitation Projects

The City will be conducting several high priority sewer rehabilitation projects during the upcoming permit term. However, due to major capital projects occurring at the WQCP during the same period, the City can't guarantee the collection system project costs will meet or exceed \$7.0 million. As a result, the City requests a lower cost requirement of \$5.0 million for sewer rehabilitation projects, as shown below.

## Provision VI.C.5.a., Table 5, Task 1 (Page 12)

#### 1. Rehabilitate High Priority Sewer Pipe

Complete \$7.0\\$5.0 million of sewer pipe rehabilitation and improvements on the wastewater collection systems. When rehabilitating a sewer pipe, the Discharger shall also rehabilitate, as needed, all associated maintenance holes and ensure that abandoned sewer laterals are not connected to the sewer main. The Discharger shall prioritize sewer pipe rehabilitation in areas known or suspected to have inflow and infiltration in accordance with the sewer master plan (task 5).

# Appendix C Response to Comments

## California Regional Water Quality Control Board San Francisco Bay Region

#### RESPONSE TO WRITTEN COMMENTS

On the Tentative Order for

South San Francisco / San Bruno Water Quality Control Plant and wastewater collection systems and North Bayside System Unit facilities

The Regional Water Board received written comments from the City of South San Francisco on a tentative order distributed for public comment. The comments are summarized below in *italics* (paraphrased for brevity) and are followed by a staff response. For the full content and context of the comments, please refer to the comment letter.

Revisions are shown with strikethrough for deletions and underline for additions.

**Comment 1:** The City requests that we specify that private sewer lateral ordinances apply to title transfers and that we require the City to propose, but not necessarily adopt, a private sewer lateral ordinance as a condition of the Regional Water Board approving bypasses of biological treatment during wet weather (i.e., blending).

#### Response

We agree with the City's suggestion that private sewer lateral ordinances should apply to title transfers and that the City should only be required to *propose* a private sewer lateral ordinance, not to *adopt* one. Table 5, Task 4, of the tentative order only requires the City to propose an ordinance. However, Discharge Prohibition III.C of the tentative order provides a benefit to the City if it chooses to adopt and implement an ordinance. Attachment D section I.G and 40 C.F.R. section 122.41(m) prohibits bypasses and allows the Regional Water Board to take enforcement, unless three conditions are met:

- a. Bypass is unavoidable to prevent loss of life, personal injury, or severe property damage;
- b. There are no feasible alternatives to bypass; and
- c. Notice of bypass is provided to the Regional Water Board.

The Regional Board considers implementation of a private sewer lateral ordinance, which will help to reduce inflow and infiltration, to be a feasible alternative to bypass. If the City adopts and implements an ordinance and completes the other tasks listed in Table 5, the Regional Water Board may find that the second condition is met. Discharge Prohibition III.C approves bypassing biological treatment units during peak wet weather provided all feasible alternatives have been implemented. As mentioned above, implementing, not merely adopting, an ordinance is a feasible measure the City can take to reduce or eliminate wet weather bypasses because it reduces infiltration and inflow from private sewer laterals, a significant contributor to the treatment plant's excessive wet weather flows. Many jurisdictions throughout the Region have already adopted and implemented ordinances. In fact, the City had also adopted one, but later rescinded it, which is evidence of its feasibility.

We revised Discharge Prohibition section III.C of the tentative order as follows (these revisions also remove an incorrect reference to advanced treatment):

Bypass of untreated or partially-treated wastewater to waters of the United States is prohibited, except as provided for in Attachment D section I.G of this Order.

Blended wastewater is biologically treated wastewater blended with wastewater diverted around biological treatment units or advanced treatment units. Such discharges are approved pursuant to 40 C.F.R. section 122.41(m)(4) and Attachment D section I.G.4 when the following conditions are met:

:

**4.** The City of San Bruno continues to implement a <u>transfer of title</u> private sewer lateral inspection ordinance, and the City of South San Francisco implements a <u>transfer of title</u> private sewer lateral inspection ordinance by January 1, 2021; and

:

We revised the Table 5, Task 4, as follows:

## **Propose and Implement Lateral Ordinances for Adoption**

Develop a <u>transfer of title</u> private sewer lateral inspection ordinance for the City of South San Francisco based on a review of Bay Area communities that have successfully adopted measures requiring inspection of private sewer laterals (e.g., upon ownership change). The Discharger shall propose the draft ordinance for adoption by the City of South San Francisco City Council and notify the Regional Water Board at least 30 days prior to presenting the proposal to the City Council.

We revised the Fact Sheet section IV.A.3 as follows:

**Discharge Prohibition III.C** (**No bypass**): This prohibition is based on 40 C.F.R. section 122.41(m) (see Attachment D § I.G). Bypass is prohibited; however, bypass is approved for the portion of the flow greater than the wet weather capacity subject to the following conditions: ... (4) the City of San Bruno continues to implement a <u>transfer of title</u> private sewer lateral inspection ordinance, and the City of South San Francisco implements a <u>transfer of title</u> private sewer lateral inspection ordinance by January 1, 2021; and the Facility is operated as designed and in accordance with the Operation and Maintenance Manual developed for the Facility (i.e., the Discharger must optimize storage and use of equalization units, and fully utilize the biological treatment units). ...

The Discharger meets the criteria required for the Regional Water Board to approve these bypasses as follows (see Attachment D section I.G.3):

:

• There are no feasible alternatives to the bypass. ...

The City of South San Francisco does not currently have a transfer of title

private sewer lateral <u>inspection program ordinance</u> to reduce wet weather infiltration and inflow from private sewer laterals within its service area. The City of San Bruno and many other jurisdictions have such an ordinance; therefore, it is feasible for the City of South San Francisco to adopt one as well. ...

:

We revised Fact Sheet section VI.C.5.a as follows:

**Specific Tasks to Reduce Wet Weather Bypasses.** ... The Discharger will also minimize wet weather bypasses by implementing collection system improvements to reduce inflow and infiltration. Furthermore, this Order requires the City of South San Francisco to develop a <u>transfer of title</u> private sewer lateral ordinance based on a review of Bay Area communities that have successfully adopted measures requiring inspection of private sewer laterals (e.g., upon ownership ehange). The City of San Bruno and many other jurisdictions already have such an ordinance; therefore, it is feasible for the City of South San Francisco to adopt one as well. ...

**Comment 2:** The City requests we clarify ownership responsibilities for the North Bayside System Unit facilities.

#### Response

We agree and revised Fact Sheet section I.A as follows:

The cities of South San Francisco and San Bruno and the North Bayside System Unit (NBSU) (together, the Discharger) discharge treated wastewater into the deepwater channel of Lower San Francisco Bay. ... The plant provides secondary treatment of wastewater <u>from the cities of South San Francisco and San Bruno</u>, the town of Colma, and a small part of the City of Daly City, and discharges the effluent to the NBSU outfall force main.

The NBSU is a joint powers authority that includes the cities of Burlingame, Millbrae, South San Francisco, and San Bruno, and the San Francisco International Airport. The NBSU agencies share discharge capacity rights and own and operates the effluent outfall force main, the combined effluent pumping station, the effluent dechlorination facilities, and the deepwater outfall. The City of South San Francisco operates and maintains the NBSU effluent pumping facilities. The cities of Burlingame and Millbrae, and the San Francisco International Airport, own and are responsible for their own effluent force mains that transport treated wastewater to the Facility. For the purposes of this Order, the plant, the Discharger's collection systems, and the NBSU outfall force main, combined effluent pumping station, dechlorination facilities, and deepwater outfall are collectively referred to as the "Facility."

**Comment 3:** The City requests language to ensure that Waste Discharge Requirements adopted by the State Water Resources Control Board are not incorporated by reference into this federal NPDES permit.

## Response

We agree that Provision VI.C.4.c of the tentative order is not intended to incorporate by reference the statewide WDRs, but we did not revise the tentative order, except to define the term "statewide WDRs." The words "While the Discharger *must* separately comply with both the statewide WDRs and this Order" could be interpreted to require compliance with the statewide WDRs as a requirement of this NPDES permit. This is not our intent (nor has it been our intent in the many other NPDES permits that include these words). To avoid confusion, we did not include these unnecessary words in the tentative order. We revised the Provision VI.C.4.c (second paragraph) as follows:

State Water Board Order No. 2006-0003-DWQ, Statewide General Waste Discharge Requirements for Sanitary Sewer Systems, as amended by State Water Board Order No. WQ 2013-0058-EXEC (statewide WDRs), contains requirements for operation and maintenance of collection systems and for reporting and mitigating sanitary sewer overflows. The statewide WDRs clearly and specifically stipulate requirements for operation and maintenance and for reporting and mitigating sanitary sewer overflows. ...

**Comment 4:** The City requested to lower the cost requirement for collection system improvement projects from \$7.0 million to \$5.0 million.

## Response

We agree since the \$7.0 million was based only on an initial estimate from the City. We revised Table 5, Task 1, of the tentative order as follows:

#### Rehabilitate High Priority Sewer Pipe

Complete \$5.0 \$7.0 million of sewer pipe rehabilitation and improvements on the wastewater collection systems. ...

We revised Fact Sheet section II.D.2 (last paragraph) as follows:

The Discharger and its satellite collection system agencies maintain sewer master plans, which identify collection system projects and ongoing maintenance activities .... Provision VI.C.5.a of this Order requires the Discharger to clean and inspect its collection system and to complete at least \$5.0 \$7.0 million of sewer pipe rehabilitation and improvements on its collection system.

We revised Fact Sheet section IV.A.3 (second bullet) as follows:

There are no feasible alternatives to the bypass. Provision VI.C.5.a requires the Discharger to implement feasible measures to minimize and eventually eliminate wet weather bypasses. ... These improvements are scheduled to be completed by 2022. Moreover, the Discharger plans to complete \$5.0 \$7 million of collection system projects over the coming permit term.
