NOTICE OF OPPORTUNITY TO COMMENT AND PUBLIC HEARING FOR PROPOSED WATER QUALITY CERTIFICATION AND WASTE DISCHARGE REQUIREMENTS FOR STREAM MAINTENANCE ACTIVITIES

NOTICE IS HERBY GIVEN THAT the San Francisco Bay Regional Water Quality Control Board (Regional Water Board) will accept written comments on the Tentative Order for issuing Water Quality Certification and Waste Discharge Requirements for stream maintenance activities in Napa County, San Mateo County, Contra Costa County, and Sonoma County.

The Tentative Order amends Order No. 2020-0034, issued to the Napa County Flood Control and Water Conservation District for their Stream Maintenance Program (SMP), and the San Mateo County's and the Contra Costa County Flood Control and Water Conservation District's Routine Maintenance Programs (RMP), to include Sonoma County Water Agency's SMP and applies to stream maintenance activities conducted pursuant to an approved SMP or RMP Manual (Manual).
