NOTICE OF OPPORTUNITY TO COMMENT ON AND PUBLIC HEARING FOR

PROPOSED AMENDMENT TO ORDER NO. R2-2019-0007, CEASE AND DESIST ORDER FOR CALIFORNIA DEPARTMENT OF TRANSPORTATION

NOTICE IS HEREBY GIVEN that the California Regional Water Quality Control Board, San Francisco Bay Region, (Water Board) has prepared a proposed amendment (Amendment) to Cease and Desist Order No. R2-2019-0007 (CDO) and it is available for public comment. The CDO was issued to the California Department of Transportation (Department) on February 13, 2019, to impose requirements for the Department to come into compliance with its statewide stormwater national pollutant discharge elimination system (NPDES) permit requirements for trash. The proposed Amendment would allow the Department an additional year, until December 31, 2022, to complete the first required trash visual assessment, and would require interim submittals of an updated visual trash assessment methodology by June 30, 2022, and a sample trash generation map produced using the updated methodology by August 30, 2022. The Amendment would also update Appendix A of the CDO to incorporate the revised deadlines and correct trash reduction benchmark acreages.
