NOTICE OF OPPORTUNITY TO COMMENT ON TENTATIVE WASTE DISCHARGE REQUIREMENTS FOR

PACIFIC 42, LLC. LAKE PARCEL C LANDFILL, APN 405-030-062 LOCATED IN RICHMOND, CONTRA COSTA COUNTY

NOTICE IS HEREBY GIVEN THAT the San Francisco Bay Regional Water Quality Control Board (Water Board) will accept written comments on the Tentative Waste Discharge Requirements (WDR) Order for the Lake Parcel C Landfill, owned by Pacific 42, LLC.

The Tentative Order would recognize new property ownership, summarize the landfill consolidation and capping work that has been completed, and require a self-monitoring plan and establishment of water quality protection standards. A post-closure monitoring and maintenance plan has already been approved by this Board, which documents how the landfill will be monitored and maintained during the minimum 30-year post-closure period.
