NOTICE OF OPPORTUNITY TO COMMENT ON UPDATED WASTE DISCHARGE REQUIREMENTS FOR THE CLOSED BURLINGAME LANDFILL LOCATED AT 250 ANZA BOULEVARD, BURLINGAME, SAN MATEO COUNTY

NOTICE IS HEREBY GIVEN THAT the San Francisco Bay Regional Water Quality Control Board (Water Board) will accept written comments on the Tentative Order (Order) for updating Waste Discharge Requirements (WDR) Order R2-2007-0039 for The City of Burlingame (The Discharger).

The Order would update the current Waste Discharge Requirements for the closed landfill. The updated Order would fulfill two primary objectives: (1) Acknowledge the planned post-closure land use (i.e., construction of a TopGolf commercial/recreational facility on top of the closed landfill where the current golf driving range resides) and planned upgrades to the Landfill cover and gas collection system; and (2) specify groundwater monitoring requirements consistent with Title 27 and due to the change in post-closure land use.
