PROPOSED TERMINATION OF ORDER No. R2-2018-0031, CEASE AND DESIST ORDER FOR THE COUNTY OF ALAMEDA, FOR VIOLATION OF TRASH REQUIREMENTS OF MUNICIPAL REGIONAL STORMWATER NPDES PERMIT, ORDER No. R2-2015-0049

NOTICE IS HERBY GIVEN THAT the San Francisco Bay Regional Water Quality Control Board (Water Board) will accept written comments on the Tentative Order to terminate [R2-2018-0031](#), Cease and Desist Order for County of Alameda (County).

The Tentative Order would terminate the Cease and Desist Order, issued to the County for violation of trash control requirements of the Municipal Regional Stormwater NPDES Permit (Order No. R2-2015-0049). The County met the Cease and Desist Order's requirements by reducing trash loads by 83.5 percent.
