## THE FAIRVIEW AT NORTHGATE RESIDENTIAL DEVELOPMENT PROJECT

(VALLEJO, SOLANO COUNTY)

**NOTICE IS HERBY GIVEN THAT** the San Francisco Bay Regional Water Quality Control Board (Regional Water Board) will accept written comments on the Tentative Order for issuing Water Quality Certification and Waste Discharge Requirements for the Fairview at Northgate Residential Development Project in Vallejo, Solano County.

This Tentative Order would authorize the placement of fill in the waters of the State for the construction of homes, streets, stormwater facilities, and other supporting infrastructure on the east side of the parcel, located near the intersection of Admiral Callaghan Way and Turner Parkway.

Pursuant to California Code of Regulations Title 23 section 2050(c), any party who challenges the Board's action through a petition to the State Water Resources Control Board under Water Code section 13320 will be limited to raising only those substantive issues that were raised before the Board at the hearing or in timely submitted correspondence.
