NOTICE OF OPPORTUNITY TO COMMENT AND PUBLIC HEARING FOR PROPOSED WATER QUALITY CERTIFICATION AND WASTE DISCHARGE REQUIREMENTS FOR

THE BERRYESSA MIXED USE DEVELOPMENT PROJECT

(SAN JOSE, SANTA CLARA COUNTY)

NOTICE IS HERBY GIVEN THAT the San Francisco Bay Regional Water Quality Control Board (Regional Water Board) will accept written comments on the Tentative Order for issuing Waste Discharge Requirements for the Berryessa Mixed Use Development Project in San Jose, Santa Clara County.

This Tentative Order would authorize the placement of fill in the waters of the State for the construction of a mixed-use project consisting of up to 850 residential units, 480,000 square feet of commercial space, 0.9-acres of open space, streets, stormwater facilities, and other associated supporting infrastructure within the Berryessa BART Urban Village Plan area.

Pursuant to California Code of Regulations Title 23 section 2050(c), any party who challenges the Board's action through a petition to the State Water Resources Control Board under Water Code section 13320 will be limited to raising only those substantive issues that were raised before the Board at the hearing or in timely submitted correspondence.
