I am asking for your help in protecting the Petaluma River, wetlands, fish and wildlife, and public investments including Shollenberger Park from devastation for the proposed and widely opposed Dutra Asphalt Plant on our river. I am concerned that the pollution of our public resources and assets by this commercial project is not being sufficiently scrutinized under the above Public Notice for a Sec. 404 Permit.

I am a volunteer with the Petaluma Wetland Alliance. We bring third grade students to Shollenberger Park and tell them about the importance of the wetlands, by acting as:

- \* a natural filter and that purifies surface water,
- \* a sponge and thus provides flood control to protect the lands near the river,
- \* a source for infusing nutrients into the water for a healthy diet for marine life,
- \* a nursery for young fish, amphibians, and reptiles, by providing shelter in their early lives,
- \* a safe refuge for migrating bird life in a world where natural habitats are increasingly more scarce.

Dear Mr. Fernandez,

I am writing to register my objection to having the Dutra plant at the proposed site at the south end of Petaluma.

In addition to noise, traffic, ugliness, use of existing wetlands, compromise of Schollenberger Park and air pollution, I am very concerned about possible leaks into the water supply.

I understand that Dutra contends that this spot is the Least Environmentally Damaging, but that argument largely rests on their having to mix the asphalt hot. However, there is much evidence to suggest that warm mix asphalt is the way of the future.

If Dutra just switched to Warm Asphalt Technology the asphalt can be hauled farther and applied at lower temperature. That technology also requires significantly less energy to prepare, thus creating significantly less emissions (both toxic emissions and GHG related to natural gas).

A study of this technology by the Federal Highway Administration in 2007 discusses this http://www.warmmixasphalt.org/submissions/68 20080223 FHWA-PL-08-007.pdf

Since then, it seems the technology, which was introduced here in 2002 from Europe where it's widely used, the use of warm asphalt has gained traction for several extremely important reasons. I don't see why it shouldn't be considered in this case, and especially in a state that rightly prides itself on its cutting-edge environmentalism.

From WarmMixAsphalt.org (http://www.warmmixasphalt.org/AboutWma.aspx):

Warm-mix asphalt allows the producers of asphalt pavement material to lower the temperatures at which the material is mixed and placed on the road. Reductions of 50 to 100 degrees Fahrenheit have been documented. Such drastic reductions have the obvious benefits of cutting fuel consumption and decreasing the production of greenhouse gases.

In addition, research at the <u>National Center for Asphalt Technology</u> and elsewhere has shown that lowering the production temperature can drastically reduce the production of emissions. By cutting emissions, warm-mix asphalt improves conditions for workers and enhances relationships with neighbors.

NAPA first brought warm-mix technology to the United States from Europe in 2002, spurring intense interest among hot-mix asphalt producers, contractors, researchers, and government agencies. Since that time, new technologies have been developed in the United States.

I strongly urge you to consider this information and to bring it to the decision-makers before next week's deadline.

Dear Mr. Fernandez,

Upon reviewing the Alternatives Analysis for the Dutra Haystack Asphalt Plant Project (UACE File no. 28104N), I see that the project assumes hot mix asphalt production, which demands that, "Access to the desired market area is limited to areas that are close enough to the plant to allow the delivered material to be at a high enough temperature to meet the specifications required to place the asphalt. ... If asphalt is allowed to cool below a certain point\*, it loses its ability to be properly spread and compacted within State and local specification requirements and is no longer a useful product." (source: p. 21, Dutra's AA report).

However, there is an increasingly and widely adopted technology that contradicts the applicant's claim: warm mix asphalt (WMA). How widely is it used? "As of the end of 2011, 47 states had adopted specifications or contract language allowing WMA on projects, and 20 states had set targets for future use of WMA."

Is it viable in California? Yes, and it has been for many years. "As of 2009, at least 14 State Highway Agencies (including California's) had adopted specifications to accommodate WMA. In addition, 22 different named WMA technologies are actively marketed in the US." In addition, the City of Santa Rosa, just up the road from Petaluma, has already completed three jobs with WMA.

Can WMA offer more flexibility in defining acceptable alternatives to the Haystack site? Yes. A more recent FHA Center for Accelerating Innovation document cites that with WMA, as compared to HMA "lower temperatures also permit more asphalt mix to be hauled for longer distances, reducing transportation costs."

Would WPA improve the environment as well as allow for longer haul distances? Yes. As the NAPA report above states in its summary on page 64, "Potential paving benefits include lower production temperatures, reduced fuel consumption, the extension of the paving season in cold climates, longer haul distances, longer storage times, and enhanced compaction." And, "On the environmental side, decreased production temperatures and reduced fuel consumption result in lower emissions at the plant and paving site. The decreased emissions include greenhouse gases, fugitive emissions, and fumes. In addition, working conditions at the plant and paving site are improved." The FHWA report concludes, "This green technology is increasing the quality of our roads and our environment."

Has WMA ever been tested in an area with similar conditions to ours here in Marin and Sonoma Counties? Indeed. Concerning longer haul distances, the following example was cited, beginning on page 39 of the NAPA report: "In 2008, the California Department of Transportation (Caltrans) [Dutra's main customer for the proposed plant] used WMA on four paving projects in Northern California to deal with a combination of long haul distances, cool weather, and polymer-modified binders (Barros 2009). Mix was hauled for one to three hours. WMA was used in both dense-graded and open-graded mixtures. Because of the cool weather and long hauls, a crust formed on the asphalt in the haul trucks; this crust broke up into chunks as the mix was dumped. For the two projects where a materials transfer vehicle was not used, some material was wasted to eliminate the chunks. Adequate workability was still observed. Temperature reductions of up to 25 degrees F were still possible and compaction was improved. Field performance to date has been good."

Has WMA pavement stood the test of time? Yes. This technology was developed in Europe and has been used there since 1999, and in the US since 2004. According to the same report (page 60, Long-term Performance), performance data was gathered in 2007 from some of the oldest WMA pavements in Europe (where temperature differences are much higher than in Northern California), and proved that "performance of WMA mixes appears to be the same as or better than the performance of conventional HMA (D'Angelo et al. 2007)."

Does WMA perform well enough to be used on heavily trafficked roads, like the 101? Yes. Not only does WMA perform better than HMA on areas exposed to heavy traffic (NCAT Test Track, 2005, 2006, 2009), but in 2007 CalTrans began WMA testing with their heavy vehicle simulator at the University of California Pavement Research Center, and found, "WMA can provide similar rutting performance as HMA (Jones, 2009)." This contradicts any argument that HMA is better suited to highways that experience heavy traffic, and thus the Dutra plant must be HMA, and therefore must be built extremely close to its intended market. (p. 60-61)

Is WMA common, or just a passing fad? It's been heavily endorsed by the market. According to the latest NAPA/FHWA survey, cited in the link above, "almost a third of all asphalt produced during the 2013 construction season was produced using warm-mix asphalt technologies."

It's also been endorsed by the international construction industry. According to this NAPA link above, "In 2013, NAPA and FHWA were honored by the Construction Innovation Forum, earning a NOVA Award for their work promoting the uptake of WMA. In 2014, WMA tonnage in the US was estimated at about 114 million tons, a 7% increase from 2013 and a greater than 577% increase since 2009."

In conclusion, it is this citizen's comment that these technological advances in WMA require a mature asphalt production company like Dutra, operating in the environmentally conscientious state of California, to expand its review of sites that would be actually viable alternatives to the environmentally delicate Haystack Landing.

One of the applicant's core arguments for defining the Haystack site as the Least Environmentally Damaging Alternative (LEDPA) is its assumed need to rely on HMA in order to remain close enough to its market to keep its product viable. If WMA, clearly the wave of the future in paving, is accepted as a reasonable alternative, one that would significantly lower the environmental impact, and allow for longer hauling distances, Haystack would be in the clear of this dubious LEDPA distinction.

The Haystack site, on a wetlands-inclusive area, directly beside the Petaluma River, a tidal slough, and directly opposite of the Alman Marsh, a special, biologically sensitive place, home to several threatened and endangered species, includes several tidally influenced drainage ditches (pp. 5,6, Dutra's AA report) which are therefore subject to degradation and pollution that should be avoided at all costs. The San Francisco Bay Water Quality Review Board has the right and the responsibility to require the applicant to consider all viable, proven technologies in its mandate to protect our common waterways.

\*Should the argument against the green technology of WMA be completely rejected by the applicant in the interests of profit, the Water Quality Review Board deserves to be provided with documentation that defines the temperatures and distances to which the applicant refers in its report as reasons for disqualifying any sites further away from its intended market. In addition, the applicant should be required to provide comparable HMA data from other plants in the area, and prove that they, too, operate in a tightly confined circle extremely close to their markets. The applicant should also be required to prove to the WQRB what average haul distances are, in actuality, of other hot mix asphalt producers in the area, since weather conditions are so important to asphalt production, hauling, and application. Without such data, it seems no one could look at this report and make an informed decision.

Dear Mr. Fernandez and LTC John C. Morrow, Commander, USACE San Francisco District: The Petaluma River and Wetlands are important to the well being of our citizens and the regional ecosystem. During my ten terms in Congress I worked long and hard to preserve and protect this valuable asset and its water quality. I found funding to keep the Petaluma River dredged and the federal navigable channel open and working for all of my constituents.

It has come to my attention that an Alternatives Sites Assessment has been submitted by The Dutra Group in support of their 404 Application. I'm writing to ask you to scrutinize this application and hold the applicant to the highest standards of environmental protection.

Asphalt production is not a water dependent manufacturing process, and sufficient asphalt production capacity already exists in Sonoma and Marin Counties. Dutra Materials needs to expand its Alternative Sites study to include sites that will not impact our sensitive wetlands and waterways.

Access to water delivery of aggregate is simply a preference for Dutra materials, not a requirement for the manufacturing process. Two existing Sonoma companies, sources of hot mix asphalt are manufacturing asphalt located far from water accessible delivery (Syar and BoDean). They are supplying the region. Warm Mix Asphalt is now an environmental option that uses less energy and is able to expand delivery to a three-hour haul. Instead of heating the asphalt to 315 degrees the asphalt is heated to 280 degrees. BoDean, a local Sonoma Company has already invested in the equipment to manufacture Warm Asphalt , and has supplied it to The City of Santa Rosa (Hoen Avenue) with great success. This is the asphalt that will replace hot asphalt in the years to come and Alternative SItes for Dutra should have a much larger search radius than indicated in Dutra Group's study.

Additionally, Dutra's barges and tugs will block the federal, dredged Navigable Waterway, if they are allowed to dock at nearby Shamrock's facility.

Since no proof exists that docking at Shamrock will be allowed, Dutra may need to build another docking facility, leading to more degradation of the wetlands and riverbank.

The impact on the river's water quality, the wetlands, the federal navigable channel and the sensitive ecosystem and Shollenberger Park all point to this site as hardly worthy of designation as the LEDPA for this factory.

May I emphasize that it is in the public's best interest and a requirement of The Clean Water Act to identify the Least Environmentally Damaging Alternative (LEDPA). Please use all your knowledge and expertise to review this application and direct the applicant accordingly.

As both a former Congresswoman and a longtime resident of Petaluma I am concerned and plan to be watchful of the application process.

The proposed asphalt plant has met all regulatory and environmental approvals and should also be approved BARWQCB. It is designed with a series of mitigation measures including sand filters and bio-retention areas to exceed current storm water management guidelines. Meeting the storm water management guidelines will result in a project whose run-off is as clean, or likely cleaner, than the existing native site.

There are also intangible water quality benefits created by this project:

- It will drastically reduce truck trips related to paving projects in northern Marin & southern Sonoma Counties. Currently asphalt for these areas is supplied from San Rafael, Santa Rosa and occasionally Vallejo or Benicia. Once again the San Rafael-based Dutra Dredging Co. (Dutra Group) Is asking they be allowed to circumvent the regulations established with regards to their constructing an asphalt plant on the Petaluma River adjacent to the Shollenberger wild Life Sanctuary, near schools, housing and business developments.

The Dutra Dredging Co. (Dutra Group) Is know for circumventing regulations once established, doing precisely what they want regardless of the impact on the community and environment. Often they chose to pay the penalty.

The Dutra Corp (Dutra Group) did have an asphalt plant in Petaluma. It was built without permits and produced a low grade asphalt which the city of Petaluma chose not to use.

#### Lawsuits

There have been many lawsuits against the Dutra Corp. August 17, 2006 San Rafael-based Dutra Dredging Co. (Dutra Group) agreed to pay \$735,000 in fines for ocean discharge violations between 1999 and 2003, according to the U.S. Environmental Protection Agency. The agency and the National Oceanic and Atmospheric Administration discovered the company "leaked or dumped" 200,000 cubic yards of dredged material from its disposal vessels while en route to a designated deep ocean disposal site 55 miles offshore of San Francisco, according to the EPA. They were caught dumping their dredging materials in the environmentally sensitive Farallones National Marine Sanctuary. The fine was pennies compared to the damage they created.

State of Florida sues Dutra Construction Co (Dutra Group) for illegal dumping of dredged material on sensitive wetlands and Coral Reefs.

In 1994 Dutra Construction Co. (Dutra Group) began contracted work with the Port of Miami, dredging a section of the shipping channel in Biscayne Bay, a "shallow subtropical lagoon with diverse habitat including mangroves, seagrass beds, and coral reefs. Manatees, crocodiles, sea turtles, and many important fish species also share the immediate marine environment with the port."1 This "rich marine habitat"1 was severely damaged by Dutra's illegal dredging and destruction of "3.5 acres of seagrass outside of the permitted dredging area."2 "in violation of county, state, and federal laws."3 "This is the largest unauthorized sea-grass-destruction case ever investigated by DERM [Miami-Dade Department of Environmental Resources Management]," declared biologist Craig Grossenbacher, chief of DERM's coastal resources section. "At the very least there was gross negligence."3 Grossenbacher also stated that "We now know this illegal dredging occurred between 1995 and 1997."3 "To make matters worse, the excavation, funded by taxpayers, led to illegal dumping of the coral rock and dredge materials."2 In 1997 Dutra stopped work and filed for bankruptcy.3

As a former board member of of the Redwood Empire Chapter Trout Unlimited (2006-2009) and Northern California Vice President California State Council Trout Unlimited (2007-2009) I am urging you not to approve the request for Dutra Haystack Landing Asphalt Plant and it's Alternative Analysis.

I was part of the research team going over Sonoma County records for both the Dutra Asphalt Plant and the existing Shamrock Sand and Gravel Barge Facility . I am very concerned with potential pollution problems that will be generated by this new Facility .

The use of Petaluma River water (brackish at best not fresh) for dust control will increase concentrations of pollution run off back in to the River and its adjoining wet lands.

The Petaluma River has an ongoing pollution issue from both residential and commercial run off through storm drains back into the river . Now add the 350 diesel trucks per day driving in and out of the project (See County approval and EIR) . Along with the oil and rubber components of the production of Asphalt . This increased concentration of pollution will adversely affect Adobe Creek (mouth of creek directly opposite parcel A) and Schollenberger Park / Ellis Creek wild life sanctuaries .

Down stream from this project is a levy breach which was not repaired as it has flooded former wetlands between Schollenberger Park property and Ellis Creek Wildlife Refuge . The increased pollution will reach migrating water foul, existing mammal and amphibian inhabitants along with Egrets, Heron, and shore birds which use the land as foraging food source.

As stated in the EIR there already exist enough asphalt production in Sonoma County ( Syar and BoDean ) to satisfy all needs . Off loading river dependent barges at Site A is not feasible due to 2 twelve inch high pressure PG&E gas lines with in 100 feet of proposed facility . Like wise the Shamrock facility ( already at capacity ) can not stack barges out into the river channel or nose to tail as it will impair river traffic .

There is no guarantee that the National Railway Administration will allow a conveyor system from the Shamrock property over the SMART railroad tracks to the Dutra property. That would necessitate the trucking of materials from Shamrock to Dutra. This would increase pollution of the air and asphalt plant site even more.

Our wetlands are under increased stress from existing pollution, encroaching construction and population increase. This project is not needed at this site as indicated by the EIR. There are alternative sites at both the Sonoma County Landfill and the Marin County Landfill (also on the Petaluma River).

For these reasons I urge not to approve this project.

The public has the right to comment on the Dutra Asphalt factory project application. This piecemeal public notice for public comment of their application in parts makes it more difficult 1) for the public to understand the full impact of the project 2) to track and respond to each request for comment for each section.

I would request that the public be given another opportunity to comment on all of the parts of the Dutra Group's application,in its entirety, once all sections have been submitted.

As a founder of Friends of Shollenberger and a citizen of Petaluma for 30 years, I have worked long and hard to inform our community about the impacts of the proposed asphalt factory on the banks of the Petaluma River. The community responded with over 1000 signed petitions to the CIty Council of Petaluma asking them to prevent this eyesore and source of toxins so close to sensitive wetlands habitat and the City's most popular Park, Shollenberger Park. The CIty Council voted unanimously to oppose the approval of the project by the County. After a 3-2 vote by the Sonoma County Supervisors to approve the project, The CIty joined as a plaintiff in the lawsuit to challenge the FEIR and the zoning changes first in Superior County Court, and finally in State Appeals Court.

It should be noted by you that the Dutra parcels were rezoned by The County to a more intense usage ("light Industrial") to accommodate the asphalt factory, despite the fact that these parcels are located in the 100 year Flood Plain. The Sonoma County General Plan wisely prohibits industrial operations from being located in the 100 year flood plain.

This abrogation by the Supervisors of the intention of their own General Plan was litigated in State Court of Appeals by a coalition of Petaluma community groups, The CIty of Petaluma, and individual citizens. Dutra Group "cured" this problem by proposing to cut

from the wetlands and us this fill to raise the footprint of the factory to an elevation above the 100 year flood plain. This solution was accepted by the court.

The judges who accepted this rationale however are not experts in the science of rising seas, floods, tides and water quality of the River. You the RWQCB are the experts. I ask you to consider whether raising the footprint of a factory within a hundred year flood plain removes it from the dangers and consequences of being located in a flood plain. The site is still located within the 100 year flood plain as official maps will prove.

If a precedent is set, allowing the Dutra Group to build in the 100 year flood plain, then we can look forward to additional industrial operations locating in the 100 year flood plain, putting both the River's water and wetlands in jeopardy.

I ask you to protect the river and the wetlands. I ask you to consider this question: Why have a General Plan that purports to protect our River and then undermine its safeguards by sleight of hand and clever legal maneuvering.

I ask your help in protecting the Petaluma River, wetlands, fish and wildlife, and public investments including Shollenberger Park. I am concerned about the likely degradation of these public resources and assets that will be caused by the proposed Dutra asphalt factory. I ask you to reject their 404 application, starting with a rejection of their Alternatives Sites Analysis as failing to be an honest survey of alternative sites.

The Petaluma River and Wetlands are important to the well being of our citizens and the regional eco-system. During my ten terms in Congress I worked long and hard to preserve and protect this valuable asset and its water quality. I found funding to keep the Petaluma River dredged and the federal navigable channel open and working for all of my constituents.

It has come to my attention that an Alternatives Sites Assessment has been submitted by The Dutra Group in support of their 404 Application. I'm writing to ask you to scrutinize this application and hold the applicant to the highest standards of environmental protection.

Asphalt production is not a water dependent manufacturing process, and sufficient asphalt production capacity already exists in Sonoma and Marin Counties. Dutra Materials needs to expand its Alternative Sites study to include sites that will not impact our sensitive wetlands and waterways.

Access to water delivery of aggregate is simply a preference for Dutra materials, not a requirement for the manufacturing process. Two existing Sonoma companies, sources of hot mix asphalt are manufacturing asphalt located far from water accessible delivery (Syar and BoDean). They are supplying the region.

Warm Mix Asphalt is now an environmental option that uses less energy and is able to expand delivery to a three-hour haul. Instead of heating the asphalt to 315 degrees the asphalt is heated to 280 degrees. BoDean, a local Sonoma Company has already invested in the equipment to manufacture Warm Asphalt, and has supplied it to The City of Santa Rosa (Hoen Avenue) with great success. This is the asphalt that will replace hot asphalt in the years to come and Alternative SItes for Dutra should have a much larger search radius than indicated in Dutra Group's study.

Additionally, Dutra's barges and tugs will block the federal, dredged Navigable Waterway, if they are allowed to dock at nearby Shamrock's facility.

Since no proof exists that docking at Shamrock will be allowed, Dutra may need to build another docking facility, leading to more degradation of the wetlands and riverbank.

The impact on the river's water quality, the wetlands, the federal navigable channel and the sensitive ecosystem and Shollenberger Park all point to this site as hardly worthy of designation as the LEDPA for this factory.

May I emphasize that it is in the public's best interest and a requirement of The Clean Water Act to identify the Least Environmentally Damaging Alternative (LEDPA). Please use all your knowledge and expertise to review this application and direct the applicant accordingly.

As both a former Congresswoman and a longtime resident of Petaluma I am concerned and plan to be watchful of the application process.

Dear Mr. Fernandez and LTC John C. Morrow, Commander, USACE San Francisco District:

The 10/18/16 email notice from Mr.Fernandez states that "The proposed Project would construct an asphalt facility and associated conveying system". The Dutra "Alternative Analysis" describes the "associated conveying system" stating: "Dutra will use the current Shamrock Material Inc.("Shamrock") landing way off-loading facility"(page 4). This statement is the foundation for Dutra's "Alternative Analysis". In fact, Dutra has no such agreement with Shamrock, as evidenced by the attached letter from Shamrock. Therefore, without the conveying system agreement with Shamrock, Dutra's proposed Project is a sham. In other words, Dutra has disseminated to a public entity a statement which is untrue or misleading in connection with its business. This is a per se violation of California false adverting statute and constitutes unfair, illegal and fraudulent business practices (California Business & Prefessions Code Sections 17200 and 17500). For these reasons alone, the Dutra permit should be rejected.

Additional reasons for rejection include the following: I am a resident of Petaluma and daily visitor at Shollenberger Park (considered a treasured habitat for numerous bird species). The resources at Shollenberger are utilized by hundreds of people every day. The uses include exercising(walking, jogging, biking), bird watching, photography, picnics, educational tours, etc. It also is an excellent resource for charity fund-raising in the form of races/walks/bird-watching, competitions for all ages--also watching rowing races on the Petaluma River along the shores of Shollenberger. For the last 7 years, the Alzheimers Association has utilized Shollenberger for its annual "walk", its major fund-raising source for Marin and Sonoma Counties. If the Dutra Permit Application is granted, these multiple uses at Shollenberger will be jeopardized.

You must and should reject Dutra's Permit Application and "Altenatives Analysis" in order to protect the Petaluma River, wetlands, fish and wildlife, and public investments including Shollenberger Park. There is no doubt that the Dutra asphalt factory will result in substantial degradation of these public resources and assets, including substantial health risks.

You must not permit Dutra's misinformation and false parameters to prevail over your duty to protect the habitat for the following reasons:
