NOTICE OF PUBLIC MEETING

CONDITIONAL WAIVER OF WASTE DISCHARGE REQUIREMENTS FOR GRAZING OPERATIONS IN THE NORTH SAN FRANCISCO BAY REGION (NAPA RIVER, SONOMA CREEK, PETALUMA RIVER, AND TOMALES BAY WATERSHEDS, INCLUDING ALL GRAZING OPERATIONS IN POINT REYES NATIONAL SEASHORE)

NOTICE IS HEREBY GIVEN that San Francisco Bay Regional Water Quality Control Board (Water Board) staff will hold a public meeting to discuss the Conditional Waiver of Waste Discharge Requirements for Grazing Operations (Grazing Waiver) in the North San Francisco Bay Region, and the upcoming renewal and geographic scope expansion. The meeting will be conducted in-person at the address shown above. Members of the public will be able to ask questions and/or make comments following the presentation.

PROJECT DESCRIPTION

The Water Board currently regulates about 96,000 acres of grazing lands in the Tomales Bay, Sonoma Creek, and Napa River watersheds with two separate Grazing Waivers. A revised multi-watershed Grazing Waiver is proposed to renew expired existing waivers and to implement the recently adopted Petaluma River Bacteria Total Maximum Daily Load (effective May 10, 2021). In addition, grazing operations located within unregulated watersheds of Point Reyes National Seashore will be included in the revised Grazing Program scope of coverage. Requirements for Grazing Waiver compliance will largely remain the same, but the proposed Grazing Waiver will expand the current Grazing Waiver program by an estimated 26,000 acres.

The Grazing Waiver requires implementation measures to minimize and control discharges of animal waste and sediment runoff by evaluating current operating practices; identifying current and future effective site-specific pollutant control measures; developing an implementation schedule for needed management actions; and annual reporting on actions taken.
