Order No. R8-2025-0020

Rescission of Waste Discharge Requirements for Specific Dischargers

The California Regional Water Quality Control Board, Santa Ana Region (hereinafter Santa Ana Water Board), finds that:

- 1. The Orders listed in Attachment "A" were issued by the Santa Ana Water Board at various times to dischargers described therein. Attachment "A" is hereby made a part of this Order. The three Orders for the dischargers listed in Attachment "A" are no longer necessary as the discharge has ceased or the project has been completed.
- 2. This action is based on the fact that the specific discharges have been eliminated, or the project has been completed. As such, this action will not result in a direct or reasonably foreseeable indirect physical change in the environment. Further, there is no possibility that this action may have a significant effect on the environment. Accordingly, this action is exempt from the requirements of the California Environmental Quality Act in accordance with Section 15061(b)(3), Chapter 3, Title 14 of the California Code of Regulations.
- 3. The Santa Ana Water Board has notified the discharger, interested agencies and persons of its intent to rescind the orders for the dischargers listed in Attachment "A" and has provided them with an opportunity to submit written comments and recommendations.
- 4. The Santa Ana Water Board, in a public meeting held on June 13, 2025, heard and considered all comments pertaining to the rescission of waste discharge requirements.

IT IS HEREBY ORDERED that orders listed in Attachment "A" be rescinded.
