OC Reclamation Inert Waste Disposal Operation

NOTICE IS HEREBY GIVEN that the Santa Ana Regional Water Quality Control Board (Santa Ana Water Board) will hold a public workshop to discuss the OC Reclamation Inert Waste Disposal Operation.

OC Reclamation, LLC and Chandler's Sand & Gravel, LLC are proposing to fill back and re-grade the former sand and gravel mine excavation quarry located at 5341 East Santiago Canyon Road in the City of Orange (Facility). This open mine will be back filled only with inert waste such as rock, concrete, brick, sand, soil, and cured asphalt, and regraded back to surface levels to match the elevation of adjacent parcels. No further land uses for the Facility are currently proposed.
