NOTICE IS HEREBY GIVEN that the Santa Ana Regional Water Quality Control Board (Santa Ana Water Board) is releasing for public review and comment tentative Order R8-2024-0058 (Tentative Order) to Signature Realty Capital Corps. (Discharger) for the Dauchy Project TTM 38074 (Project). The Project encompasses the subdivision of 24.73 acres into 53 dwelling units, and on-street improvements such as sidewalks, curb, and gutter. The construction of the Project will result in the permanent physical loss of 0.018 acre of *ephemeral streambed*, to waters of the state. The permanent impacts are a result of mass *grading for site preparation and road improvements*.

The Santa Ana Water Board intends to consider adopting the Tentative Order during a public hearing at a regularly scheduled Santa Ana Water Board meeting as follows:
