**NOTICE IS HEREBY GIVEN** that the Santa Ana Regional Water Quality Control Board (Santa Ana Water Board) is releasing for public review and comment tentative Order R8-2024-0064 (Tentative Order) to San Bernardino County Department of Public Works (Discharger) for the Maple Lane Drainage Maintenance Project (Project). The Project encompasses routine maintenance of the Maple Lane drainage for the purpose of maintaining capacity, reducing severe erosion potential, and protecting all nearby roadways. The implementation of the Project will result in the temporary impacts of 0.30 acre of ephemeral, earthen streambed waters of the state. The temporary impacts are a result of various maintenance activities, repairs, and access for basin and channel slopes, rock bottom control structures, grouted and un-grouted rock features, culvert inlets and outlets, sediment removal or redistribution, vegetation management, and ingress-egress grading.

The Santa Ana Water Board intends to consider adopting the Tentative Order during a public hearing at a regularly scheduled Santa Ana Water Board meeting as follows:

Interested persons may attend and express their views orally on this matter at the public hearing. Oral statements should be brief to allow all interested persons time to be heard. Such comments will generally be limited to three minutes, though the Board Chair may grant additional time on a case-by-case basis.

Please check the Santa Ana Water Board's website for the most up-to-date public hearing date and location, as they are subject to change.
