NOTICE OF PUBLIC HEARING

TENTATIVE ORDER R8-2025-0020

NOTICE IS HEREBY GIVEN that the Santa Ana Regional Water Quality Control Board (Santa Ana Water Board) is releasing for public review and comment tentative Rescission Order R8-2024-0020 (Tentative Order), which will rescind Order 81-74 Layton Water Brine Pond, Order 83-19 Camino West Coast Services Inc. (Big Brand Tire & Service), and R8-2018-0090 Riverside County Flood Control & Water Conservation District North Norco Line NB Stage 3 Project.

These orders are being rescinded because the discharges have been eliminated, or the project has been completed

The Tentative Order will be considered for adoption at a public meeting that will occur at the following date, time and location:

Such comments will generally be limited to three minutes, though the Board Chair may grant additional time as deemed appropriate on a case-by-case basis.
