## **TENTATIVE ORDER R8-2025-0032**

NOTICE IS HEREBY GIVEN that the Santa Ana Regional Water Quality Control Board (Santa Ana Water Board) is releasing for public review and comment tentative Order R8-2025-0032 (Tentative Order), which will serve as Waste Discharge Requirements for the discharge of chemical amendments into the subsurface at the Centrilift Facility (5421 Argosy Avenue, Huntington Beach) to evaluate the effectiveness of in-situ groundwater remediation of 1,4-dioxane and/or volatile organic compounds (VOCs) within the specified treatment zones. With proper management and monitoring as required by the Tentative Order and associated Monitoring and Reporting Program, any potential adverse effects will be localized, of short duration, and are not expected to unreasonably impair any existing or prospective beneficial uses of groundwater. Such comments will generally be limited to three minutes, though the Board Chair may grant additional time on a case-by-case basis.
