WASTE DISCHARGE REQUIREMENTS FOR  
PILOT SCALE IN-SITU REMEDIATION  
OF DEEP VADOSE ZONE AND GROUNDWATER  
AT ALL METALS PROCESSING OF ORANGE COUNTY,  
8401 STANDUSTRIAL STREET, STANTON**

**TENTATIVE ORDER R8-2025-0013**

**NOTICE IS HEREBY GIVEN** that the Santa Ana Regional Water Quality Control Board (Santa Ana Water Board) is releasing for public review and comment tentative Order R8-2025-0013 (Tentative Order), which will serve as Waste Discharge Requirements for the discharge of chemical amendments into the subsurface at All Metals Processing Facility (8401 Standustrial Street, Stanton) to promote in-situ remediation of contaminants of concern, primarily, hexavalent chromium (CrVI), volatile organic compounds (VOCs), and per- and polyfluoroalkyl substances (PFAS), within the specified treatment zone. With proper management and monitoring as required by the Tentative Order and associated Monitoring and Reporting Program, any potential adverse effects will be localized, of short duration, and are not expected to unreasonably impair any existing or prospective beneficial uses of groundwater.
