NOTICE IS HEREBY GIVEN that the Santa Ana Regional Water Quality Control Board (Santa Ana Water Board) is releasing for public review and comment tentative Order R8-2025-0079 (Tentative Order) to PSIP WR Green River, LLC for the Green River Ranch Business Park Industrial Project (Project).

The Project purpose is to construct an industrial service development, associated with the Green River Ranch Specific Plan. The Project consists of five industrial buildings totaling 746,167 square feet with associated infrastructure on 78.87 acres. The development of the Project will result in a total of 2.08 acres of temporary and permanent impacts to waters of the State.

The Santa Ana Water Board intends to consider adopting the Tentative Order during a public hearing at a regularly scheduled Santa Ana Water Board meeting as follows:
