NOTICE IS HEREBY GIVEN that the Santa Ana Regional Water Quality Control Board (Santa Ana Water Board) is releasing for public review and comment, the tentative Order R8-2026-0035 (Tentative Order) for the Riverside University Health System Wellness Center Project (Project).

The Project's purpose is to develop a wellness center to expand inpatient behavioral health treatment capacity and integrate behavioral health services. The Project will permanently impact 3.11 acres (3,646 linear feet) of waters of the State associated with mass grading to construct the development and associated infrastructure, including required stormdrain improvements.

The Santa Ana Water Board intends to consider adopting the Tentative Order during a public hearing at a regularly scheduled Santa Ana Water Board meeting as follows:
