BACKGROUND

The court's reference to the State Water Resources Control Board ("State Water Board" or "Board"), the assignment to the Board's Administrative Hearings Office ("AHO"), the hearing issues specified in the court's October 7, 2021 order, and related information are discussed in the AHO's December 13, 2021 Notice of Assignment and Status Conference and are not repeated here.

The AHO held a status conference on January 18, 2022, during which the AHO hearing officer and the parties' attorneys discussed the status conference issues listed on page 5 of the AHO's December 13, 2021 notice. This order and notice follow that status conference.

STATUS CONFERENCE ORDER

The attorneys for the parties shall meet and confer and attempt to reach agreement on the following deadlines and dates:

- 1. Deadline for the parties to file with the AHO their simultaneous designations of expert witnesses (any witnesses who have any of the qualifications specified in Evidence Code section 720, subdivision (a) and who may testify during the AHO hearing in this matter).
- 2. Deadline for the parties to file with the AHO any stipulation regarding any substantive issues associated with any of the hearing issues. Such stipulation may include stipulations on factual or legal issues or stipulations on use of prior depositions or testimony.
- 3. Deadline for the parties to file with the AHO their exhibits and written proposed testimony for the AHO hearing in this matter.
- 4. Proposed AHO hearing dates.

Following these meetings and conferences, the attorneys for the parties shall prepare one document, which shall list, separately for each of the preceding items, the parties' stipulation on the item or the parties' respective positions on the item.

One the parties' representatives shall e-mail this document to the AHO at the AHO's e-mail address (AdminHrgOffice@waterboards.ca.gov) on or before **February 1, 2022, at 1:00 pm**. All e-mail addresses listed in the attached service list shall be listed in the cc line for that transmittal e-mail.

SECOND STATUS CONFERENCE

The AHO will hold the second status conference in this matter on the date and at the time listed on the first page of this order and notice. The purpose of this status conference will be to discuss the dates listed in the document described in the preceding section of this notice and order and to develop a pre-hearing and hearing schedule for this matter. After this status conference, the AHO will issue a notice of hearing for this matter.

Any person who wants to participate in this status conference may do so using the Zoom conference information listed on the first page of this order and notice. Any person who wants to observe this status conference without participating may do so through the Administrative Hearings Office's YouTube channel, which is accessible through the link listed on the first page of this order and notice.
