#### TO ALL PARTIES:

On December 15, 2021, the State Water Resources Control Board’s Division of Water Rights (Division) issued to Respondent Stella Vivanco an Administrative Civil Liability (ACL) Complaint under Water Code section 1055. Respondent requested a hearing in this matter on January 7, 2022. The State Water Resources Control Board’s Administrative Hearings Office (AHO) issued a Notice of Public Hearing on February 9, 2022. This Notice of Public Hearing set a hearing date of May 11, 2022 at 9:00 a.m.

On March 30, 2022, Julé Rizzardo, an Assistant Deputy Director of the Division, advised the AHO and Respondent that the Division was withdrawing the ACL Complaint against Respondent in this matter. Also on March 30, 2022, Mr. Lewis sent the AHO an e-mail that referenced the Division’s withdrawal of the ACL Complaint and requested that the AHO cancel the hearing scheduled in this matter.

Based on the Division’s withdrawal of the ACL Complaint, the AHO cancels the hearing in this matter that was scheduled for May 11, 2022 at 9:00 a.m.
