## **BACKGROUND**

On July 7, 2021, the Administrative Hearings Office (AHO) of the State Water Resources Control Board (State Water Board or Board) issued a Notice of Status Conference regarding Nevada Irrigation District's petition for assignment of state-filed Application 5634 and accompanying water-right Application 5634X01 and South Sutter Water District's request for releases from priority of state-filed Applications 5633 and 5634 in favor of water-right License 11120 (Application 10221). Additional background information about Nevada Irrigation District's proposed project, petition for assignment, and application for a permit to appropriate water, and South Sutter Water District's request for releases from priority, are described in the July 7 notice.

The AHO held status conferences in this matter on August 31, 2021, January 18, 2022, and July 20, 2022.

## **STATUS CONFERENCE**

The hearing officer will hold a status conference on the date and at the time specified on the first page of this notice by Zoom teleconference. No in-person appearances will be allowed. The status conference will be held and electronically recorded by Zoom teleconference. The AHO will not retain a court reporter for the status conference. Any party may arrange for a court reporter at the party's own expense.

During the status conference:

- (1) The hearing officer will ask representatives of the Nevada Irrigation District and South Sutter Water District to provide an update on the status of negotiations, actions, or other new information related to Nevada Irrigation District's pending Petition for Assignment of State-Filed Application 5634 and accompanying water-right Application 5634X01, and South Sutter Water District's Request for Releases from Priority of State-Filed Applications 5633 and 5634 in favor of water-right License 11120.
- (2) The hearing officer will hear any comments from the participants and may consider other procedural issues raised by any of the participants.

Nevada Irrigation District and South Sutter Water District shall each file a status conference statement or file a joint status conference statement with the AHO, and serve copies of it on the other parties listed in the attached service list, that addresses status conference issue (1), above, by **September 21, 2022**, at 12:00 p.m. If any other party wants to file a status conference statement, the party shall file the status conference statement with the AHO and serve copies of it on the other parties listed in the attached service list by **September 30, 2022**, at 12:00 p.m. The AHO will post the statements on the Water Board AHO-FTP site in the folder for this matter.
