On April 8, 2022, the Administrative Hearings Office (“AHO”) of the State Water Resources Control Board (“State Water Board” or “Board”) issued a Notice of Public Hearing in this proceeding.

On May 19 and June 2, 2022, the AHO held its public hearing in this proceeding by Zoom teleconference.

The AHO has prepared its proposed order and transmitted it to the Clerk of the Board. Copies of this proposed order and the AHO’s transmittal memorandum are enclosed.

Pursuant to Water Code section 1114, subdivision (c)(4), any interested party may submit a written request to the Clerk of the Board describing which of the actions authorized by subdivision (c)(2) of section 1114 the party requests the Board to take, including an explanation of the reasons for the party’s request. Any such request must be submitted within 30 days of the date of this notice, that is by **February 16, 2023**. Any party submitting such a request shall transmit it by U.S. Mail and e-mail to:

The agenda will describe the process for appearing at the Board meeting to make oral comments, and will specify the deadline for submitting any slides or other documents that the party will use to accompany the party's oral comments.
