On May 17, 2013, the California High Speed Rail Authority (HSRA) submitted an application to the State Water Resources Control Board (State Water Board) for issuance of a Clean Water Act (CWA) section 401 water quality certification (Certification) for the High Speed Train Project – Merced to Fresno Permitting Phase 1 (Project). State Water Board staff deemed the application complete on June 17, 2013.

State Water Board staff reviewed the information submitted by HSRA describing activities, proposed water quality protection measures and mitigation, and compensatory mitigation for the Project. State Water Board staff additionally conducted Project field reviews with HSRA staff on May 13, 2013 and August 1, 2013, to review proposed impact areas.
