## Project Name: OC Loop Segments O, P, and Q Coyote Creek Bikeway Project

(Reg. Meas. ID: 441496 and SWRCB ID: SB20032IN)

**Background:** On March 6, 2025, Orange County (OC) Public Works submitted an application for Clean Water Act section 401 water quality certification for the OC Loop Segments O, P, Q Coyote Creek Bikeway Project (Project).

**Project Description:** The Project intends to construct a bike trail along the north side of the concrete-lined Coyote Creek East Fork and close a gap in the OC Loop bike trail system. Waters of the state within the Project area would be temporarily impacted during site access and staging of material, equipment, and scaffolding.

The Project application reports temporary impacts to waters of the state, including waters of the United States, as shown in Table 1. Temporarily impacted areas would be restored to pre-project condition once the Project is complete. No permanent impacts to waters of the state are anticipated.
