## DISCLOSURE OF WATER SUPPLY WELL LOCATION INFORMATION ON GEOTRACKER

Greetings:

Recently, state law (Water Code section 13752) was amended to mandate public access to well completion reports. Well completion reports are required to be filed with the Department of Water Resources (DWR) for all groundwater wells at the time that they are constructed. The reports are required to contain information regarding each well's location and construction, and the lithology of the subsurface, among other items. Prior to the statutory amendment, well completion reports were confidential and not available to the public. As a result of the amendment, all well completion reports are available to the public, except that personal information (the owner's name and address) must be removed (redacted). The purpose of this letter is to solicit your input (and input from your membership, if applicable) on what steps, if any, the State Water Resources Control Board (State Water Board) should take in response to this new law.

Currently, the State Water Board obscures from public view the precise locations of certain types of, but not all, groundwater wells on its GeoTracker and GeoTracker Groundwater Ambient Monitoring and Assessment (GAMA) online groundwater information systems (http://geotracker.waterboards.ca.gov/ and http://geotracker.waterboards.ca.gov/gama). Specifically, GeoTracker GAMA has historically shown the precise locations of site cleanup monitoring wells, but has obscured the locations of water supply wells for public water systems and private domestic wells by providing a randomly-generated point within approximately one mile of the well's precise location. In addition, the State Water Board's Drinking Water Program has not released records that identify the precise location of water supply wells used by public water systems. In accordance with the previous version of Water Code section 13752 and the Public Records Act, the State Water Board has been granting access to the precise locations of water supply wells only to public agencies that agree not to disclose those locations. Since well completion reports, including information about the location of the wells, are now publicly

available by request from DWR,1 State Water Board management is considering whether to continue maintaining the confidentiality of groundwater well location information on its online groundwater information systems.

Access to accurate, complete, and centrally located groundwater data is critical to better manage our water resources, especially in time of drought and as local agencies throughout the state implement the Sustainable Groundwater Management Act. Obscuring water supply well location information has reduced the ability of hydrogeologic researchers, decision-makers and the public, including disadvantaged communities, to readily access accurate data. Dozens of large water systems currently provide water supply well information on the internet and water supply wells are often identifiable via online mapping tools, such as Google maps.

Most water supply wells are also visible to any person observing the site, because a portion of the well or its related structures is above the ground surface. The State Water Board's water right database, (eWRIMS) has for several years publicly shown the precise location of all water right diversion points, including wells that divert water subject to the State Water Board's water right permitting authority. Displaying the exact location of water supply well locations in GeoTracker would align how the State Water Board displays water supply location data across its databases. Nonetheless, some have expressed water security concerns if water supply well locations are more readily available on GeoTracker.

We welcome your comments on making well information public on the State Water Board's databases.

DWR is in the process of redacting names and addresses from approximately 800,000 well completion reports, and expects to make all well completion reports available to the public online in approximately a year.
