Tule Subbasin Probationary Hearing Agenda

The California State Water Resources Control Board (State Water Board or Board) will hold a public hearing on September 17, 2024 to consider whether to designate the Tule Subbasin as a probationary basin pursuant to the Sustainable Groundwater Management Act (SGMA). See the <u>Tule Probationary Hearing notice</u> for information on parking and accessibility for the hearing.

This hearing agenda describes the expected order of events for the hearing, which constitutes one item before the Board at the September 17, 2024 Board Meeting. The hearing may start as early as, but not before, 9:00 a.m. Time limits, breaks, panels that are included, and the order of events may change at the discretion of the Board Chair.
