# Notice of Intent to Adopt a Mitigated Negative Declaration

Pursuant to California Environmental Quality Act (CEQA) section 21092 and CEQA Guidelines section 15072

**PROJECT TITLE:** Lone Band of Miwok Indians Water System Improvements (Project)

**APPLICANT:** Lone Band of Miwok Indians (Applicant)

**LEAD AGENCY:** State Water Resources Control Board (State Water Board)

**PROJECT LOCATION:** Assessor's Parcel Number (APN) 005-180-005-000 in southwestern Amador County, approximately 3 miles southwest of Lone, California.

The Project site is not present on any of the lists enumerated under section 65962.5 of the Government Code.

**PROJECT DESCRIPTION:** The Project would include the installation of a new water distribution system to provide potable water to 14 existing residences. The existing water distribution system would remain in place to provide water for irrigation and fire protection services only, while a new distribution system connected to the Jackson Valley Irrigation District would provide potable water to the 14 existing residences.
