**NOTICE OF PUBLIC SCOPING MEETINGS**

**TRIENNIAL REVIEW OF THE  
WATER QUALITY CONTROL PLAN FOR OCEAN WATERS OF CALIFORNIA**

**NOTICE IS HEREBY GIVEN** that the State Water Resources Control Board (State Water Board) has begun the 2019 triennial review process for the Water Quality Control Plan for Ocean Waters of California (Ocean Plan). The Ocean Plan identifies the beneficial uses of ocean waters, establishes water quality objectives for protecting those beneficial uses, and describes implementation programs for achieving water quality standards. Triennial reviews of water quality control plans are required by the Clean Water Act section 303(c)(1) and U.S. EPA Title 40 of the Code of Federal Regulations, section 131.20. The purpose of the triennial review is to identify key issues that will guide the State Water Board's priorities for future amendments to the Ocean Plan.

The State Water Board will host three public scoping meetings to discuss the 2019 triennial review and solicit informal comments on potential projects or amendments to update the Ocean Plan. Potential projects or amendments may include, but are not limited to, proposing new or revising existing water quality objectives and beneficial uses, revising programs of implementation, and reviewing exceptions to the Ocean Plan.


