NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT AND OPPORTUNITY FOR TRIBAL CONSULTATION

PROPOSED UNDERGROUND STORAGE TANK CASE CLOSURE PURSUANT TO HEALTH AND SAFETY CODE SECTION 25296.10 AND THE STATE WATER RESOURCES CONTROL BOARD LOW-THREAT UNDERGROUND STORAGE TANK CASE CLOSURE POLICY BIG BEAR MUNICIPAL WATER DISTRICT (RESPONSIBLE PARTY) BIG BEAR MARINA, 500 PAINE ROAD, BIG BEAR LAKE, SAN BERNARDINO COUNTY

NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board (State Water Board) will accept comments on the proposed underground storage tank (UST) case closure for Santa Ana Regional Water Quality Control Board, case number 083602283T (Site).

Upon review of the case, the State Water Board may close or require the closure of any UST case if it is determined that corrective action has been completed in accordance with Health and Safety Code section 25296.10. Pursuant to State Water Board Resolution No. 2012-0061, the Executive Director or Chief Deputy Director of the State Water Board may close or require closure of cases that meet the criteria specified in the State Water Board's Low-Threat Underground Storage Tank Case Closure Policy (Policy) adopted by State Water Board Resolution No. 2012-0016.

A copy of this notice has been provided to the responsible party, owner/operator, environmental consultant on record, the applicable Regional Water Quality Control Board and local agency that has been overseeing corrective action, agencies with authority to issue building permits, owners and occupants of the impacted property, owners and occupants of all parcels adjacent to impacted properties, the water replenishment district, the local water purveyor, the municipal water district, county water district, and special act district with groundwater management authority.

OPPORTUNITY FOR TRIBAL CONSULTATION

Meaningful engagement with California Native American Tribes is fundamental to the mission of the State Water Board. This project being undertaken by the State Water Board is the proposed closure of a UST release case and, if approved to move forward,

may involve the destruction of wells used for monitoring and remediation to protect groundwater.

The requirements of Public Resources Code § 21080.3.1 (Stats. 2014, ch. 532 (AB 52)), do not apply to the proposed UST case closure. However, in accordance with Governor's Executive Order B-10-11, as a best practice the State Water Board hereby notifies California Native American Tribes that are traditionally and culturally affiliated with the geographic location of the Site of a consultation opportunity regarding this proposed UST case closure. The Site is located at **500 Paine Road, Big Bear Lake, San Bernardino County**. The geographic location of the Site can be viewed on the GeoTracker Case Record webpage for this case (see link above).

Consultation may be requested up until the close of the comment period (**12:00 noon on Friday, October 6, 2023**).
