**NOTICE IS HEREBY GIVEN THAT** the State Water Resources Control Board (State Water Board) will accept comments on the proposed underground storage tank (UST) case closure for Santa Ana Regional Water Quality Control Board Case Number 083000827T (Site).

Upon review of the case, the State Water Board may close or require the closure of any UST case if it is determined that corrective action has been completed in accordance with Health and Safety Code section 25296.10. Pursuant to State Water Board Resolution No. 2023-0036, the Executive Director or Chief Deputy Director of the State Water Board may close or require closure of cases that meet the criteria specified in the State Water Board's Low-Threat Underground Storage Tank Case Closure Policy (Policy) adopted by State Water Board Resolution No. 2012-0016.

Meaningful engagement with Native American Tribes is fundamental to the mission of the State Water Board. The State Water Board is proposing closure of a UST cleanup

case and, if approved to move forward, closure procedures may involve destruction of wells and removal of underground equipment used for monitoring and remediation.

Native American Tribes that are traditionally and culturally affiliated with the geographic location of the Site are invited to engage with the State Water Board regarding this proposed UST case closure. The Site is located at 2646 W 1<sup>st</sup> Street, Santa Ana, Orange County.
